About the Project, Objectives, Expected Outcomes and Main Activities	
- Can an organization implement a relocation project based on a contract agreement where a whole building is offered for usage by third country nationals, not depending on the voucher scheme proposed in the call?	The scheme lists 4 type of accommodation schemes: - Hotel Vouchers - Apartment Rental - Hotel Rentals - Host Families
	We assume the "whole building" stated in the question is a combination of apartments (or a hotel rental) and, therefore, it meets one of the options listed above.
	Regarding the ownership of the building, if the owners have a legal status in the country and they are legally allowed to rent the premises, nationality should not be an issue.
 We would have one question about the call for proposals that was just sent out for the 20 000 shelter places. The scheme foresees two axes: creation of shelter for relocation; and creation of shelter for asylum seekers who can't benefit from relocation. 	The calculation of the number of beneficiaries is done taking into consideration turn of tenancy an apartment can host during a 2 year period, taking into consideration that a beneficiary can stay up to 6 months and the number of months of rent per apartment will vary. This is:
On that last one, we have trouble understanding the table stating that total beneficiaries are estimated to number 21 500 people. We don't quite understand the calculation behind it. We understand that for the 1st month, if 1000 people are registered every week by the asylum service, you will find yourself with 4000 asylum seekers needing accommodation, but for the second month, that number seems to have dropped even though 2000 people are considered as registered every week. We don't understand the calculation for months 2, 3, 4, 5 and 6. Maybe you could help?	 If the apartment is rented on month 1, the expected turn of tenancy is 4 in 24 months; If the apartment is rented on month 2, the expected turn of tenancy is 3.8 in 23 months If the apartment is rented on month 3, the expected turn of tenancy is 3.7 in 22 months If the apartment is rented on month 4, the expected turn of tenancy is 3.5 in 21 months If the apartment is rented on month 5, the expected turn of tenancy is 3.4 in 20 months If the apartment is rented on month 6, the expected turn of tenancy is 3.3 in 19 months If we multiply the number of beneficiaries in months 1, 2, 3, 4, 5 and 6 per the turn of tenancy, and we add them all, we have the 31 500 expected.
 The concept note can include both target groups (relocation and asylum seekers not qualified for relocation) or should be a separated concept note for each group? - The concept notes should describe activities in national or regional level?
- There is a special form in the case of a consortium for partner declaration or each partner of the consortium should submit each own?

Same format should be used for individual or group proposals. However, group arrangements should be clearly described when applicable.

Proposals can include one or all target groups, one or all areas and one or

all modalities of accommodation. The proposal can also prioritize a

specific target group, and one or different locations or accommodation arrangements, depending on capacity and area of coverage. Proposals

should describe the activities in the area of coverage defined by the

organization.

- Can an organization participate in more than one concept note, in the case of a consortium?
- Is there a limit of concepts note that an organization can participate as leading or partner organization?
- There is a special form in the case of a consortium for partner declaration or each partner of the consortium should submit each own?
- Is it possible for an applicant organization to submit a concept note for only one specific activity, like provision of medical services?
- Will concept notes concerning <u>only</u> the provision of services to the accommodation facilities, such as interpretation services or escorting of beneficiaries, but not the actual setting up of a facility, be eligible for review?
- The note focuses mainly on the provision of accommodation capacity and some basic services. Save the Children and partner NGOs focus on the most vulnerable children, including unaccompanied children, who are in need of a range of support services, such as care, protection, recreational activities, legal information, psycho-social support, family tracing services, (informal) education and activities in the community. Can these services be included as objective in the concept note in order to fulfil the rights and meet the critical needs of UAC and minimum standards of care and protection?
- Vulnerable families and children at risk, notably unaccompanied and separated children, need to be identified, their needs need to be assessed and they need to be provided with information on asylum seeking and hotspot/relocation procedures in Greece in order to be referred to these services when in their best interests, in the areas of arrival (islands). Can this service be included as objective in the concept note?
- Save the Children and partners have set-up transit housing for extremely vulnerable UAC as an alternative for protective custody/detention during the registration process with the police, in first line reception areas (on Lesvos as a pilot), can this service be expanded and included as objective in the concept note on the islands where hotspot procedures will be established?

If an organization is part of a Proposal submitted by a group of NGOs (i.e. Consortium), and also would like to submit a separate Proposal, it can be done, but:

- the NGO must clearly describe the situation as part of the individual proposal; and,
- activities in both applications should be different in nature and in location.

No limit has been established, but above notes should be taken into consideration.

Yes, if it relates to services described/required within the Call for Expression of Interest, it can be submitted and will be reviewed.

Yes, it can. As mentioned above, proposals can include all target groups, all areas and all modalities of accommodation, as well as the proposal can prioritize a specific target group, a/different location(s) or accommodation arrangements, depending on capacity and area of coverage. The Committee will ensure that there is no duplication between activities/objectives included in proposals and regular activities/projects under implementation.

- What is the size limit for the uploading of the project concept note? How many MB?	There is no pre-established limit. Thus, UNHCR e-mail system can accept up to 5 MB. If a proposal is larger than 5MB, the proposal and documents should be divided and sent separately.	
- Can supporting documents be submitted as an annex to the concept note or they should be submitted as separate .pdf files?	Yes, it is up to the organization presenting the proposal.

Should this form be submitted from each partner in the case of a consortium? 	Required supporting documents are described in the Call for Expression of Interest. However, organizations are free to add any additional documents they see necessary to support their Proposals.
