**MAIN ACTIVITIES**

**Refugee Protection**

- In 2015, following UNHCR’s request, the Government created a working group for development of two instructions related to individual and mass arrival of refugees and asylum-seekers. Following intense work of all involved ministries, the instructions are now ready for a final review. UNHCR hopes to see them approved by the end of 2015. As agreed with the State Border Service, UNHCR prepared information stands for asylum-seekers, which were placed at all border crossing points.
- The overall responsibility for Refugee Status Determination (RSD) lies with the Ministry of Labor, Migration and Youth. In order to improve and maintain high quality of the state RSD, UNHCR has been providing refugee law training to the state authorities involved in RSD, judiciary, border guards and the police. UNHCR also reviews legal assessments and provides its recommendations. UNHCR conducts mandate RSD for a limited number of persons, in case the office determines that a decision of the government authorities was not taken in accordance with international standards.

**Reduction and Prevention of Statelessness**

- The reduction and prevention of statelessness activities in Kyrgyzstan are carried out on the basis of the National Action Plan (NAP) updated annually at the High Level Steering meetings. The Government referred to the NAP in its 2011 pledges confirmed at Inter-ministerial meeting (7-8 December 2011, Geneva).
- In June 2014, UNHCR launched a pilot project aimed at reducing and preventing statelessness in Kyrgyzstan. The project is funded under the UNHCR’s “Seeds for Solutions” initiative. By July 2015, 56 multifunctional mobile teams comprising lawyers and state officials have been created, trained, and equipped to register and document stateless persons and those at risk of statelessness throughout the country. These teams travel to remote areas of Kyrgyzstan in order to provide legal consultations to beneficiaries, and to help stateless persons file for citizenship determination or Kyrgyz citizenship acquisition. In so doing, they identify gaps in legislation or procedures to be addressed.
- By August 2015, the teams have identified over 8,200 new persons of concern falling under UNHCR’s statelessness mandate, the majority of whom filed for citizenship determination or acquisition. Over 3,600 individual cases have already been resolved. The registration and documentation effort is expected to complete in 2016, having covered the entire territory of Kyrgyzstan.
- At UNHCR initiative, a Working group on development of citizenship and statelessness legislation proposes changes to the legislation to fill in the current gaps. The latest recommendations were endorsed by State Registration Service (SRS) and circulated in February 2015. WG also plans to review the statelessness determination procedure.

## Durable Solutions

- In August 2015, UNHCR conducted re-profiling of all Convention and Mandate refugees residing in the country to improve the understanding of the refugee population’s situation, capacities, needs and intentions. This exercise will allow UNHCR to find tailor made solutions for all refugees residing in Kyrgyzstan.
- UNHCR is implementing until the end of 2015, a peacebuilding project aimed at increasing trust among communities and between individuals and authorities. The project is funded by the UN Peacebuilding Fund and focuses on conflict sensitivity and effective problem solving methods within the local self-government structures. The activities include legal assistance, implementation of community based peacebuilding initiatives, monitoring/analysis and advocacy.
- Kyrgyzstan is one of the three pilot countries worldwide for the implementation of the United Nations Secretary-General's Policy Decision on Durable Solutions (No. 2011/20). In 2014, the UN Country Team endorsed a joint Durable Solutions Strategy that will ensure a continued focus of all agencies towards the remaining challenges for those affected by the June 2010 conflict.

## Emergency Preparedness

- UNHCR is working closely with the Ministry of Emergency Situations (MoES) to develop and maintain the level of emergency preparedness. Government stakeholders and UNHCR agreed on a joint contingency plan, which lays out a detailed response mechanism in case of mass refugee influx from neighboring countries.
- In April 2015, Ministry of Emergency Situation organized a joint field exercise in order to improve interaction between UNHCR, UN Agencies, international and non-governmental organizations. The exercise also provided instruction on admission and accommodation of refugees from adjacent countries in case of escalation of military and political situation on territory of neighboring country.
- During 2015, two Working Groups have been held with MoES and Border Guards’ Service to review and update the existing Contingency Plan. The 5<sup>th</sup> High Level Working Group on Contingency planning will be held in November 2015.

## WORKING WITH PARTNERS

- In protecting refugees and asylum-seekers, UNHCR works closely with government partners, such as the Ministry of Labor, Migration and Youth, Ministry of Justice, Ministry of Interior, Ministry of Foreign Affairs, Ministry of Education and Science, State Border Service, Mandatory Health Insurance Fund, and Office of the Prosecutor General. UNHCR also collaborates with the Institute of Ombudsman, Parliament, Supreme Court, and others, Legal Clinic “Adilet”, Centre for International Protection, Public Association Counterpart-Sheriktesh, and Crisis Centre “Sezim”.
- In the framework of finding opportunities for refugees to locally integrate, UNHCR is working to identify partners to include refugees into their assistance schemes; such as UNICEF, the Aga Khan Foundation and GIZ.
- In the framework of reduction and prevention of statelessness, UNHCR cooperates with the State Registration Service, Citizenship Commission of the President’s Office, Public Foundation “Fergana Valley Lawyers without Borders”, and NGO “Women Entrepreneurs Support Association”.
- Ministry of Social Development, Agency for Local Self-Governance and Inter-Ethnic Relations, Foundation for Tolerance International, Public Foundation “Abad”, Law Clinic, and Public Foundation “Spravedlivost” are partners within UNHCR’s peace building project.
