
## Statistics on Displaced Iraqis around the World

September 2007

#### **GLOBAL OVERVIEW**

An estimated 60,000 Iraqis are being forced to leave their homes every month by continuing violence. As of September 2007, there were believed to be well over 4 million displaced Iraqis around the world, including some 2.2 million inside Iraq and a similar number in neighbouring countries (in particular Syria and Jordan) and some 200,000 further afield. Around one million were displaced prior to 2003. The ability of neighbouring states to handle such larger numbers is close to breaking point. In recent months visa restrictions have been considered which, if implemented, will result in Iraqis having greater difficulty finding a safe haven. UNHCR's April 2007 Conference on Iraqi displacement focused attention on the huge humanitarian crisis developing in the region. Over the past year, Iraqis have once again become the leading nationality seeking asylum in industrialized countries, with 22,200 Iraqis applying for asylum during 2006 and 19,800 during the first six months of 2007. However, some 95 percent of uprooted Iraqis are still located in the Middle East.

### INSIDE IRAQ

The number of internally displaced people (IDP) within Iraq has risen by more than 50 percent since early 2006. In all, more than

1,043,900 new IDPs have been created by conflict and a sharp upturn in sectarian violence since the February 2006 bombing in Samarra.

As a result of initial optimism after the fall of the Saddam Hussein regime in 2003, over 300,000 Iraqi refugees returned home during the two years following the war – mainly from Iran. Of these, around 27,000 were assisted by UNHCR. However, by mid-2007 more than 2.2 million Iraqis were living

outside Iraq and few were returning voluntarily. Many foreign refugees had also left or were keen to do so. Of those remaining, some have found a relatively safe haven in northern Iraq, whilst others – most notably the Palestinians – are effectively trapped with nowhere to go.



## IRAQI REFUGEES & ASYLUM SEEKERS IN INDUSTRIALIZED COUNTRIES

Iraqis were the largest single group of asylum seekers arriving in industrialized countries in 2006. However, the total of 22,000 was less than half the average number arriving during the six years prior to the 2003 war. Numbers have continued to rise sharply during 2007 with a total of 19,800 asylum applications lodged by Iraqi citizens during the first six months of the year in the 36 industrialized countries for which data was available.

### Resettlement to Industrialized Countries

During the first half of the 1990s, more than 5,000 Iraqis were being resettled to industrialized countries each year. However, after 2003, the numbers fell by around half. Between 1 January and 21 September, 2007, with reinforced resettlement operations under way, UNHCR had referred 14,934 of the most vulnerable Iraqi refugees for consideration for resettlement to 14 countries. Of these, 10,844 persons were submitted to the United States and a total 4,090 to Australia, Canada, Denmark, United Kingdom, New Zealand, Finland, Sweden, Netherlands, Brazil, Ireland, Spain, France and Norway. This represents 75 percent of UNHCR's annual regional target of 20,000. By the end of September some 1,800 Iraqis had departed to various resettlement countries.
