UNHCR Guidelines on Statelessness on Ensuring Every Child's Right to Acquire a Nationality

These Guidelines examine the actions required by states to ensure that every child acquires a nationality. They are intended to provide interpretative legal guidance for governments, NGOs, legal practitioners, decision-makers and the judiciary, as well as for UNHCR staff and other UN agencies.

Preventing and reducing statelessness, and protecting stateless children

A document co-published with Plan International examining the urgent need to protect stateless children. It identifies the causes of statelessness, the experience of statelessness for stateless children, and the legal framework that can protect stateless children. It also provides information on birth registration as a preventative measure.

Gender Discrimination and its impact on Children's Right to Nationality

UNHCR has surveyed nationality laws and identified those States which do not allow women to confer nationality to their children on equal terms with men.

In 2011, UNHCR co-organized, with CRTD.A, a dialogue with women and family members affected by discrimination against women in nationality laws. The testimonies from the dialogue have compelling information on the impact of statelessness on children.

The workshop with the ASEAN Intergovernmental Commission on Human Rights reviewed a number of the known situations of statelessness in the region, before considering the international legal framework that exists in the region. Various good practices adopted by ASEAN Member States to address statelessness were identified, with a particular focus on successful approaches that had been taken to prevent and reduce statelessness among women and children.

Universal Periodic Review (UPR) Recommendations

The first fifteen full sessions of the UPR show a steady increase in the number of recommendations relating to statelessness, going from one recommendation in the first session to 30 in the 15th. The most common themes are birth registration (109 recommendations), reform of nationality laws, including to ensure children acquire a nationality (95 recommendations), and accession to the statelessness conventions (70 recommendations).
