- Considering : that in order to comply with article 59 clause 3 of the Government Regulation No. 2 Year 2007 pertaining to the Procedures for Obtaining, Loosing, Nullifying and Regaining Citizenship of the Republic of Indonesia, it is a necessary to establish a Ministerial Regulation by the Ministry of Law and Human Rights pertaining to the Procedure of Registration, Recording and Administration of immigration facilities as for citizens of the Republic of Indonesia with dual nationalities,
