The Immigration (Designation of Travel Bans) (Amendment) Order 2006

The Secretary of State, in exercise of the powers conferred upon him by section 8B(5) of the Immigration Act $1971(\mathbf{a})$, makes the following Order:

1. This Order may be cited as the Immigration (Designation of Travel Bans) (Amendment) Order 2006 and shall come into force on 13th December 2006.

2. For the Schedule to the Immigration (Designation of Travel Bans) Order 2000(**b**) there shall be substituted the Schedule set out in the Schedule to this Order.

3. The Immigration (Designation of Travel Bans) (Amendment) Order 2005(c) is revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Immigration (Designation of Travel Bans) Order 2000 ("the 2000 Order") by substituting the Schedule set out in the Schedule to this Order for the Schedule to the 2000 Order (which was last substituted by the Immigration (Designation of Travel Bans) (Amendment) Order 2005 ("the 2005 Order")). Any person named by or under an instrument listed in the new Schedule or falling within a description in such an instrument will be excluded from the United Kingdom (subject to the exceptions specified in article 3 of the 2000 Order).

The effect of substituting the Schedule set out in the Schedule to this Order for the Schedule to the 2000 Order is to add to, and delete from, the list of designated instruments, and to make some minor technical amendments to the list.
