The 2012 London Olympics showed the concept of value-oriented populism with the analog methods to express the British society.

Coubertin valued "beauty [as] the involvement of the arts and the mind in the [Olympic] Games [...] to be realized through participation in the Games" as an essential element of modern Olympism. Therefore, Hans Lenk, gold medalist 1960 and great international philosopher, proposed an extension of the Olympic Motto into "citius-altius-fortiu-pulchriushumanius" to include aesthetic and humanistic thoughts constructing an Olympic ideal. Inspired by Lenk's proposal, the editors chose to extended motto as subtitle of this book to accentuate the "cultural views of Olympics". The goal assigned to the Olympic cultural program by the IOC is to promote harmonious relations, mutual understanding and friendship among the participants and visitors of the Olympic Games. 





### Rio de Janeiro's emerging sporting mega-event geography: unraveling the Carioca pattern of urban development

In a span of two years the city of Rio de Janeiro will have hosted two of the biggest sporting events in the world, the 2014 World Cup and 2016 Summer Olympics. As the author argues throughout this dissertation, the potential these sporting mega-events hold for attracting capital investment to the city is immense. And, as such, the city of Rio de Janeiro has unveiled a dizzying array of new urban policy initiatives designed to prepare the city for the mega-event and in the process make the city an attractive space for international investors. The consequences of these policies, the author argues, are irrevocably altering the sociospacial structure of the city creating new landscapes for tourist consumption and zones for real estate speculation. In the process, the city of Rio de Janeiro is permanently reconfiguring its nearly 450-year-old urban settlement pattern characterized by a relatively high-percentage of low-income residents occupying residencies in and near the urban core. This dissertation examines how this process is unfolding across the city. The findings suggest low-income residents are being pushed to the periphery of the city through both 'hard' displacement (forced evictions) as well as 'soft' forms of displacement, including gentrification. This research specifically focuses on the latter, exploring the various ways in which gentrified landscapes in Rio de Janeiro's sporting mega-event city have been produced. MA 27733



Inspired by the London 2012 Olympic Games, three groundbreaking projects have created a powerful legacy for sustainable food in London and across the UK: 1. Food Legacy 2012: A UK-wide project that has seen leading caterers and other organisations adopt London 2012's sustainable food standards. These organisations, such as the Metropolitan Police and Transport for London, serve in excess of 200 million meals per year. 2. Sustainable Fish Cities: An Olympic initiative, encouraging the UK catering industry, businesses, government and others to pledge their commitment to serving sustainable fish. To date, 400,000 UK government employees now eat only sustainably caught fish, and the value of fish per year the UK government has committed to buy from sustainable sources is £17 million. 3. Capital Growth: A Games-inspired project that surpassed its goal of establishing 2,012 new community food growing spaces in London by 2012. This case study, compiled in 2015 by the IOC provides a good overview of the positive impacts of the legacy of these Games.

### The origins of the Olympic Games

Even in Antiquity it was debated when and why the Olympic Games had been established and by whom. Modern scholarship has also advanced a great number of hypotheses on the origins of the Games (ranging from funeral Games to harvest ceremonies/vegetation magic or even initiation rites), but a truly convincing reconstruction has not yet been formulated. The present volume offers a new comprehensive explanation for the phenomenon and argues that the Games evolved from hunting and from animal ceremonialism observed among various hunting groups. This explanation is admittedly a hypothetical one, based mainly on the interpretation of the archaeological material and some ethnographic parallels, but conjecture is necessary due to the complete absence of contemporary written evidence. In addition, although it is essentially a simple theory that simultaneously explains many perplexing features of the Games in a coherent way, it must remain without definitive proof, as with all other previous.



### <u>Competitiveness of the Hungarian elite sport system</u> Erika Gulyás. 2016. 58 p. Postgraduate research grant programme 2015 Olympic Studies Centre, International Olympic Committee

This paper presents the initial results of significant research conducted under the IOC PhD Student Research Grant Programme with the support of the Hungarian Olympic Committee. The main objectives of the research were to understand why Hungary is successful in specific sports and to explore the relationship between elite sport policy systems and success in international competitions. The increasing international sporting competition forces governments to invest more money in elite sport development just so they can maintain their elite sport success as the supply of medals remains basically constant. A macro- and meso-level analysis were conducted within the framework of this research. The data collection based on information gained through an overall guestionnaire and interviews with main stakeholders, coaches and athletes within national sport federations (De Bosscher, 2010). The data collection was focused on the sixteen prioritised sport federations and the five team sports which benefited from a tax relief system. Secondary data were collected regarding the national public funding for sport, elite sport and sport by sport since 2006, and an Infostrada database was used to analyse historical performance in the different disciplines and compare Hungarian performance with those of other countries. This research will provide information to policy makers about the competitive position of Hungary in elite sport and, in this respect, explore the critical success factors which will allow Hungary to assess how best to manage its future success in an increasingly competitive international environment.

# Early developmental environment and Olympic success: analysis of an Australian sporting "hotspot"

Kristy O'Neill. 2015, 64 p.

This study aims to identify an Australian sporting "hotspot" and the reasons for its ability to produce a greater relative number of Summer Olympic representatives 1984-2012 per head of the population. The overall study adopted a mixed-methods approach, with the first stage identifying the "hotspot" using publicly available, biographical data on all known (n = 2160) Australian Summer Olympians 1984-2012. The "hotspot" was examined through utilising a case study methodology within the context of Bronfenbrenner's (1979, 2005) "Ecological Systems Theory". Both community and Olympian's perceptions regarding why the "hotspot". occurred and the influence it has had on the athletic development of these Olympians was investigated. The results determined that a range of demographic, geographic, historical, social and fortuitous factors contributed to the creation of this "hotspot". Access to build and natural facilities, climate, family influence, schools, strong community clubs, opportunity to train and compete with older athletes, access to role models, high socioeconomic status and an endemic sports culture were amongst key contributing factors underlying the development of this "hotspot". Although many of these features appear to be unique to the "hotspot". area in Perth, Western Australia, some have potential to be transferred to other athlete development environments.

After supporting early Anti-Doping initiatives in the late 1960s and 1970s, they became highly influential in such leading sports organizations as the International Olympic Committee and the International Association of Athletics Federations. From the 1980s onward, the international sport system relied heavily on their network of Anti-Doping laboratory experts in maintaining and advancing a rigid testing regime. Hence, this book offers a nuanced analysis of the establishment of the structures and initiatives in the global fight against doping in sport.





Furthermore, it acknowledges that as a result of the increasing use of new technologies and biomaterials, there is now particular interest in techniques that promote biological healing of articular lesions and permit complete functional recovery. ### Waterman: the life and times of Duke Kahanamoku

Kahanamoku used his Olympic renown to introduce the sport of surf-riding, an activity unknown beyond the Hawaiian Islands, to the world.



# Where the English refused to tread: India's role in establishing hockey as an Olympic Summer sport

Nikhilesh Bhattacharya. 2015, 44 p. Postgraduate research grant programme 2015 Olympic Studies Centre, International Olympic Committee.

The evolution of field hockey as an Olympic Summer Sport in the inter-war years was marked by two contrasting developments. England, the home of modern hockey, made a solitary appearance in Antwerp in 1920 (where the matches were held in early September) and won gold but thereafter refused to play while the other constituent parts of Great Britain stayed away from Olympic hockey altogether. On the other hand, India, then a colony under British rule, aligned with countries on the Continent and joined the newly founded International Hockey Federation (FIH) to take part in the 1928 Amsterdam Games and, over the next decade, played a crucial role in keeping hockey within the Olympic fold. My project examines England's reluctance, and India's eagerness, in the light of developments that were taking place in the history of hockey, the Olympic Movement and the world at large. This is the first systematic study of the emergence of field hockey as a permanent Olympic Summer Sport (men's field hockey has been a part of every Olympic Games since 1928) as it covers five archives in two countries, various online databases and a host of secondary sources including official reports, and newspaper and magazine articles.


### License to jump! : a story of women's ski jumping

Marit Stub Nybelius... [et al.]. Beijbom Books AB, 2015, 137 p. At the 2015 Nordic Ski World Championship in the Swedish resort Falun, the World Championship in women's ski jumping will be conducted. Women's ski jumping did not have a smooth way to become an internationally acknowledged and accepted sport. However, that struggle is no longer discussed. In many European countries women's ski jumping regularly gets TV coverage and the print media covers it in its sports sections. This book aims to give insight into the at least 150-year-history of women's ski jumping from its beginnings until it became an Olympic sport in the 2014 Sochi Games. It shows the struggle and effort of female ski jumpers, coaches, families and others to make this sport internationally recognized and accepted. The chapters reflect a collection of research done by international authors. Due to the accessibility of sources the main focus is on Europe and North America. However, we do not claim to offer a complete history: there are many histories of women's ski jumping, depending on the geographic location. We tried to avoid an overlapping of contents, which was not always possible, because each chapter was to be an entity in itself. In the future, still, bit by bit, little pieces have to be added to the puzzle to gain a complete picture of the evolution of this sport. Although all authors have an academic background in sport history and/or sport sociology and sport media, the book is aimed to appeal to the general public. For all those readers who are interested in more details, footnotes and references are added.

# The path to global sport sponsorship success: an event history analysis modeling approach

However, despite the importance of a sponsorship's duration to both sides of the relationship, it is not well–understood whether certain factors or conditions can jeopardize these cooperative, business-to-business partnerships. Therefore, this study intended to further understanding of the relationship between sponsorship sellers and buyers by investigating factors that may predict the dissolution of such partnerships. From a theoretical standpoint, the study represents an important extension of the relationship marketing paradigm to better understand the dynamics of the sponsorship business-to-business relationship.





For many athletes around the world there is just one sporting competition that truly matters: the Olympic Games. Unfortunately, the available spots are scarce. In many sports it does not suffice to be second, you need to be the best amongst your countrymen. It is obvious that the decision to let someone go or not to the Games is a fruitful source of disputes. The present article focuses on the role of the Court of Arbitration for Sport (CAS) in resolving selection disputes. The ambition is to provide a practical guide for the disputes ahead and to showcase the CAS as a useful avenue to resolve them.



### Nothing but medals?: attitudes towards the importance of Olympic success Jan Haut, Robert Prohl, Eike Emrich. IN: International review for the sociology of sport,

volume 51, number 3, May 2016, pp. 332-348.

States intervene increasingly in financing and organization of Olympic elite sport in order to maximize national success in the medal table. Are those efforts reflected by a strong desire for medals within the population? Is national success regarded as so important that even critical measures are accepted? And would that indicate more general tendencies to nationalistic or authoritarian attitudes? These and other questions were addressed in a survey carried out in Germany in 2012. Results show that medals are indeed perceived as important, especially in lower educational levels, but by far not as important as sticking to sporting values and the rules of fair play. Multivariate analyses reveal that the desire for medal success is highly dependent on the belief in and perception of the Olympic competition.



This book explores several cultural and historical paths intertwined in the genesis and development of sport and physical activities within colonial and postcolonial contexts. As far as youth organizations and Western-based sports are concerned, the Independencies political split needs to be reconsidered, from a cultural perspective with practices overlapping spatial, chronological and epistemological borders. When looking at the variety of practices, the colonial legacies and the ensuing migration journeys through a global perspective, there is a need to understand the diverse ways of composing and building the postcolonial sport worlds. 



# The women's Olympics?: a gender analysis of NBC's coverage of the 2012 London Summer Games

Roxane Coche, C. A. Tuggle. IN: Electronic news, volume 10, number 2, June 2016, pp. 121-138.

This study examines NBC's U.S. prime-time broadcast coverage of the 2012 Summer Olympic Games for gender equality and compares that coverage to previous years. Olympic coverage is particularly important to female athletes because many receive little media attention beyond Olympic competition. The study found that, for the first time since 1996, NBC gave more airtime to women's sports than to men's sports. However, most of that coverage devoted to women's events was confined to "socially acceptable" sports.
