

UNHCR continues to advocate for closer co-operation and coordination with the Government, civil society and other UN agencies to provide protection and support to persons of concern.

Recent operational activities and highlights

Protection:

In January 2012 the Ministry of Interior (MOI) established a Working Group to amend the Refugee Law and to adopt internal instructions on asylum matters. UNHCR has been actively involved in the Working Group and expects to see positive developments during the course of the year. UNHCR continues to provide legal assistance to refugees and asylum-seekers ensuring their access to the national asylum system and preventing cases of detention and deportation of refugees.

Registration:

Registration/verification exercise of 2011 conducted with the Government was completed UNHCR plans to assist the Government with the development of a specialized database.

Assistance and community services

UNHCR provides material, financial, medical and/or social assistance to persons of concern in doing so UNHCR also works with refugee communities to mobilize self-reliance of refugees.

UNHCR supports refugee children to ensure their access to education (provision of books, school uniforms and enrollment in extracurricular courses, such as Cyrillic script and Tajik History). With the assistance from the German Government UNHCR runs the DAFI project assisting young refugees to pursue higher education in Tajik universities through yearly scholarships.

Durable solutions for refugees


UNHCR engages all three durable solutions in its operation in Tajikistan. Assistance is provided to mainly Afghan refugees who wish to repatriate to their country of origin. Resettlement is pursued for particularly vulnerable individuals. Finally, legal assistance is provided to persons who meet the requirements for naturalization under the citizenship law.

Government capacity building:

UNHCR assists the Passport Registration Service under the Ministry of Internal Affairs in establishing an adequate asylum system. In this regard, UNHCR participates as observer in the National Refugee Status Determination Commission advising and guiding the government on international standards and practices in the refugee status determination process. UNHCR also provides training and technical assistance to relevant government structures (Ministry of Interior, Prosecutor's Office, judiciary, lawyers, etc.)

Statelessness:

UNHCR is working in Tajikistan with relevant government partners on developing a national plan of action for identification of stateless persons and finding solutions to their situation. An important part of this work is to remove gaps in the national legislation and its procedures. UNHCR continues on advocate for the Tajikistan's accession to the Statelessness Conventions.
