Guidance Note on the Preparedness Package for Refugee Emergencies

1. In response to the high demand from field operations for support with preparedness and contingency planning for refugee emergencies, the Emergency Capacity Management Service of DESS developed the Preparedness Package for Refugee Emergencies (PPRE). The development of the Package took place in cooperation with the Regional Bureaux, support Divisions as well as a 'field reference' group, comprised of colleagues working in various regions.

- Systematic emergency preparedness and early planning are known to have a positive impact
 on the quality and timeliness of the refugee emergency response. Effective and timely contingency
 planning, involving partners from the outset, strengthens UNHCR's leadership and response to
 emergencies.
- 3. The purpose of the Preparedness Package for Refugee Emergencies (PPRE) is to provide guidance to UNHCR operations and partners on standard preparedness actions, risk analysis for refugee emergencies, and contingency planning practice. The objective is that these actions are taken *before* the refugee emergency occurs. Field operations and the Regional Bureaux should use this guidance as part of their regular operational activities. The checklists and format can be adapted to situation specific needs.

The Guidance Note sets benchmarks for the following areas:

- a. Minimum Preparedness
- b. Refugee Emergency Risk Assessment
- Advanced Preparedness
- d. Contingency Planning Process and Format (Country and Regional Level).

- 4. The PPRE forms part of the "Guidance Notes on "Strengthening UNHCR's Emergency Policy and Procedures", as Guidance Note 7¹. It supersedes all previous guidance on contingency planning for refugee emergencies and is aligned with the new IASC Emergency Response Preparedness (ERP) approach.
