





4. Population reached through Protection interventions


Services provided:

- Resettlement, Registration, Documentation and legal.

6. Key Achievements

- Continuous advocacy efforts managed to decrease the rates of deportation.
- Focused on legal issues related to documentation, including development of coordinated response to refugees with documentation problems contributing to protection concerns. At each governorate level NGOs provided guidance on the documentation related problems, supported families and ensured referrals to legal partners.
- Focused on finding solutions to ongoing issues such as early marriages, child labor, Informal tented settlements and people with disabilities by establishing/reviving taskforces or ad-hoc coordination bodies such as ITS, Legal and Documentation. The objective was to set guidelines and minimize impact on people with vulnerabilities.
- Child Protection working group in cooperation with the Family Protection Department of the Government of Jordan established and launched the Standard Operating Procedures for Best Interest Determination (BID) of refugee children in Jordan.
- Targeted to achieve efficiency of the projects implementation and proper addressing needs of beneficiaries by
 mainstreaming coordination tools such as ActivityInfo, Needs Assessment Registry and Services Advisor.
 UNHCR, UNICEF and UNFPA assisted the National Council for Family Affairs in two workshops aimed at
 establishing parliamentary support for a revised draft of a Family Protection Law containing key protection
 provisions against violence within the family.

7. Challenges faced during the reporting period

- Out of 38 organizations participating in the Inter-Agency in 2017 in the Protection sector, only 22 reported receiving funds in the first quarter.
- Staff turnover in NGOs and UN agencies requires regular attention of the sector coordination to keep all the members updated on the sector priorities and requirements.
- Continued weakness by some partners in reporting their progress...etc.
- Commitment towards the coordination mechanism to the Syrian Response to be recognized by all sector members as not limited to attending coordination monthly meetings.

8. Key priorities and gaps foreseen in the 2nd quarter (April - June)

- Continued coordination between members of Protection sector on to increase legal services to refugees.
- Enhance linkage between Shelter and Protection sectors to ensure efficient identification of cash-for-shelter beneficiaries
- Strengthen reporting and monitoring of activities and progress towards goals by means of continuous training
 of partner agencies, promotion of reporting requirements, and analysis of the collected data on the sector
 implementation.
