On Approval of the Procedure for Execution, Issuance and Extending Validity of a Refugee's Certificate

In order to assure issuance of refugee's certificates, in pursuance of the Resolution of the Cabinet of Ministers of Ukraine *On Approval of Regulations on a Refugee's Certificate* dd. October 11, 2002 # 1527 (1527-2002-p) (as amended) I HEREWITH ORDER TO:

1. Approve the Procedure for Execution, Issuance and Extending Validity of a Refugee's Certificate (hereinafter — "the Procedure"), as attached.

2. Make following amendments to clause 6 of the *Temporary Instruction on Execution* of Documents Required for Solving Issues of Granting, Loss and Deprivation of the Refugee Status, as approved by the Order of the State Committee for Nationalities and Migration of Ukraine dd. April 29, 2002 N 20 (z0422-02), registered with the Ministry of Justice of Ukraine on May 11, 2002 under N 422/6710:

To declare null and void sub-clauses 6.2, 6.3;

In this connection, to consider sub-clauses 6.4, 6.5 as sub-clauses 6.2, 6.3, respectively.

3. T.Ye.Fandykova, Deputy Head of the Department for Refugees and Migration, should assure public registration of the Order with the Ministry of Justice of Ukraine.

4. K.P.Denha, Chartered Secretary and Chief Accountant, should provide migration service departments (agencies) in the Autonomous Republic of Crimea, oblasts, Kyiv and Sevastopol cities with the required number of application forms and should assure production of stamps for extending validity of refugee's certificates and issuance of a refugee's travel documents for traveling abroad.

5. L.S.Hryshko, Head of the HR Department, should assure informing heads of migration service departments (agencies) in the Autonomous Republic of Crimea, oblasts, Kyiv and Sevastopol cities on the Order within five days after its coming into effect.

6. Heads of migration service departments (agencies)) in the Autonomous Republic of Crimea, oblasts, Kyiv and Sevastopol cities should assure implementation of the Procedure as approved herein.

7. The Order shall come into effect in 10 days upon its state registration with the Ministry of Justice of Ukraine.

8. Cancel the Order of the State Committee for Nationalities and Migration of Ukraine dd. October 21, 2004 # 55 On Approval of the Procedure for Execution, Issuance and Extending Validity of a Refugee's Certificate.

9. Yu.M.Sukhov, Deputy Head, shall be responsible for control over execution of the Order.

PROCEDURE FOR EXECUTION, ISSUANCE AND EXTENDING VALIDITY OF A REFUGEE'S CERTIFICATE

The present Procedure has been executed in accordance with the *Regulation on a Refugee's Certificate*, approved by the Resolution of the Cabinet of Ministers of Ukraine dd. October 11, 2002 N 1527 (1527-2002-p) (as amended)

1. General Provisions

1.1. A refugee's certificate (hereinafter — "the Certificate") shall be a passport document, which identifies a person, confirms the fact of granting the refugee status in Ukraine to such person; it shall be used for execution of rights and fulfillment of obligations, as provided for by the Law of Ukraine *On Refugees* (2557-14) and other laws of Ukraine.

1.2. The Certificate shall be issued to a foreigner or a stateless person aged 16, by a migration service agency in the Autonomous Republic of Crimea, oblasts, Kyiv and Sevastopol cities (hereinafter — "migration service agencies") based on decisions of the State Committee for Nationalities and Migration of Ukraine on granting the refugee status in Ukraine to a foreigner or a stateless person.

A separated child, who has been granted the refugee status in Ukraine, shall be given a certificate before reaching 16.

2. Execution of the Certificate

2.1. When a migration authority has executed a written conclusion on granting / refusal in granting the refugee status, a foreigner or a stateless person — subject of the decision on execution of documents for solving the issue of granting the refugee status (hereinafter — "an applicant") — should be summoned to the migration authority for execution and submission of:

- an application for issuance of a refugee's certificate (hereinafter — "an application form") in a form of the Attachment 1, signed by an applicant;

- two pictures having dimensions of 35 x 45 mm;

- two 35 x 45 mm pictures of each family member of an applicant under 16, who stays with him/her in Ukraine, and data on whom have been entered into an application form of a person appealing for the refugee status (one picture should be pasted in an attachment to an application form alongside with a child's personal data).

A foreigner or a stateless person may file the above documents to a migration service agency in person or through his/her legal representative.

A migration service agency should verify data presented in documents, as referred to in clause 2.1 herein.

Validity of entries in an application form should be certified with a signature of the head of a migration service agency and the seal of such agency.

An application form with accompanying documents should be attached to a personal file of an applicant; it shall form an integral part thereof.

A completed personal file of an applicant shall be sent to the State Committee for Nationalities and Migration of Ukraine in accordance with paragraph 8 of sub-clause 5.1. of the *Temporary Instruction on Execution of Documents Required for Solving Issues of Granting, Loss and Deprivation of the Refugee Status*, approved by the Order of the State Committee for Nationalities and Migration of Ukraine dd. April 29, 2002 # 20 (z0422-02), registered with the Ministry of Justice of Ukraine on May 11, 2002 under # 422/6710 (as amended).

The State Committee for Nationalities and Migration of Ukraine shall fill in a certificate and send it to the relevant migration service agency by courier for further handing to a refugee within three days after adoption of a decision on granting the refugee status.

An entry on execution of a certificate should be made in a reserved field of an application form.

3. Procedure of Filling In the Refugee's Certificate

3.1. A refugee's certificate should be executed in line with data indicated in an application.

3.2. Data of a certificate should be printed in black in the visual inspection field. Printing height should be 3 mm, with horizontal printing density — 15 charters / 24.5 mm.

Field titles should be printed in black. Height of capital letters should be up to 1.3 mm, small letters — up to 1 mm.

3.3. Filling in data fields:

3.4. Dates should be indicated as follows:

Day — 2 figures (1 to 9 should be preceded by 0), followed by a white space, Month — 3 letters

January — JAN;	July — JUL;
February — FEB;	August — AUG;
March — MAR;	September — SEP;
April — APR:	October — OCT;
MAY — MAY;	November — NOV;
June – JUN;	December — DEC.

Year — white space followed by two last figures.

3.5. If a date of birth or a part thereof is missed, they shall indicate "XX" or "XX" instead of a date or a year, and "XXX" — in place of a month, and "XX XXX XX" — in place of a date, month and year, respectively.

3.6. Sex shall be indicated as follows: "female" for female, and "male" for male.

3.7. Data on children shall be field in the special filed "Children" on pages 3, 4 and 5 of the document.

3.8. An official stamp of the State Committee for Nationalities and Migration of Ukraine should be affixed to the uppers right corner of a picture of a receiving applicant, pasted in a reserved field of the Certificate. An official stamp of the State Committee for Nationalities and Migration of Ukraine should be affixed to pictures of children pasted on pages 3, 4 and 5 of the Certificate and seal of an authorized officer of the State Committee for Nationalities and Migration of Ukraine.

4. Issuance of a Certificate

4.1. A certificate shall be issued by a migration service agency, which considers the relevant case on granting the refugee status, within seven working days after the State Committee for Nationalities and Migration of Ukraine hands over the certificate, to a person whose name is indicate in a certificate, in person.

In order to receive a certificate, a refuge should arrive at the migration service agency.

A refugee shall certify reception of a Certificate with his/her personal signature in a relevant field of a Certificate and the refugee certificates' registration log (Attachment 2).

The State Committee for Nationalities and Migration of Ukraine should be informed on a data of a Certificate's issuance and the reference number thereof without delay.

The reference number of a Certificate and date of its issuance should be entered into the reference databank of the centralized informational system of the State Committee for Nationalities and Migration of Ukraine. 4.2. At issuance of a refugee certificate, a certificate the fact that a decision was made to process a person's documents for solving the issue of granting refugee status in Ukraine or a certificate confirming appeal to court should be withdrawn from a refugee.

5. Exchange and Renewal of a Certificate

5.1. A certificate shall be exchanged if all pages reserved for its extending, change of a refugee's family name and/or name are filled in, some discrepancies in entries are revealed or it becomes unsuitable for use.

5.2. In order to exchange a certificate, a refugee shall file documents, as referred to in clause 2.1 herein, and a certificate the migration service agency at the place of his/her residence. If a certificate is exchanged due to alteration of a family name, name, discrepancies revealed, a refugee should also submit documents validating reasons of such exchange.

5.3. In case of loss of a certificate, a refugee should inform an interior body and a migration service agency at the place of his/her residence thereof within three working days.

5.4. In order to renew a certificate, he/she shall submit:

- documents, as referred to in clause 2.1 herein;

- a certificate confirming registration of a refugee's application on loss of a certificate, issued by an interior body, or a certificate on opening (refusal in opening) or closing a criminal case on stealing a certificate, issued by an interior body.

5.5. Within three days, a migration service agency shall verify data, as referred in an application form and documents attached thereto. Should any doubts concerning credibility of information or any need in authentication and verification of documents validity occur, a migration service agency shall have the right to address appropriate requests to interior bodies, the State Security Service, other governmental authorities, bodies of local self-government and civic organizations in order to receive assistance in determination of true facts concerning such person

Based on verification results, the head of a migration service agency shall sign an application form and affix an official seal thereto.

An application form and enclosed documents should be sent to the State Committee for Nationalities and Migration of Ukraine.

A certificate to be exchanged should be given back to a refugee before the actual exchange takes place.

5.6. A certificate should be exchanged / renewed subject to the relevant decision of a migration service agency with making a special entry in a reserved field of an application form.

The State Committee for Nationalities and Migration of Ukraine shall exercise the new certificate within seven working days after the relevant decision is made.

An executed certificate shall be sent to the relevant migration service agency for handing over to a refugee.

6. Extending Validity of a Certificate's Term

6.1. A Certificate's validity shall be extended at re-registration of a refugee by a migration service agency at a place of his/her residence.

6.2. In order to extend a certificate's validity, a refugee shall submit:

- his/her application on extending a certificate's validity (Attachment 3) bearing his/her signature;

- a certificate to be extended bearing an entry of an interior body on registration of a refugee at the place of his/her residence.

If an application is filed through a legal representative, his/her powers should be verified under the procedure established by the law.

An application and enclosed copies of documents shall be registered in the refugee certificates' registration log.

6.3. A migration service agency shall consider an application on extending a refugee's certificate validity within seven working days after its submission.

Based on consideration results, a migration service agency shall pass its decision.

6.4. A term of validity of a certificate shall be extended based on the relevant decision on extending of a certificate's validity with making a relevant entry in a special reserved field of an application.

6.4. A migration service agency shall extend a certificate's validity by affixing a stamp on extending of a certificate's validity (Attachment 4); a sealed certificate shall be handed over to a refugee.

A stamp on extending of a certificate's validity should be affixed to pages 7-8 of a certificate.

6.6 If a travel document for traveling abroad is issued to a person, a relevant stamp shall be affixed to page 6 of a certificate.

7. Procedure of Review and Appeal against Decisions on Refusal in Exchange / Renewal or Extending a Certificate's Validity

7.1. During re-consideration of an application on exchange / renewal or extending a certificate's validity, relevant documents submitted before, should be taken into account.

In case of refusal in exchange / renewal or extending a certificate's validity, a repeated application may be positively resolved if circumstances preventing exchange / renewal or extending of a certificate's validity ceased to exist.

7.2. In case in refusal in exchange / renewal or extending of a certificate's validity, a migration service agency shall inform the person concerned thereof in writing, specifying the reasons of refusal.

7.3. If a claim is satisfied, a migration service agency and the State Committee for Nationalities and Migration of Ukraine shall fulfill a court decision without delay.
