She also oversees projects implemented by IOM in the region. During the previous eight years Ms. Marin was the coordinator of the Counter-Trafficking Regional Unit for Central America and Mexico which allowed her not only to implement projects on direct assistance to victims but also to provide technical support to governments to put into place CT national and regional initiatives and enhance cooperation in the region. Ms. Marin holds a Master Degree in International Development from Clark University, Massachusetts.

Ana Hidalgo, is a psychologist with Master Studies on Women's Issues by the University of Costa Rica. **Brandon B. Prelogar** He is the Special Advisor for Refugee & Asylum Affairs at the Department of Homeland Security's (DHS) Policy Directorate. He previously served as the Acting Special Advisor for Refugee & Asylum Affairs, and before that as the Policy Directorate's Senior Policy Advisor for Refugee & Asylum Affairs. Before joining the DHS headquarters' Policy Office, Prelogar worked as a U.S. Citizenship and Immigration Services (USCIS) Refugee Officer in the Refugee Affairs Division's headquarters office. He is a graduate of the Yale Center for International and Area Studies, where he received a Master's degree in International Relations, and Dartmouth College, where he received a Bachelor's degree in philosophy. Prelogar also served as a U.S. Peace Corps volunteer in Bulgaria.

Bruno Stagno Ugarte Ministry of Foreign Affairs of Costa Rica. He served as President of the Assembly of State Parties of the International Criminal Court. Carmen Moreno, is Executive Secretary of the Inter-American Commission of Women (CIM) of the Organization of American States (OAS). Her functions include advising the Member States and the General Secretariat regarding gender equity, political and economic empowerment of women, women's human rights, and the elimination of violence against women. She served as Director of the United Nations International Research and Training Institute for the Advancement of Women (UN-INSTRAW) based in the Dominican Republic. Ambassador Moreno was the first woman to be appointed as Eminent Ambassador of Mexico, and represented her country at international meetings on gender, political, economic, and social issues. She has served as Ambassador for Mexico in several countries and organizations. She has a graduate degree in International Relations and is a member of the Association of Statespersons, the Mexican Foreign Service Association, the Mexican Pro-United Nations Association, and the Mexican Chapter of the International Society for Development, as well as a Founding Member of the Center for Strategic Analysis and International Negotiation.

**Carmen Rosa Villa Quintana**, is the Regional Representative of the United Nations High Commissioner for Human Rights. Mrs. Villa-Quintana, of Peruvian nationality, worked for the Judicial Branch and the Public Ministry of her country until 1993, when she began her career as an international officer. She participated in the United Nation's Verification Mission in Guatemala, headed the High Commissioner's Office in Columbia starting in 1999, and since 2006 has served as Representative for Latin America and the Caribbean.

Charu al-Sahli was hired as FIAC's Statewide Director in February 2006. She was FIAC's Advocacy Coordinator for Detention from 2001-2004. She completed a six-month apprenticeship at IOM Headquarters in Geneva with the Department of Trafficking in Persons and Assisted Voluntary Returns. She has completed coursework in children's rights and trafficking prevention and protection with the ILEA and in Israel. Recently she has joined IOM El Salvador in charge of trafficking issued.

**Erika Feller,** United Nations Assistant High Commissioner for Protection, UNHCR. Erika Feller, an Australian national, holds since January 2006 the post of Assistant High Commissioner for







Protection, one of the four top management positions with the United Nations High Commissioner for Refugees. Ms. Feller has more than 38 years of experience in international human rights and refugee law, a field in which she has published extensively. Her professional career has included 14 years and three international postings with the Australian Diplomatic Service, including as Head of the Australian Foreign Ministry's Human Rights Section. In her 23 years at UNHCR, she has served in various capacities in the Department of International Protection, including as its Director, but also as the High Commissioner's Regional Representative for Malaysia, Brunei and Singapore, and Regional Coordinator for the Comprehensive Plan of Action for Indo Chinese Refugees. Ms. Feller has traveled extensively, throughout Africa, Asia, Europe, the Middle East and North America, for the purposes of advice and negotiations with Governments on their asylum policies and practices. Ms. Feller is a graduated from Melbourne University in 1971 with an honours degree in Law, coupled with a Bachelor of Arts degree [LLB{hons}/BA]. She is married, with two children.

Fabián Oddone Argentina. He is currently working in the Direction of Human Rights, of the Ministry of International Relations of Buenos Aires. He is in charge of the coordination of the National Plan against Discrimination; Member of the National Commission for Refugees; working as representative of the Ministry of International Relations in subjects such as migrations, promotion of human rights at national level; etc. He has a Master in Laws of Georgetown University, Washington, D.C.; a diploma of the Instituto del Servicio Exterior de la Nación; and a Law degree of the Faculty of Law of the National University of Buenos Aires. He has served as a professor in several international forums. He has published articles on issues related to nationality, discrimination, democracy, migrations, refugee law and human rights.

**Gabriela Saavedra Fainé** Chilean, statistics graduate from the Catholic University of Chile. With experience in the Department of Migration and Foreign Relations of the Ministry of Interior since 1990, serving as Chief of the Visa Division. As part of her duties she participated in tasks involving requests seeking refuge and resettlement. In April of 2005, she was named Chief in charge of the recently created Refuge and Resettlement Division. Currently, she is responsible for the processing of refuge and resettlement requests, analysis and presentation of the cases to the Commission of Refugee Status Recognition and of proposing government policies to the authorities of the Ministry of Interior, so that the State may have the capacity to adapt to the especial conditions of refugees. In the same sense, she must propose plans that facilitate the integration process of refugees in the country.

**Halima-Sa'adia Kassim** holds a Ph.D. in History from The University of the West Indies. She has published papers on Muslim women in Trinidad focusing on education and community development. Prior to joining the CARICOM Secretariat, Halima taught Sociology and History at a community college in Trinidad and later was in education administration. Since joining the CARICOM Secretariat, Halima has written several technical papers on migration, MDGs, child protection and gender.

Janina Del Vecchio Ugalde Minister of Governance, Police, and Public Security, previous to her appointment she served as Congresswoman in the Legislative Assembly of the Costa Rican Republic, as Chief of the Presidential Cabinet under Dr. Oscar Arias Sánchez, and also held many other posts in Costa Rican Foreign in embassies in Spain, the Holy See, the Sovereign Military Order of Malta, Switzerland, and before many organizations within the United Nations framework. She was Vice-rector of Education and served in other academic and administrative positions within the University of Costa Rica. Mrs. Del Vecchio is the author of multiple articles and has been a speaker at many international forums in the diplomatic, economic, and international relations spheres for Latin America before the European Community. Jorge Martínez Pizarro is a geographer and demographer and works a researcher for the Population Division of the Latin American and Caribbean Demographic Center (CELADE) of the Economic Commission for Latin America and the Caribbean (ECLAC) in Santiago, Chile. He specializes in issues relating to international migration, rights, and development in Latin America and the Caribbean. He has participated in various studies on said issues and on population and development in the region. He has authored numerous publications focusing on (among other topics) the relationships between population and poverty, between migration, development, human rights, globalization, and integration, and between the migration of skilled labor, gender, and women, as well as countrywide studies for several countries on international migration, internal migration, urbanization, and spatial population redistribution. He has also participated in the preparation of various institutional documents for CELADE and ECLAC on population and development, besides joining numerous technical assistance missions to Latin American and Caribbean countries and serving as a member of CELADE's teaching staff.

Jorge Peraza-Breedy Currently holds the position of Coordinator to the Technical Secretariat of the Regional Conference on Migration (RCM or Puebla Process). Anthropologist and Industrial Engineer from the University of Costa Rica. Also, he has a Masters in Development Policies from the Institute of Social Studies in The Hague, Netherlands. Before his post at the RCM, he worked over 6 years with the International Organization for Migration (IOM) as a Specialist in Programs of the Migration Management Links and Services Unit (ESEMI) in IOM's Regional Office for Central America and Mexico. Previous to this, he worked with several of non-governmental organizations in the promotion of cultural exchange programs and environmental protection. His experiences in migration matters include the development and implementation of migration management projects (issuance of travel documents, border management, strengthening of institutional capacities), labor migration and remittances. He has also taught in the University of Costa Rica and in the Inter-American Institute of Human Rights.

He has held various executive positions with the International Organization for Migration at IOM's Headquarters in Geneva, and in Bangkok, Cairo, and Vienna over his many years of service to the Organization. He currently is the IOM Regional Representative for Central America and Mexico. His academic credentials include a Master's Degree in Sociology from the University of Amsterdam, chemistry studies at the University of Lisbon, and planning studies at the University of Amsterdam.

**Katya Somohano,** was born in Mexico City. She is a lawyer from Universidad Nacional Autónoma de México, with a Master's Degree in International Law from Cambridge University in the UK, and pursued studies in European Law in the same institution. She has served in a number of government institutions in the field of international affairs. She was Director of International Affairs of the Puebla Panama Plan in the Secretaría de Comercio y Fomento Industrial (SECOFI). She was Director of Juridical Affairs at the Security Council of the UN while working for the Ministry of Foreign Affairs. She participated in international negotiations of a number of juridical instruments and at the UN Sanctions Committees of countries with supervision regimes, and in







the follow up of the peace-keeping operations. She acted as Deputy Personal Assistant to the Minister for Foreign Affairs. She has been Professor of International Law and Community Law at the Law School of UNAM. She is member of the Mexican Council of International Affairs (COMEX), and is presently General Coordinator of the Mexican Support Commission for Refugees (COMAR), decentralized agency of the Ministry of Interior.

Laura Thompson Chacón Deputy Director General of the International Organization for Migration (IOM), previously she was the Ambassador and Permanent Representative of Costa Rica to the United Nations Office and other International Organizations in Geneva. Over the course of her diplomatic career, she has represented Costa Rica to UNESCO, the United Nations and other international organizations in Geneva. In this capacity, Ambassador Thompson Chacón chaired several bodies on migration and refugee related matters, including the Executive Committee and the Council of the International Organization of Migration, and the Executive Committee of the United Nations High Commissioner for Refugees (UNHCR). Previously, she has held various posts as Legal Counsel to diverse international organizations in Geneva, including the United Nations Compensation Commission. She participated as a fellow professor or a panelist in several seminars and roundtables on a wide variety of subjects ranging from migration, human rights, education, environment, to disarmament and compliance with international treaties, throughout the regions of the world. Ambassador Thompson Chacón obtained a Masters degree in international relations with a specialization in international law from the Institut Universitaire de Hautes Etudes Internationales of Geneva and holds a degree in law from the University of Costa Rica.

Laurence Hart, has been working for the International Organization for Migration (IOM) since1999: he has served in Central America, Tunisia and, currently, in Libya. Before IOM, Dr.Hart has worked for UN and OSCE in the preparation, observation and follow-up of parliamentary and local elections in several areas of the Balkans: Bosnia-Herzegovina, Eastern Slavonia and Albania. Dr. Hart holds a degree in Political Science and a European Master's Degree on Human Rights and Democratization. He has also written several articles and made scientific contributions on migration, human rights and refugee issues in international contexts.

**Marcela Chacón** Costa Rica Vice Minister of Security, with special Strategic Management functions at the Ministry of Interior, Public Security and Police. For over 12 years, she has been responsible for the supervision of security and cooperation programs from the US Embassy in San José. Since 1999 she held the position of legal specialist and training official of the Defense Office of that diplomatic mission. She has received awards and acknowledgements by the Embassies of the US and Canada, as well as from the US Department of Defense. She is a lawyer and notary public.

Marcia Bebianno, Organization of American States.

María Mercedes López Peña Salvadoran citizen, Ms. López-Peña has a Licenciatura in Modern Languages from Los Angeles City College, and a vast experience in Management and Municipal







Training. She has held positions such as Executive Director of CARECEN Steering Committee, integrated by the Universidad Centroamericana José Simeón Cañas (UCA), Catholic Relief Service (CRS), FESPAD in El Salvador. Program Manager responsible for the follow up and management of CARECEN International Programs in Human Rights, in Houston, Texas; legal advisor, responsible for education and promotion of activities such as visits to human rights centers in the migrants route in Central America. While living in Los Angeles, CA, she worked at the Central American Refugees Center as a social worker. She is an associate member of women organizations, with experience in organizing volunteer groups of youngsters in topics such as HIV, Environment and Migration. She is presently Deputy Director General of Migration for El Salvador.

Mario Zamora Cordero Costa Rican citizen, he has a Doctor's Degree in Political Science and Sociology from the Universidad de Granada, and a Doctor's Degree in Law from the Universidad de Salamanca, both in Spain. He pursued other graduate studies in Spain, Costa Rica and Colombia, in Latin American Studies, Criminal Justice Administration, and Community Law. He is an international speaker and has held a number of positions at the Ombudperson's Office and at the Ministry of Interior and Public Security. He is presently Director General of Migration and Alien Affairs of Costa Rica.

Mark Fleming, is a staff attorney in the Inter-American Commission on Human Rights' Rapporteurship on the Rights of Migrant Workers and their Families. As part of the Rapporteurship's work, Dr. Fleming has lead the Commission's investigation into human rights concerns regarding U.S. immigration detention and due process and recently coordinated the Inter-American Commission's visits to U.S. immigration detention facilities in Texas and Arizona. The Commission intends to release its full report in the coming months. Dr. Fleming also manages the Inter-American Commission's docket of individual cases related to migrant workers' rights in the hemisphere.

Marta Juárez, Director Bureau for the Americas. Marta Juarez assumed her functions as Director of the Bureau for the Americas at UNHCR Headquarters in Geneva on 1 August 2009. With more than 25 years of experience with UNHCR, her different responsibilities around the world have given Ms. Juarez a deep knowledge of refugee issues. Marta Juarez started her career in Mexico, her country of origin. Afterwards, she served at UNHCR Headquarters in Switzerland, in the Office in Dar-as-Salaam, United Republic of Tanzania, in Pakistan, as Assistant Representative and then in Sri Lanka as Operations Coordinator in the area then controlled by the Liberation Tigers of Tamil Eelam (LTTE). At the end of the year 2000, she returned to UNHCR Headquarters as Senior Resource Manager for the Bureau for the Americas; during those four years, she administered human and financial resources of the whole American continent, responsible for budgetary allocation for the implementation of country programmes, and acted as Officer in charge of the Bureau. From 2005 to July 2009, she was UNHCR Representative in Ecuador where an innovative programme was designed and implemented for the registration and recognition as refugees of thousands of asylum-seekers in remote and isolated areas within the country.







**Nadine Perrault**, has been a leading human rights lawyer in Haiti and an activist for women's full participation. Following the Vital Voices conference of the Americas in 1998, Nadine returned home to spearhead the Vital Voices Chapter in Haiti, Femmes en Democratie, which now includes over 100 women leaders throughout Haiti. She currently serves as a founding Board member for Vital Voices Haiti and an Advisor to UNICEF at the United Nations in New York.

Patricio Zuquilanda-Duque He is Permanent Representative of the Organization of American States (OAS) in Costa Rica. He has a Doctor's Degree in Jurisprudence from the Universidad Central del Ecuador, pursued graduate studies in International Trade at GATT in Switzerland, graduated from the Universidad Federal del Estado de Pará in Brazil as a specialist in Regional Development and Amazonian Affairs, and also graduated from CEPAL in Santiago de Chile. In addition, he has a Licenciatura in Political Science.
