1. Weekly activities	
	UNHCR – 22 refugees were detained by FAA during the days leading up to the PWG. Those detained were released with their documents following an intervention from UNHCR and MINARS. Urban refugees from Dundo have been arriving in Cacanda reception centre worried about deteriorating security situation in Dundo.  Advocacy must be increased to ensure that refugees are not detained indiscriminately. Refugees should have freedom of movement within Dundo.  UNHCR is working with SME in creating a mechanism to alert UNHCR/SME when refugees are detained.  Weekly relocation from Cacanda to Lovua continued, with 320 individuals relocated. Families living in the area prone to flooding in Cacanda were given priority.  Initial consultations with community have taken place regarding representation and community structures in both Lovua and Cacanda.  UNICEF — currently consolidating PPA's with partners. Caritas will be responsible for the management of the UAM shelter, which will be moved from Cacanda to Lovua in November. World Vision have arrived in Dundo to begin working with UNICEF in CP case management. They may recruit refugees, such as the community mobilisers as they live and work in the field, in order to expand the CP team.  Caritas has been focusing on physical control of the UAM shelter, however a gap has been identified in the daily routine/activities of the children.  World Vision — Are developing a work plan. This week they have been working with UNICEF to understand who does what and the context and coordination mechanisms in Dundo.  ICRC — have trained 4 volunteers and 2 coordinators in Cacanda to begin family tracing services. The process has also been explained to the leaders in Cacanda. Priority when using the services will go to those who have never had contact with families since flight.  Services will start from Monday 25th September.  In the coming 2-3 weeks ICRC hopes to recruit volunteers in Lovua.
