

The High Commissioner's statement will provide an overview of the operational and policy priorities of his Office.

The general debate is articulated around issues raised in the statement of the High Commissioner. For its preparation, the Committee will have received an outline of the High Commissioner's statement in advance of the session. The Committee will also have before it brief updates on developments at the regional and global levels.

The list of speakers for the general debate will be opened on 5 September 2016.
