


# **Burkina Faso**

June 2017

Burkina Faso hosts approximately 34 000 Malian refugees living in and around two camps in the Sahel Region. The country knows also some urban refugees and asylum seekers. Given the prolonged crisis in Mali, UNHCR is reorienting its programs towards the transition from traditional assistance to livelihood activities and cash based interventions. Following several security incidents since 2016, refugees are more and more prone to stigmatisation from the host community.

#### **POPULATION OF CONCERN AS OF 30 MAY 2017**





# Working with Partners

 UNHCR maintains a strong collaboration with its donors, sister agencies and the government's National Refugees Commission CONAREF. Together with nine selected partner organisations, UNHCR upholds efficiency in providing services to refugees.

## Main Activities

#### **Protection**

 Contributing to a favorable protection environment by ensuring fair protection processes and documentation, targeting assistance to people with specific needs, and promoting peaceful coexistence between refugees and local communities.

#### **Education**

 Ensuring optimal access to education by providing pre-school and primary education services in the refugee camps, maintaining school infrastructures, and supporting catch-up classes and vocational training.

#### Health

Optimizing the health status of the population by ensuring optimal access to primary healthcare
in the refugee camps, and facilitating access to secondary/tertiary healthcare services.

#### **Food Security and Nutrition**

Improving the nutritional well-being of the refugee households by preventing and treating malnutrition, and supervising the monthly food distribution in the refugee camps.

#### **Water and Sanitation**

Ensuring access to safe and potable water by maintaining water supply and sanitation systems;
 raising awareness on water preservation and hygiene, and providing soaps and hygiene kits.

#### **Shelter and NFIs**

Ensuring access to habitable covered living spaces that provide a secure and healthy
environment with privacy, comfort and dignity, by maintaining traditional emergency shelters
and constructing dome tents; providing non-food items to refugees in need.



#### **Camp Coordination and Camp Management**

• Optimizing the effectiveness of the camps' activities and strengthening community mobilization through meetings involving refugee leaders.

#### **Access to Energy**

 Promoting environment-friendly practices and ensuring access to domestic energy population by distributing firewood, promoting the use of solar cookers and developing innovative solutions.

#### **Community Empowerment and Self-Reliance**

Contributing to the economic self-reliance of persons of concern and their access to self-employment
opportunities, through capacity building and asset strengthening in the field of craftwork business, herd
management and milk production.

#### **Durable Solutions**

• Ensuring potential for voluntary return and resettlement is realized.

#### **Supply Management**

Ensuring the procurement of goods and services as well as an effective end-to-end delivery, warehousing, fleet and fuel management.
