

Terms of Reference and Work Plan GPC Task Team on Protection Mainstreaming

Revised: March 2017

I. Introduction

The Global Protection Cluster (GPC) Task Team on Protection Mainstreaming (TTPM) was established in 2009 to define the concept of Protection Mainstreaming as well as develop operational tools, guidelines, and training materials to promote Protection Mainstreaming within the humanitarian community¹. The TTPM has been working closely across sectors considering that Protection Mainstreaming is a responsibility of the humanitarian community as a whole. As such, the Task Team has increased and broadened its membership to better represent the cross-sector nature of Protection Mainstreaming and better reflect the perspectives and needs of non-protection actors. Complementarity with similar concepts and approaches such as Accountability, Gender, Child Protection and Inclusion has led to a close collaboration with other cross-cutting issues. Notwithstanding concrete achievements in raising awareness and knowledge on protection mainstreaming principles, promoting Protection Mainstreaming in humanitarian operations remains a high priority for the GPC in 2017. As such, the purpose of this document is to clarify the objective and ways of working of the Task Team on Protection Mainstreaming as well as highlight the key strategic activities of its annual work plan. Theses ToRs and Work Plan will be reviewed on a need basis, and at least once a year.

II. Vision and Mission Statement

The TTPM vision is that all humanitarian actors across sectors respect and fulfil the elements of Protection Mainstreaming in all humanitarian programmes by contributing to the promotion of Protection Mainstreaming as an essential element of humanitarian responses and a core principle of humanitarian programme quality. To achieve this, the mission of the Task Team is to develop the tools, trainings and support needed to global and field humanitarian actors to ensure that the letter and spirit of the key elements of Protection Mainstreaming are included in strategic and operational policies and guidance on humanitarian programmes throughout the humanitarian program cycle. The vision and mission of the Task Team support directly the IASC Statement on the Centrality of Protection (2013) and the IASC Protection Policy (2016), with Protection Mainstreaming being an enabler to achieving the Centrality of Protection at the field and operational level.

III. Ways of Working

1. TTPM Coordination Team

The Task Team is chaired by two members, one NGO and one UN Agency – currently the International Rescue Committee (IRC) and OCHA. The Task Team Coordinator is hosted by the IRC and dedicates the majority of his/her time to the implementation of the work plan².

This <u>Coordination Team</u> is responsible for:

- Reaching out to key actors to join and participate in the work of the Task Team, updating the list of members and their contact information.
- Representing the TTPM in global fora, including by attending meetings of the GPC PPRG, and of other Task Teams & AORs of the GPC as well as meetings and events from key stakeholders.
- Providing technical desk support through the GPC Helpdesk.
- Tracking progress, updating, and revising the ToR/Work Plan.
- Organizing calls every two months, take minutes and share relevant information on the GPC website and other networks.

2. Membership and Associated Organizations

The Task Team counts over 30 agencies/140 participants representing GPC AoRs, UN Agencies, NGOs, Global Clusters, and Key Stakeholders from across the humanitarian sector.³ Membership to the Protection Mainstreaming Task Team is open to any organization, agency or cluster that would like to participate⁴.

All members are expected to:

- Attend regularly the conference calls (the GPC Operation Cell is required to be present on all calls).
- Contribute to the development, implementation and monitoring of the ToRs and Work Plan.
- Volunteer to take the lead or support the implementation of activities listed in the Work Plan and regularly report on progress made.

3. Decision Making Processes

The co-leads will facilitate a transparent and collaborative decision-making process, referring to the GPC PPRG if no consensus is found. Any Task Team members can submit a suggestion regarding the development and implementation of the Work Plan allowing at least 10 working days for input and/or objections from other members. Lower level decisions about how to implement activities already in the work plan will be discussed with the members present on the call and shared through the minutes.

4. Task Team Conference Calls

The Task Team will hold one 90 minute (max.) call every two months. At least 3 days before the call, the co-leads will circulate an agenda allowing for all members to input and suggest modifications. Calls will primarily review the implementation of the work plan. Members of the Task Team can propose any topic of conversation related to Protection Mainstreaming. If these cannot fit into regular bi-monthly calls, additional thematic calls will be organized on an *ad-hoc* basis. The Coordination Team will prepare minutes of all calls and make them available through the GPC website and via email.
