SYRIA ARAB REPUBLIC: WHOLE OF SYRIA PROTECTION SECTOR RESPONSE ANALYSIS FOR 2017 (as of end-November 2017)




This analysis provides a snapshot of the protection sector response as a whole, as of 30 November 2017, including information on geographical coverage and progress against 2017 HRP targets, based on 4W reporting from protection partners in the various hubs. As of end-November 2017, the Whole of Syria protection sector, including Child Protection, GBV and Mine Action, has provided 6,469,100 protection interventions across Syria (67% of the 2017 HRP target), 903,100 of which were reported in November 2017. 35% of these interventions (2,247,500) are people reached through explosive hazards risk education. Another 380,100 are beneficiaries reached with women and girls empowerment and GBV prevention activities and 592,200 are girls and boys engaging in structured, sustained child protection programmes, including psychosocial support. Further, 777,200 protection interventions were conducted through explosive hazards risk education. Another 380,100 are beneficiaries reached with women and girls empowerment and GBV prevention activities and 592,200 are girls and boys engaging in structured, sustained child protection programmes, including psychosocial support. Further, 777,200 protection interventions were conducted through community based protection services (including awareness raising on protection risks, recreational and community mobilisation activities, targeted social and economic support for persons with specific protection needs/ vulnerabilities). In 2017, the sector and it's AoRs have been involved in 46 different advocacy initatives and have conducted capacity building initiatives on various protection-related fields of competence for 33,400 humanitarian partners.

Regarding other output indicators on protection interventions, as of end-November 2017, a total of 1,050 interventions supported community-based initiatives (85% of HRP target), 116,900 people received legal counselling or assistance, including on civil documentation and HLP issues (73% of HRP target) and 142,300 people received Psychological First Aid or structured psychosocial support (92% of HRP target). Protection monitoring which is a crucial tool to guide programming by informing all humanitarian actors of vulnerabilities, risks and protection concerns, was conducted in more than 237 communities in 2017.


To date, in 2017, Protection partners have reached 19 out of the 30 UN-declared besieged communities and 56 out of the 103 military-encircled areas in 2017*. The ability of protection partners to regularly assess those areas and conduct protection activities remains constrained and unpredictable, with 9 besieged areas reached in November 2017 (against 13 in October and 17 in July 2017). 67% of the total response was delivered in four governorates: Aleppo, Damascus, Homs and Rural Damascus and 58% of the total interventions were conducted in 47 sub-districts categorized as severity 5 or 6 of the protection severity scale (updated as of September 2017). Deir-ez-Zor governorate continues to be the lowest one served by protection partners, owing to the entire governorate still considered (ongoing military operation and widespread explosive hazard contamination).

OVERALL PROGRESS AGAINST HRP TARGET FOR 2017




NUMBER OF INTERVENTIONS AND GEOGRAPHIC COVERAGE REACHED IN 2017

Sector members have reached **1,841** communities in **233** sub-districts in 2017, with **685** in **180** sub-districts in November. Five sub-districts: A'rima, Bulbul, Haritan (Aleppo), Eastern Bari (Hama) and Kiseb (Lattakia) and 100 communities across the country have been reached in November, for the first time in 2017. The increase in the number of interventions in April and May is due to the cumulative reporting of students who have completed risk education activities towards the end of the school year.



RESPONDING PARTNERS


The sector had 51 unanonymised organizations, taking part in the HRP for 2017, alongwith several anonymised NGOs. As of October, **120** organizations have reported to the 4Ws. In total, the sector partners with **196** organizations, of which **164** implement protection activities on ground.

COMPARISON OF RESPONSE BETWEEN GOVERNORATES/COHERENCE OF COVERAGE ACROSS THE RESPONSE

The graph below reflects a generally proportionate overall response between the percentage of protection interventions and percentage of total People in Need (PiN) in each governorate, main exceptions being Aleppo, Damascus and Homs where there is a greater concentration of protection interventions as a percentage of the whole. The graph should NOT be read to mean that one or another Governorate is over-served or under-served. It is a reflection of coherence between the spread of protection interventions and the total PiN. 

RESPONSE TO HARD-TO-REACH AREA (as per Sep 2017 Besieged and HTR list)

Out of 1,167 Hard-to-Reach ("HTR") locations with 2.98M people in need, 223 have been reached in 2017 with **573,700** protection interventions, of which **85,800** in **100** locations were done in November. The graph below shows the proportion of interventions conducted in HTR areas in each governorate vs proportion of people in need in the governorate in HTR areas.


Graph comparing percentage of protection interventions conducted in HTR areas in a Governorate to percentage of people in need (PiN) in the HTR areas in that Governorate




PEOPLE REACHED WITH A MINIMUM OF ONE INTERVENTION

During November 2017,at least **316,600 people received a minimum of one protection intervention**, bringing the total for 2017 to **2,253,400**. More than a **quarter** of those reached in November are in Aleppo Governorate and **73%** of those reached in the year are in four Governorates (Damascus, Aleppo, Rural Damascus and Homs).

The number of persons reached with at least one intervention per month is calculated based on the number of people benefitting from the activity with the widest reach per community (or neighbourhood where applicable). It is certain to under-report the total number of persons receiving protection interventions in a community.

RESPONSE ANALYSIS BY FREQUENCY OF REACH

The overwhelming majority of protection interventions in the Syria response require sustained presence and access. It is often only with a direct link to a community that qualitative interventions such as those provided by the sector can be implemented and have lasting impact. In light of the importance of sustained presence, the analysis in this page looks at the frequency of reach (a measure of presence) at sub-district level. Map 1 shows monthly frequency of reach in 2017, i.e. the number of months that each sub-district has been reached with activities reported in the current year. The graph below details the same information, visualising the number of sub-districts in each governorate, reached for 0 to 11 months in 2017.


Map 2 and Map 3 analyse frequency of reach in the last three quarters, from March to November 2017. The quarters are divided as Q1 (March - May), Q2 (June - August) and Q3 (September - November). Map 2 looks at the quarter in which the sub-district was last reached. Map 3 visualises the frequency of reach, looking at whether the sub-district was reached in a single or multiple quarters, and identifying areas missing protection assistance for long periods.




No. of months (frequency) of reach in 2017 by sub-district - comparison by Governorate


