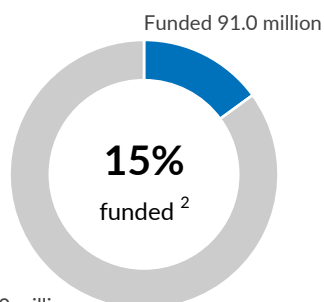

Notes:

1. The financial requirements for Central Africa and Great Lakes are for the operations in Burundi, Cameroon, Central African Republic, Dem. Rep of the Congo, Reg Off, Gabon, Rwanda, The Republic of the Congo and United Republic of Tanzania.

2. The percentage funded is calculated using earmarked contributions pending the eventual allocation of broadly earmarked and unearmarked contributions.
3. Contributions are shown by the level of flexibility in the earmarking. Contributions earmarked to a situation within a country are classified as country level.
4. The broadly earmarked contributions listed are those which can potentially be used for Central Africa and Great Lakes due to their earmarking to a related situation or theme, or to the region. The total amount of the contributions is shown for donors who have contributed \$2 million and more.
5. The total amount of unearmarked contributions is shown for donors who have contributed \$10 million and more.
