# **AT A GLANCE**

# **OVERVIEW**

The 2018 Burundi Regional RRP articulates the protection and humanitarian needs of an anticipated 434,000 Burundian refugees by the end of 2018. The RRP outlines the inter-agency response strategy and financial requirements of 27 partners responding across four countries of asylum. The Burundian refugee population in the region is expected to grow by 56,000 in 2018. At the same time, partners are planning to assist the voluntary and informed repatriation of some 60,000 refugees to return to Burundi. UNHCR and response partners facilitate voluntary repatriation in accordance with existing tripartite agreements but they have not yet begun a promotion phase. For all Burundian refugees who express their wish, UNHCR and partners are prepared to assist them to return to Burundi providing that they indicate to have made a free and informed decision to return voluntarily. As the crisis enters its fourth year, the main focus of the response will be to ensure access to asylum for those still leaving Burundi while supporting host countries to continue to provide protection and humanitarian assistance to refugees, prioritizing livelihoods and self-reliance in a whole of society approach that promotes socio-economic inclusion in host communities and national systems.





#### **2018 STRATEGIC OBJECTIVES**

Country level objectives and activities in the Democratic Republic of the Congo, Rwanda, Tanzania and Uganda support the following overarching regional objectives:

- 1. Preserve equal and unhindered access to territorial asylum and protection, promote the full enjoyment of rights, and maintain the civilian character of asylum.
- Achieve minimum standards in the provision of multi-sector assistance and protection with a view to anchor the response in government systems, protection policies, and development plans, with integrated services wherever possible.
- 3. Ensure **peaceful co-existence and social cohesion** between host communities and refugees, including through protection of the natural environment.
- 4. Foster **economic self-reliance** for refugees and host communities, reducing dependency on aid and promoting socio-economic growth in line with national development plans.
- 5. Ensure refugees have access to **durable solutions** where available.

# **REGIONAL COORDINATION**

The 2018 RRP brings together 27 partners across the four countries of asylum. The United Nations High Commissioner for Refugees appointed Catherine Wiesner as the Regional Refugee Coordinator (RRC) for the Burundi situation to work with UNHCR Representatives in Burundi, Tanzania, Rwanda, Uganda, and the DRC to ensure an overarching vision and coherent inter-agency engagement across the region. In so doing the RRC works at the regional level to facilitate strategic, planning, and operational synergies and collaboration with Governmental, UN system, Governmental Organizations, donors, civil society partners, private sector, and other stakeholders. At the country level, the Refugee Coordination Model remains the main tool to coordinate the refugee response.
