**Vulnerabilities of children and caregivers reduced and their resilience strengthened**

**Indicator 1: # of boys and girls benefiting from psychosocial support**

**Definition:** # of girls and boys benefitting from psychosocial support, defined as: promoting well-being and establishing normalcy through the following: recreational activities (indoor and outdoor play, sport, dance, art, theatre, music, puppets, cultural events, story-telling; learning activities, including lifeskills, literacy and numeracy, vocational training, awareness raising sessions, conflict resolution skills; information and orientation sessions: orientation sessions on different topics related to their well-being such as registration, distribution, information on day to day needs (for basic services) within the family, key messages on GBV and child protection; emotional and social support activities: such as group therapy, group counselling sessions, home/family visits, Psychological First Aid. Child protection actor must interact directly with the child.

**Indicator 3: # of girls and boys at risk of harm or survivors of violence individually assisted with specialised services**

**Definition:** # of girls and boys at risk of harm (*all* risk levels: high, medium, low) individually assisted with specialised services (through case management). Reporting begins at the **start** of service provision. See case level definitions below or refer to the Practical Guidance for case management.

**Risk Level**

Female high - # of girls at high risk of harm individually assisted with specialised services  
Male high - # of boys at high risk of harm individually assisted with specialised services

Male - # of boys at risk of harm or survivors of violence individually assisted with specialised services

**Definition:** # of service providers undergoing technical, skills-oriented trainings in child protection in emergencies knowledge and services (ex. CPiE core training, CP MS training), including training on case management and referral pathways.
