Food Security Task force led by Ministry of Agriculture (MoA) shared an update regarding the formulation of the narrative component (sector response plan) and the project summery sheet of the food security sector.</li> </ul>	
	<ul> <li>The Food security Task force chair emphasized the importance of the Partners' commitment in reporting on JORISS. Projects not funded during 2017 were revised.</li> </ul>	
	<ul> <li>The proposed Project summery sheet for the food security sector includes four project under refugee pillar (REF) and eight project under resilience pillar (RES).</li> <li>Some RES project concerning agriculture were moved to livelihoods sector, the other were revised to reflect the resilience aspect for the Food Security sector.</li> </ul>	
	<ul> <li>The project summery sheet will be shared with the food security partners.</li> <li>Partners who were not part of the consultation process during the JRP workshop are encouraged to share their input with the Food Security task force by Monday 2<sup>nd</sup> of Oct COB.</li> </ul>
