A SUPPLEMENTARY AGREEMENT made between the GOVERNMENT OF THE
REPUBLIC OF HUNGARY (hereinafter referred to as "the
Government") of the one part and the UNITED NATIONS HIGH
COMMISSIONER FOR REFUGEES (hereinafter referred to as "the High
Commissioner") of the other part;

WHEREAS the Parties hereto entered into an Agreement signed
in Geneva on the 4 October 1989 (hereinafter referred to as "the
Original Agreement") concerning local settlement of refugees in
the Republic of Hungary;

WHEREAS it is deemed necessary to extend the project until
31 March 1990;

IT IS HEREBY AGREED between the parties hereto as follows:


1. The project governed by this Agreement shall be deemed to
have commenced on 1 June 1989 and shall terminate on 31
March 1990.
2. The period mentioned in the budget attached as Annex B to
the Original Agreement is hereby amended to read:
1 June 1989 - 31 March 1990"
3. Except to the extent inconsistent herewith all provisions of
the Original Agreement shall remain in full force and effect.



Reference is made to the agreement signed on 4 October 1989 between UNHCR and the Government of the Republic of Hungary governing project 89/TF/HUN/LS/450 concerning local settlement of refugees in the Republic of Hungary. Further reference is made to cable HUN/HCR/0080 of 22 December 1989 from Branch Office Budapest requesting the transfer of the second instalment foreseen by the original Agreement.

2. The initial obligation of US\$ 1,000,000 is hereby increased by US\$ 2,000,000 to read: US\$ 3,000,000.
