The Chairperson of the Executive Committee will open the seventieth session on Monday, 7 October 2019 at 10 a.m. in the Assemble Hall at the Palais des Nations in Geneva.

The High Commissioner's statement will provide an overview of the operational and policy priorities of his Office.

Item 3 High-level segment on statelessness and general debate

The High-level segment to mark the midpoint of the #IBelong campaign to end statelessness by 2024 includes a panel discussion with the United Nations Deputy Secretary-General Amina Mohammed, High Commissioner for Human Rights Michelle Bachelet, High Commissioner for Refugees Filippo Grandi, High Commissioner on National Minorities of the Organization for Security and Co-operation in Europe Lamberto Zannier, UNHCR's Goodwill Ambassador Cate Blanchett and Ms. Maha Mamo, a stateless refugee who was given nationality by Brazil.

The general debate is articulated around issues related to statelessness and those raised in the statement of the High Commissioner. Delegations are encouraged to refer to what they are doing to end statelessness by 2024 in their statement, including new commitment and pledges. The Committee will have received an outline of the High Commissioner's statement in advance of the session. The Committee will also have before it brief updates on developments at the regional and global levels. The list of speakers for the general debate will be opened on 9 September 2019.
