### 1 METHODOLOGY

Provide qualitative information on the factors influencing return intentions of affected population staying in collective centers or sites not managed by Government institutions in the Island of New Providence.

#### **SPECIFIC OBJECTIVES:**

- Describe why they chose to stay at a non-government collective center.
- Identify factors influencing their return intentions.
- Understanding the families' main concerns from the perspective of the heads of households.

Semi-structured questionnaire
answered by heads of households,
and on-the-field observations.

# WHY STAY AT A NON-GOVERNMENT COLLECTIVE CENTER?

#### "We reached a shelter and our properties were stolen, they had a contact through their family and decided to move in"

Male, 33

"I trust my family more"

Male, 75

"We have small children"

Female 60

"We felt extremely unsafe in Nassau and this was the best option available"

# RETURN INTENTIONS

- Haitian ethnic background: Only one household reported wanting to remain at their current place (staying at the mother's house and needed materials to build an extra room).
- Bahamian ethnic background: Only one household reported wanting to go back. The remaining households expressed intentions to remain at the current location for at least the next 4 weeks.
- Difference between intentions and wants

FACTORS INFLUENCING

**INTENTIONS** 

The head of household found a job

I don't feel safe here

I want to start over I have nowhere else to go

I lost everything

There is nothing left for me there

I have no other choice at the moment

I go where my family goes



## MAIN CONCERNS AND NEEDS

- Job opportunities and stability for at least 2 months to recover mentally "If you can work, you would move."
- Rent (housing), Vehicle and Employment
- Documentation (regular/irregular)
- Psychosocial assistance

"I did not believe in those things before, but lately I am seeing the waves coming at me... I think I need psychosocial support" (Male, 33)



- Scarse food and clothing distribution for people outside official collective centers
- 1 respondent expressed concerns about a loan he acquired to build his house back in Abaco.

#### RECOMMENDATIONS

#### **HOUSING/SHELTER**

#### **Housing solutions in Nassau:**

 Deposit, rent, key money, fees, documentation, etc.

#### **Housing solutions in Abaco:**

- -Construction of houses
- -Provision of tools and materials for repairs/improvements by the family.
- -Land/tenure

#### **LIVELIHOODS**

Job/entrepreneurship
(Start-up capital, tools, etc.)
opportunities at their
communities of origin and/or
current location of residence
depending on the families'
context.

#### **DOCUMENTATION AND MIGRATION**

- -Lost/stolen documents
- -Basic identification/certification

Brother in the US, she would like to move there but is lacking documentation.

(Female, 23)

"If I don't make it in Nassau,
I want to go to Canada" However, he
had Bahamian passport, but his son
(4 years old) lost his documents during
the hurricane. (Male, 34)
