The Office of the United Nations High Commissioner for Refugees (UNHCR), established on 14 December 1950 by the General Assembly of the United Nations, requests that you submit a price offer for the provision of medical supplies for the 3 CPCSMCs:

Mariupol (Sartana) (Mariupol, Mariupol, Mariupol) Radina MV, Building 2), Volnovakha District Council (Volnovakha, Matrosov Lane, 5) and Maryina District Council (Marinka, 22A Friendship Ave.). The details of the assignment are set out in this RFP.

GOODS: Please provide the following information in your proposal:

- Currency: UAH (without VAT);
- Additional costs, if any;
- Certificates of quality and passports of goods .;
- Cost of delivery of the specified goods in accordance with Annex A to the specified place;
- Total cost of goods and services;
- Terms of service;
- Detailed specification of the offered goods.

The Bidder agrees that the price quotation provided is complete and allows the said works to be performed properly, taking into account consumables, garbage collection, etc. Otherwise, UNHCR will not reimburse such costs.

Please note that UNHCR is exempt from taxes and duties, so your offer should be submitted with clear non-VAT prices. (The procedure for issuing shipping documents for participants who are VAT payers is given in Annex D).

Tenderers are invited to request clarification on this RFQ by e-mail at mykheien@unhcr.org . The deadline for receipt of questions is 23:59. Eastern European Time 10/05/2020.

Please note that the e-mail rules set by UNHCR limit the size of applications to a maximum of [8] megabytes, so several messages may be required to send the entire document packet.

- Your company name;
- Number of messages sent (e.g. 1/2, 2/2)

Your bid must be valid for at least 30 days. UNHCR Standard Payment Terms - 30 days after satisfactory provision of goods or services and acceptance by UNHCR.
