The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950 by the United Nations General Assembly¹, intends to identify interested vendors in supply of non-food items and construction materials for implementation of UNHCR humanitarian programmes in the non-Governmentally controlled areas of Donetsk region.

This is an invitation to vendors or their legally entitled agents to <u>express interest</u> in supply of the above-mentioned goods. Vendors shall find herewith the necessary requirements for registration with UNHCR, the specification of goods required and qualification information.

UNHCR invites all interested vendors to carefully follow the instructions described below.

1. <u>REQUIREMENTS</u>

The Office of the United Nations High Commissioner for Refugees (UNHCR), Representation in Ukraine (referred to hereinafter as UNHCR), invites vendors or their legally entitled agents to supply non-food items and construction materials in the non-Governmentally controlled areas of Donetsk.

IMPORTANT:

Technical specifications of the requirements are detailed in Annex A of this document.

It is strongly recommended that this Expression of Interest document and its annexes be read thoroughly.

<u>Note</u>: this document and/or a submission of an expression of interest shall not be construed in any way as an offer to establish a contract.

2. QUALIFICATION PROCESS

Interested vendors should express interest by providing the below requested documentation.

- 1. Profile of the company
- 2. Statutory, enabling and certifying documents
- 3. Documentation procedures on tax reporting (for companies with VAT payer status)
- Detailed information on goods / goods catalogue (Technical specification form Annex A)
- 5. Previous experience with the UN (if any).

Receipt of your emailed bid submission will be acknowledged through an automated reply. Your automated reply must be dated before the deadline of 12 February 2021 23:59 HRS EET.
