Enhancing resettlement through private sponsorship programmes — an increased role for civil society in Switzerland?

#### **Background**

Resettlement and other legal pathways enable refugees to reach safety without having to embark on hazardous journeys. They are globally recognized as important tools for the resolution of large refugee crises. In the New York Declaration for Refugees and Migrants, which was adopted by the UN General Assembly in 2016, UN Member States expressed their intention "to expand the number and range of legal pathways available for refugees to be admitted or resettled in third countries".1

Switzerland has been engaged in resettlement since the 1950s and has since then successfully resettled and integrated many refugee groups. More recently, Switzerland has set up three consecutive programmes for the resettlement of refugees of the Syrian conflict. The latest of these three programmes will end in 2019.

Given the significant shortage in resettlement places available worldwide, a continuation, augmentation and institutionalisation of the Swiss resettlement programme would be key. While there seems to be interest in a continuation of the programme, concerns are voiced by some relating to the high costs and challenges of integration.

Civil society as well as interested local communities could play an important role through advocacy to get the necessary political consensus for a continuation of the resettlement programme. In addition, building on the longstanding experience they have in volunteer work, concrete and active support for overcoming the identified challenges of the existing programme could also be decisive for its continuation.

So-called private sponsorship programmes could provide a vehicle for offering for such support. These are civil society initiatives which commit private resources to complement government responsibilities in resettlement programmes. The area for which private resources are used can vary depending on the programme. All such initiatives are, however, in one way or the other engaged in the local integration of legally admitted refugees. Thus, they create positive dynamics at local level, improve integration outcomes and build relationships between refugees and the host communities.
