TECHNICAL SPECIFICATIONS AND TECHNICAL OFFER FORM

OBJECTIVE

UNHCR Brazil is interested in establishing Frame Agreement(s) with one or more qualified companies and manufacturers for the supply and delivery of hammocks.

The contracted company(s) must be authorized by the competent authorities and must normally supply such goods under Brazilian regulations with full technical, financial, managerial, and administrative autonomy.

The modality of contract resulting from this tender will be a Frame Agreement. This type of Contract does not require a financial commitment from UNHCR at the time of signing. Financial commitments will be established on a case-by-case basis, each time services are requested, through the issuance of purchase orders.

The award of a Contract does not confer upon the successful bidder any exclusivity with respect to the services provided (it is at the discretion of UNHCR and UNHCR specifically reserves the right to award more than one Frame Agreement for the provision of the services), nor does it grant the successful bidder any rights of a different or more extensive nature.

Sleeping/resting hammock with hammock articulators. Simple single model, cotton fabric, capacity to support 150 to 200 kilos. Several colors.	1, 500 units
Support ropes for hammocks (two per hammock). Each 1.50-meter-long. Material must be multifilament, braided, made of polypropylene. Various colors.	3,000 units
Hooks to support the hammock. Separate hooks in galvanized iron, size 3/8.	500 units
