

## Regulations for COVID-19

To enter Serbia it is obligatory to have one of these options:

1. A negative PCR test not older than 48 hours.
2. Persons who have been vaccinated in the Republic of Serbia and hold a valid certificate of vaccination and citizens of countries with which the Republic of Serbia has concluded an agreement on the mutual recognition of immunization certificates, who have been vaccinated in said country and hold a valid certificate issued by the competent state authority – Covid vaccine legitimation (states: Hungary, Turkey, UAE, Slovenia\*, Czech Republic). In both cases person must be **fully** vaccinated (vaccinated with two doses, or a single dose if vaccinated using the AstraZeneca COVID-19 vaccine and Johnson & Johnson's Janssen (J&J/Janssen) COVID-19 vaccine);
3. Beside a vaccination certificate, all tests for the presence of SARS-CoV-2 are recognized (negative PCR-test or HAGT, not older than 48 hours). Citizens of Republic of Slovenia that have been infected with Covid 19 virus within the last 180 days, as well as those who received the first dose of the vaccine against COVID-19 within a maximum of eight months after infection, are allowed to enter the Republic of Serbia provided they hold a certificate of recovery from COVID-19. Furthermore, minors of up to 15 years of age are allowed to enter the Republic of Serbia without quarantine or a negative PCR test if they are accompanied by a close family members who meet the criteria for entering the country without quarantine.

To maintain the safety and protection of all participants, the Organizing Committee asks all participants to follow this COVID-19 protocol.

All members of the delegation must follow the health regulations in accordance with instructions of the health authorities in the host country.

### **Mandatory:**

- Masks are to be worn in all interior spaces, in outdoor areas where distance cannot be provided as well as in all official vehicles.
- Masks can only be taken off while eating.
- Athletes are allowed to take off the mask while in shooting position.
- It is required to change a mask few times per day, even with reusable masks.
- Physical distancing guidelines must be followed at all times (both open and closed spaces).
- The delegation is obliged to have an adequate supply of masks, hand sanitizers and gloves.

- Only athletes who are on the schedule to be on the line, according to the program, as well as their coach and assistant are allowed in the shooting range during qualifications or training, along with the judges and technical staff of the Organizers.

- Upon display of any symptoms, members are obliged to seek medical attention then selfquarantine until obtaining a negative PCR.

- Teams are to register a responsible person to monitor compliance by members of the antiCOVID-19 protocol established by Organizer of competition.

The person who is chosen must inform the Organizers about suspicion of COVID-19 of their member as well as identify and inform the Organizers with whom the suspected member has been in contact with.

Appropriate measures for isolation are to be taken if any member displays symptoms.

Entrance to the 10m or 25/50m shooting range will be available only to those who are cometaing and their coach or assistant.

**Entrance to the shooting range will be available only to:**

**10m range:**

-athletes, their assistants and coaches

-assistants and coaches must wear masks all the time

-athletes can take off mask during match

**25/50m range:**

-atheletes, assistants and coaches

-assistants and coaches must wear musk all the time

-athletes can take off mask during match
