### DUTIES of refugees and beneficiaries of humanitarian protection in the Republic of Moldova

If you were granted refugee status or humanitarian protection in the Republic of Moldova you have the following duties:

To know and respect the Constitution and legislation of the Republic of Moldova;

To have a fair and civilized behaviour in society;

In case you are placed in the accommodation centre to respect the internal regulations;

To reimburse the amounts received as financial aid, if your incomes allow you to do so.

The refugees shall contact the Asylum and Integration Directorate in order to obtain a new identity card, upon the expiry of its validity, with at least 30 days prior to the expiration, and in case of loss or damage, within 3 days.

Beneficiaries of humanitarian protection shall contact immediately the Asylum and Integration Directorate in case of loss or damage of the humanitarian protection identity card.

# RIGHTS of refugees and beneficiaries of humanitarian protection in the Republic of Moldova

If you were granted refugee status or humanitarian protection in the Republic of Moldova you have the following rights:

- To be informed about your rights and duties in Republic of Moldova;
- To reside on the territory of the Republic of Moldova and obtain respective documents to confirm your identity and to allow border crossing. Beneficiaries of refugee status will be issued an identity document valid for five years and beneficiaries of humanitarian protection for a period of one year;
- To choose a place of residence;
- 4To be employed;
- To receive wages and benefit from social insurance;
- To be enrolled in compulsory general education under the same conditions as the citizens of the Republic of Moldova, as well as in other forms of education on the same conditions as foreigners and stateless persons;
- To benefit from health care;

- In case of unaccompanied minors or beneficiaries of humanitarian protection, to benefit from all types of social assistance provided to children who are citizens of the Republic of Moldova;
- To freely practice your religion and to provide your children with religious education;
- 10 benefit from the right of protection of your personal data;
- 1 To have unhindered access to courts and administrative assistance;
- 12Not to be returned or expelled;
- 1 To live in the accommodation centre for a certain period of time;
- 14To participate in programs of social integration, upon request;
- 150ther rights and duties granted to foreigners and stateless persons legally residing on the territory of the Republic of Moldova.

In the absence of necessary means of subsistence you have the right to financial aid.

The financial assistance shall be granted for a period of six months by submitting a request to the Asylum and Integration Directorate and by signing a commitment to reimburse the amount received subject to availability of incomes that allow you to do so.

The financial aid can be requested within two months from the date of granting the refugee status or humanitarian protection.

The request to participate in programs of social integration shall be submitted within 30 days from the date of granting a protection form.
