- Create conditions conducive to voluntary repatriation: including by supporting the Government

of Afghanistan in land distribution to returnees and investing in the human capital, resilience and portable skills of refugees in host countries.

 Channel additional investments into the national public service delivery systems in the Islamic Republics of Iran and Pakistan to support inclusive policies of the Governments benefitting both host communities and refugees.
