INTRODUCTION

The mine action needs assessment questions catalogue provides a comprehensive list of questions that mine action actors can use to assess needs. This catalogue is meant to complement the [mine action analysis framework](#), which maps out the different types of information that can help to plan and implement effective mine action interventions. Information is drawn from multiple mine action resources and synthesized for convenience.

Note on terminology: Although in documents we should systematically refer to 'explosive ordnance', every programme/sector should find the best term, clear and comprehensible to local communities and easily translatable without misinterpreting its sense. Training/awareness for enumerators to avoid biased/biasing interpretation should be considered, as well as producing a small booklet/poster/banner with few pictures/drawings to help them when asking the questions. In addition, when internally working on questions, any question leading interviewees to differentiate between different type of EO should be avoided, because potentially misleading. Finally, dry testing the questionnaire with a sample of interviewees prior to conducting the live survey seems to be a good practice, allowing MA drafters-enumerators-interviewees to determine a common understanding.
