

What is HLP?

Housing, Land and Property rights are about having:

...a home, free from the fear of forced eviction – a place that offers shelter, safety and the ability to secure a livelihood.





HLP rights: beyond 'ownership'




- HLP rights not just 'ownership'.
- They include other forms of rights
 - user rights (e.g. rights held by tenants, access to natural resources or for livelihoods)
 - easement rights (e.g. traditional passage through a piece of land or through neighbour's land).
- HLP rights can be held on an individual basis or collectively





But. Complexity...



HLP rights: beyond 'ownership'



• HLP rights can be documented (land title, lease agreement) or not.

The lack of documentation does not mean that the right does not exist.

- Important to understand that different people or groups can have rights to the same piece of land, including those who have been displaced.
- Overlapping land tenure systems and rights can be complex to understand.

Women's HLP Rights

- Women disproportionately affected by issues related to HLP, including in displacement.
- Often struggle to access their rights.
- Gap between law and practice.
- Addressing HLP rights promotes gender equality.
- Inheritance and marital property laws can protect women's rights.
- Land is one of the most significant assets for women.
- Economic survival and recovery often depends on access and control of land.
- Must not reinforce any existing gender discrimination as part of any response.





Mine action interventions do not take place in a political, legal, social or economic vacuum...

Mine Action interventions have the potential to:

- Exacerbate land conflicts or create new ones
- Contribute to land grabbing or forced evictions as value of land increases
- Maintain or entrench gender inequalities in access to land
- Undermine food security if population relies on land for subsistence





HLP and Mine Action

'Do No Harm'

- Contribute to positive protection outcomes through safe and inclusive programming
- E.g. Previously excluded persons or communities now able to access land as a result of a mine action intervention





Two key HLP concepts...

Security of Tenure

Due Diligence





What is Tenure Security?

- Tenure is the relationship among groups or individuals with respect to housing and land
- Tenure is the system of rules that governs Who, can do What, for How long on Which housing, land and property
- Common tenure arrangements include 'ownership', 'renting' and 'possession'
- Security of tenure: the right of all individuals to have guaranteed legal protection against forced eviction, harassment and other threats
- Particular focus on Women's Tenure Security and HLP







What is Due Diligence?

Definition of due diligence

 A process of research and analysis in any given situation to avoid harm to other persons or property

- Why? Verify property rights, reduce/avoid disputes. Durable solutions. Do No Harm and safer programming
- When? At all stages of intervention
- How? Specific to each intervention, each context.





Due Diligence - How?

For Example...

- ☐ Find out who has rights in the land;
- ☐ Check existing property records at land registry or equivalent
- □ Consult local authorities.
- ☐ Walk around the boundaries of the property and across it to see if there are signs of contested claims.
- ☐ Ask neighbours about the property and its owner.
- □Consult local elders about the history of the property.
- ☐ Identify and mitigate potential disputes














HLP and the SPHERE standard

The affected population has security of tenure in its shelter and settlement options...

KEY ACTIONS

- 1. Undertake due diligence in programme design and implementation
- 2. Understand the legal framework and the reality on the ground
- 3. Understand how tenure systems, arrangements and practices affect security of tenure for at-risk groups
- 4. Implement shelter and settlement programmes to support security of tenure
- 5. Support protection from forced eviction




HLP and Mine Action - HOW?

COLLABORATION!


- Ensure awareness about the relationship between HLP rights and mine action
