## **Answer**

# **Preliminary note**

Seven out of 12 responding EU+ countries indicated they do not conduct research in countries of origin with the aid of trusted third parties.

Five answering EU+ countries do conduct research with the aid of trusted third parties and those mentioned:

#### BE

Until recently BE worked with lawyers of trust to check judicial documents in Iran, Pakistan and Turkey. For security reasons their identity was not mentioned in the information, only a description and a small C.V. This collaboration had to stop due to a ruling of our supreme court that states that full coordinates have to be provided: name, email, phone etc.

## DE

DE conducts research in case of individual claims in countries of origin via their diplomatic representations/embassies in various countries of origin. In some cases, local embassy staff is responsible for conducting research on the spot, mainly in the capitals of the respective countries; in most cases however, the research is conducted with the aid of trusted third parties such as lawyers, doctors/medical practitioners, pharmacists or international, regional or local organizations. In some cases lawyers, doctors and other trusted persons of German origin who are employed by the embassies conduct the research, sometimes not only in the country of origin where the embassy is located but also in neighboring countries.

The trusted third parties are contracted in different ways, they are paid on a fee basis, prices differ depending on the topic and effort, for legal requests in average 250,-€ have to be paid, for medical research approximately 150,-€, in some cases higher fees have to be paid.

Additionally the BAMF works with liaison staff in specific countries of origin. Based on an agreement between the Federal Ministry of Interior and the Ministry of Foreign Affairs to speed up asylum procedures as well as to support the Federal Office's migration research, voluntary return and integration civil servants from the BAMF are working at diplomatic representations and embassies, currently they work in the following countries: Albania (Tirana), Iran (Teheran), Kosovo (Pristina), the Russian Federation (Moscow) and Turkey (Ankara). The liaison officers are responsible for conducting research in cases of specific requests submitted by case workers via the unit responsible for the liaison staff. They also contact trusted third parties working for the embassies in the respective countries of origin.

## DK

DK uses lawyers approved by Danish embassies in their asylum determination process, but only to verify the authenticity of documents, i.e. arrest warrants, verdicts etc.

#### FI

The Finnish Immigration Service can conduct research in the countries of origin if Finnish Embassy exist there. FI Embassies use trusted third parties/lawyers to do the research.

## LU

LU has a liaison officer in Kosovo, the only third country where the asylum unit asks for research in the context of a request for international protection.
