ORDER OF THE MINISTER OF INTERNAL AFFAIRS OF THE REPUBLIC OF KAZAKHSTAN

of April 7, 2015 No. 315

About approval of standards of the state services "Registration and Issue of Permission to Foreigners and Stateless Persons for Permanent Residence in the Republic of Kazakhstan", "Certification to Stateless Persons and Residence Permits to the Foreigners Who Are Constantly Living in the Republic of Kazakhstan", "Registration of Acceptance and Getting Out of Nationality of the Republic of Kazakhstan", "Assignment and Prolongation of the Status of the Refugee in the Republic of Kazakhstan"

(amended as of 27-12-2018)

According to <u>Item 1</u>) <u>article 10</u> of the Law of the Republic of Kazakhstan of April 15, 2013 "About the state services" PRIKAZYVAYU:

- 1. Approve:
- 1) the standard of the state service "Issue of Permission to Foreigners and Stateless Persons to Permanent Residence in the Republic of Kazakhstan", according to appendix 1 to this order;
- 2) the standard of the state service "Certification to Stateless Persons and Residence Permits to the Foreigners Who Are Constantly Living in the Republic of Kazakhstan", according to appendix 2 to this order;
- 3) the standard of the state service "Registration of Acceptance, Recovery and Getting Out of Nationality of the Republic of Kazakhstan", according to appendix 3 to this order;
- 4) the standard of the state service "Assignment and Prolongation of the Status of the Refugee in the Republic of Kazakhstan", according to appendix 4 to this order.
- 2. (Sainov S. S.) to provide to department of migratory police of the Ministry of Internal Affairs of the Republic of Kazakhstan:
 - 1) state registration of this order in the Ministry of Justice of the Republic of Kazakhstan;
- 2) within ten calendar days after state registration of this order its direction on official publication in periodic printing editions and information system of law of Ad let;
- 3) publication of this order on official Internet resource of the Ministry of Internal Affairs of the Republic of Kazakhstan.
- 3. To impose control of execution of this order on the deputy minister of internal affairs of the Republic of Kazakhstan Turgumbayev E. Z. and Department of migratory police of the Ministry of Internal Affairs of the Republic of Kazakhstan (Sainov S. S.).

Standard of the state service "Issue of Permission to Foreigners and Stateless Persons to Permanent Residence in the Republic of Kazakhstan"

Chapter 1. General provisions

- 1. The state service "Issue of Permission to Foreigners and Stateless Persons to Permanent Residence in the Republic of Kazakhstan" (further the state service).
- 2. The standard of the state service is developed by the Ministry of Internal Affairs of the Republic of Kazakhstan (further the Ministry).
 - 3. The state service appears territorial subdivisions of the Ministry (further the service provider).

Reception of an application and issue of result of rendering the state service is performed through the service provider.

Chapter 2. Procedure for rendering the state service

- 4. Terms of rendering the state service:
- 1) from the moment of delivery of packet of necessary documents to the service provider 60 (sixty) calendar days;
 - 2) the most allowed time of expectation for delivery of documents 30 (thirty) minutes;
 - 3) the most allowed time of servicing 30 (thirty) minutes.
 - 5. Form of rendering the state service: paper.
- 6. Result of rendering the state service issue of permission to permanent residence in the Republic of Kazakhstan (further permission) in form, according to $\underline{appendix}\ 1$ to this standard of the state service or the motivated answer about refusal in rendering the state service in cases and on the bases, stipulated in Item 10 these standards of the state service.

Form of provision of result of rendering the state service: paper.

7. The state service is rendered on paid basis to the foreigners and stateless persons which are temporarily staying in the Republic of Kazakhstan with the visa on permanent residence or arrived from the states which signed agreements on visa-free procedure for entrance and stay with the Republic of Kazakhstan and also to ethnic Kazakhs irrespective of category of the visa issued by it. Foreigners and stateless persons listed in article 7 of the Law of the Republic of Kazakhstan "About population shift" cannot address for receipt of the state service.

Payment of the state fee is performed in cash or non-cash form through the banks of the second level or the organization performing separate types of banking activities which issue the document (receipt) confirming the size and payment date.

8. The working schedule of the service provider - Monday through Friday inclusive, from 09:00 till 18:30 o'clock about lunch break from 13:00 till 14:30 o'clock, except days off and holidays, according to the labor law of the Republic of Kazakhstan.

Reception of an application and issue of result of rendering the state service is performed from 9:00 to 17:30 o'clock with lunch break from 13:00 till 14:30 o'clock.

- 9. For receipt of the state service, the uslugopoluchatel provides in law-enforcement bodies in the place of stay, the following documents:
- 1) the statement questionnaire for issue of permission to permanent residence in the Republic of Kazakhstan in form, according to appendix 2 to this standard of the state services.
- 2) the copy and the original (for reconciliation) the national passport, the document of the stateless person of uslugopoluchatel, effective period, which on the date of filing of application over 180 calendar days;

the copy and the original (for reconciliation) the certificate of birth or other identity document of the child of not reached sixteen-year age, in case of the joint appeal;

- 3) written consent of the state of his nationality, in quality which the departure leaf can serve or other document confirming the exit visa on permanent residence abroad (except for foreigners and persons without citizenship who are recognized as refugees or who are granted shelter in the Republic of Kazakhstan and ethnic Kazakhs from People's Republic of China if other are not provided by international treaties);
 - 4) the autobiography on state or Russian, with the signature of petitioning;
- 5) the document on confirmation of the solvency according to Rules of confirmation by the foreigners and stateless persons applying for receipt of permissions to permanent residence in the Republic of Kazakhstan, the solvency during stay in the Republic of Kazakhstan approved by the order of the Government of the Republic of Kazakhstan of November 26, 2003 No. 1185, except for of the ethnic Kazakhs, the former compatriots who were born or which was earlier consisting in nationality of the Kazakh Soviet Socialist Republic or the Republic of Kazakhstan, and also persons having the right to acquisition of nationality of the Republic of Kazakhstan in the simplified procedure based on international treaties of the Republic of Kazakhstan and members of their families;
- 6) the document on criminal record (lack of criminal record) in the state of civil accessory and or permanent residence, issued by competent authority of the relevant state (except for ethnic Kazakhs of citizens of People's Republic of China if other is not provided by international treaties);
- 7) notarially certified consent of the child aged from 14 up to 18 years on permanent residence in the Republic of Kazakhstan;
- 8) the notarized agreement or notarized consent with physical person or legal entity on provision to the applicant of the dwelling on accommodation and statement on permanent registration accounting;
- 9) the certificate of medical examination of the foreigner of absence of diseases which availability forbids entrance to foreigners and stateless persons to the Republic of Kazakhstan according to the order of the Minister of Health of the Republic of Kazakhstan of September 30, 2011 No. 664 "About approval of the list of diseases which availability forbids entrance to foreigners and stateless persons to the Republic of Kazakhstan" (No. registered in the Register of state registration of regulatory legal acts 7274);
 - 10) one photo of 35x45 mm in size;
- 11) the certificate of absence or the termination of nationality of other state, issued by competent authority of the relevant state (in case of the address of the stateless person of not having certificate of the stateless person).

Effective period of the documents specified in subitems 5), 6), 9) of this Item no more than 180 calendar days.

The documents constituted in foreign language are subject to the translation on state or Russian. Authenticity signatures of the translator are notarially witnessed.

Uslugopoluchatel, to eighteen-year age, arrived to the territory of the Republic of Kazakhstan separately from parents or if both parents are citizens of the Republic of Kazakhstan, submits the documents specified in subitems 1) 2), 7) - 10) this Item.

Uslugopoluchatel having permanent registration for the territories of the Republic of Kazakhstan, who drew up getting out of nationality of the Republic of Kazakhstan or lost nationality of the Republic of Kazakhstan represents, the documents specified in subitems 1) 2), 4), 9), 10) this Item.

Uslugopoluchatel living in the territory of the Republic of Kazakhstan the having passports of sample of 1974 or living without identity documents which belonging to nationality of the Republic of Kazakhstan, or to

nationality of any state is not established by law-enforcement bodies in addition submit the document confirming accommodation or registration for the territories of the Republic of Kazakhstan.

For identification of persons, law-enforcement bodies of the Republic of Kazakhstan at the place of residence constitute the protocol of poll in which are reflected when and where checked were born, nationality of parents at the time of their birth when and according to what documents arrived to the Republic of Kazakhstan which of relatives and where lived or lives now, their nationality and other questions depending on circumstances and so on.

After adoption of documents the coupon about adoption of documents for issue of permission to permanent residence in form, according to appendix 3 to this standard of the state service with indication of date of issue is issued to uslugopoluchatel.

- 10. The bases for refusal in rendering the state service <u>are stipulated in Article 19-1</u> Law of the Republic of Kazakhstan "About the State Services", and also:
- 1) illegally arrived, and also pursued for making of crimes by the legislation of the countries, natives of which they are;
- 2) exempted from places of detention which permanent residence before condemnation was outside the Republic of Kazakhstan;
 - 3) committed crimes against humanity;
- 4) not provided confirmation of the solvency according to Rules of confirmation by the foreigners and stateless persons applying for receipt of permissions to permanent residence in the Republic of Kazakhstan, the solvency during stay in the Republic of Kazakhstan approved by the order of the Government of the Republic of Kazakhstan of November 26, 2003 No. 1185, except for of the ethnic Kazakhs, the former compatriots who were born or which was earlier consisting in nationality of the Kazakh Soviet Socialist Republic or the Republic of Kazakhstan, and also persons having the right to acquisition of nationality of the Republic of Kazakhstan in the simplified procedure based on international treaties of the Republic of Kazakhstan and members of their families;
 - 5) repeatedly violating the law on legal status of foreigners in the Republic of Kazakhstan;
 - 6) kindling international and religious strife;
 - 7) actions of which are directed to violent change of the constitutional system;
- 8) opposing sovereignty and independence of the Republic of Kazakhstan, calling for violation of unity and integrity of its territory;
 - 9) having not removed or unspent conviction for crime;
- 10) in the presence of data at bodies of homeland security on their involvement in extremism or terrorist activities;
- 11) submitted false documents or reported about himself obviously false data in case of the address with the petition for permission to permanent residence in the Republic of Kazakhstan or without reasonable excuse not submitted necessary documents within the terms established by the legislation of the Republic of Kazakhstan;
- 12) expelled within five years the Republic of Kazakhstan by the time of issue of permission to permanent residence in the Republic of Kazakhstan;
- 13) if it is necessary for protection of the rights and legitimate interests of citizens of the Republic of Kazakhstan and other persons;
- 14) got permission to permanent residence and living in the territory of the Republic of Kazakhstan less than hundred eighty three calendar days within any consecutive twelve-monthly period from date of issue of permission to permanent residence;
- 15) got married with citizens of the Republic of Kazakhstan, formed the basis for receipt of the residence permit if this scrap is nullified by the judgment which took legal effect;
 - 16) having diseases which are contraindication for entry into the Republic of Kazakhstan.
- 17) brought to the administrative responsibility for offense in the field of population shift, the taxation and the labor law of the Republic of Kazakhstan;

- 18) to the interests of homeland security creating threat;
- 19) owing to participation of person in foreign armed conflicts, extremist and (or) terrorist activities in the territory of foreign state.

Chapter 3. Procedure for appeal of decisions, actions (failure to act) of the service provider (or) his officials concerning rendering the state service

11. Appeal of decisions, actions (bezdeystviye) of the Ministry, the service provider and (or) his officials, concerning rendering the state services: the claim is submitted addressed to the head of the service provider to the address specified in Item 15 of this standard of the state service or addressed to the head of the Ministry of the address: 010000, city of Astana, Prospekt Tauyelsizdik, 1.

The claim is submitted in writing by mail or purposely through office of the service provider or the Ministry.

Confirmation of adoption of the claim is its registration (stamp, the entering number and date) in office of the service provider, or the Ministry, with indication of surname and initials of person which accepted the claim, term and the place of receipt of the answer to the made complaint.

In the claim of uslugopoluchatel its surname, name, middle name (are entered in case of its availability), the postal address. The claim is signed by uslugopoluchatel.

The claim of uslugopoluchatel which arrived to the service provider, the Ministry is subject to consideration within five working days from the date of its registration. The motivated answer about results of consideration of the claim goes to uslugopoluchatel by mail or is issued purposely to office of the service provider or the Ministry.

In case of disagreement with results of the rendered state service the uslugopoluchatel can address with the claim to authorized body by assessment and control of quality of rendering the state services.

The claim of uslugopoluchatel which arrived to authorized body by assessment and control of quality of rendering the state services is subject to consideration within fifteen working days from the date of its registration.

12. In disagreement cases with results of the rendered state service, the uslugopoluchatel has the right to take a legal action in established by the legislation.

Chapter 4. Other requirements taking into account features of rendering the state service

- 13. Addresses of places of rendering the state service are placed on Internet resource of the Ministry: mvd.gov.kz in the Section "About Activities of Law-enforcement Bodies".
- 14. Uslugopoluchatel has possibility of receipt of information on procedure and the status of rendering the state service in the mode of remote access by means of single contact center concerning rendering the state services "1414".
- 15. Contact telephone numbers of service desks concerning rendering the state service are specified on Internet resource: mvd.qov.kz.

Chapter 1. General provisions

- 1. The state service "Certification to Stateless Persons and Residence Permits to the Foreigners Who Are Constantly Living in the Republic of Kazakhstan" (further the state service).
- 2. The standard of the state service is developed by the Ministry of Internal Affairs of the Republic of Kazakhstan (further the Ministry).
 - 3. The state service appears territorial subdivisions of the Ministry (further the service provider).

Reception of an application is performed, through:

- 1) service provider;
- 2) the service provider in non-commercial joint-stock company "The Government for Citizens state corporation (further the State corporation);

Issue of ready documents is performed:

- 1) service provider;
- 2) through the State corporation.

Chapter 2. Procedure for rendering the state service

- 4. Terms of rendering the state service:
- 1) from the moment of delivery of packet of necessary documents no later than 17 (seventeen) working days;
 - 2) the most allowed time of expectation for delivery of document package uslugopoluchatel:

the service provider has 30 (thirty) minutes;

in the State corporation - 15 (fifteen) minutes;

3) the most allowed time of servicing of uslugopoluchatel:

the service provider - 30 (thirty) minutes;

in the State corporation - 15 (fifteen) minutes.

In case of the appeal to the State corporation day of acceptance does not enter rendering the state service in time.

- 5. Form of rendering the state service: paper.
- 6. Result of rendering the state service certification of the stateless person or the residence permit of the foreigner in the Republic of Kazakhstan on paper through the service provider in case of the personal address of uslugopoluchatel or his legal representative or to the confided person under the notarized power of attorney or the motivated answer about refusal in rendering the state service in cases and on the bases, the stipulated in Item 9-1 this standard of the state service.
- 7. The state service is rendered on paid basis to physical persons: to foreigners and stateless persons (further uslugopoluchatel).

When rendering the state service the state fee which according to article 615 of the Code of the Republic of Kazakhstan "About taxes and other obligatory payments in the budget" constitutes (Tax code) is collected:

in case of execution of the certificate of the stateless person - 8 MRP, established on the date of payment of the state fee:

in case of execution of the residence permit of the foreigner in the Republic of Kazakhstan - 0,2 MRP established on the date of payment of the state fee.

In the State corporation payment can be performed through payment gateway of "the electronic government" (further - PShEP) or through banks of the second level payment of the state fee is performed in cash or non-cash form or the organization, the performing separate types of banking activities which issue the document (receipt) confirming the size and payment date.

- 8. Working schedule:
- 1) the service provider Monday through Friday inclusive, from 9-00 till 18-30 o'clock with lunch break from 13-00 till 14-30 o'clock, on Saturday from 9-00 till 13-00 o'clock, day off Sunday and holidays, according to the labor law of the Republic of Kazakhstan.

Reception of an application and issue of result of rendering the state service is performed from 9:00 to 17:30 o'clock.

2) the State corporation - Monday through Saturday inclusive, according to the established working schedule from 9-00 till 20-00 o'clock without interruption for lunch, except for days off and holidays, according to the labor law of the Republic of Kazakhstan.

Acceptance is performed in place of registration of uslugopoluchatel according to the procedure of "electronic" queue, without the accelerated servicing, possibly booking of electronic queue by means of the portal.

9. The list of the documents necessary for rendering the state service in case of the address of uslugopoluchatel to the service provider, and also in the State corporation:

for execution of the residence permit of the foreigner in the Republic of Kazakhstan:

- 1) valid national passport;
- 2) the receipt on payment of the state fee (except for payments through PShEP);
- 3) of two photos in size 3,4,5 see (on paper);

for execution of the certificate of the stateless person:

1) the receipt on payment of the state fee (except for payments through PShEP);

- 2) of three photos in size 3, 5kh 4,5 see;
- 3) one of the following documents:

the foreign passport with the expired effective period;

certificate of the stateless person;

passport of sample of 1974 (former Union of Soviet Socialist Republics);

military ID;

the certificate of release from places of detention;

the certificate of getting out of nationality of the Republic of Kazakhstan and change of nationality according to the Presidential decree of the Republic of Kazakhstan, and also change of nationality according to the international treaties ratified by the Republic of Kazakhstan;

the certificate of birth (in case of registration to persons up to sixteen years);

the certificate on the return granted by foreign institutions of the Republic of Kazakhstan (when losing the certificate of the stateless person temporarily being located abroad).

When rendering the state service by means of information system "The registration Item "Documentation of Registration of Foreigners and Stateless Persons" photography of uslugopoluchatel is made by the service provider according to requirements of international standards and without payment. The facsimile of uslugopoluchatel is entered into the electronic form by photography, the signature of uslugopoluchatel - via the signature scanner.

After adoption of documents the coupon of registration of the request in form, according to $\underline{appendix 1}$ to this standard of the state service with indication of date of issue is issued to uslugopoluchatel.

When rendering the state service the uslugopoluchatel represents written consent in form, according to appendix 2 to this standard of the state service on use of the data which are the secret protected by the law, containing in information systems if others are not provided by the laws of the Republic of Kazakhstan.

In the State corporation issue of ready documents is performed by employees of the State corporation based on the receipt on acceptance of the relevant documents, in case of presentation of the identity certificate (or his representative under the notarized power of attorney).

If the uslugopoluchatel did not address for result of the state service, the State corporation provides storage within one year of date of production then transfers them to the service provider for destruction.

- 9-1. Service providers refuse rendering the state services in the following bases:
- 1) establishment of unauthenticity of the documents submitted by uslugopoluchatel for receipt of the state service, and (or) these (data) containing in them;
- 2) discrepancy of the provided materials necessary for rendering the state service, according to the list stipulated in Item 9 these standards of the state service.

Chapter 3. Procedure for appeal of decisions, actions (failure to act) of the service provider (or) his officials concerning rendering the state service

- 10. Appeal of decisions, actions (bezdeystviye) of the Ministry, the service provider and (or) his officials, concerning rendering the state services, the claim is submitted addressed to the head of the service provider to the address specified in Item 13 of this standard of the state service or addressed to the head of the Ministry of the address: 010000, city of Astana, Prospekt Tauyelsizdik, 1.
- 11. The claim is submitted in writing by mail or purposely through office of the service provider or the Ministry.

Confirmation of adoption of the claim is its registration (stamp, the entering number and date) in office of the service provider, or the Ministry, with indication of surname and initials of person which accepted the claim, term and the place of receipt of the answer to the made complaint.

In the claim of uslugopoluchatel its surname, name, middle name (are entered in case of its availability), the postal address. The appeal is signed by uslugopoluchatel.

The claim of uslugopoluchatel which arrived to the service provider, the Ministry is subject to consideration within five working days from the date of its registration. The motivated answer about results of consideration of the claim goes to uslugopoluchatel by mail or is issued purposely to office of the service provider or the Ministry.

In case of disagreement with results of the rendered state service the uslugopoluchatel can address with the claim to authorized body by assessment and control of quality of rendering the state services.

The claim of uslugopoluchatel which arrived to authorized body by assessment and control of quality of rendering the state services is subject to consideration within fifteen working days from the date of its registration.

The claim to actions (failure to act) of the employee of the State corporation goes to the head of the center for the address specified in Item 14 of this standard of the state service.

Confirmation of adoption of the claim in the center which arrived as if on purpose, and by mail, its registration is (stamp, the entering number and registration date are put down on the second copy of the claim or the cover letter to the claim).

12. In disagreement cases with results of the rendered state service, the uslugopoluchatel has the right to take a legal action in the procedure established by the legislation.

Standard of the state service "Registration of Acceptance, Recovery and Getting Out of Nationality of the Republic of Kazakhstan"

Chapter 1. General provisions

- 1. The state service "Registration of Acceptance, Recovery and Getting Out of Nationality of the Republic of Kazakhstan" (further the state service.).
- 2. The standard of the state service (further the Standard) is developed by the Ministry of Internal Affairs of the Republic of Kazakhstan (further the Ministry).
 - 3. The state service is territorial to divisions of the Ministry (further the service provider).

Reception of an application and issue of result of rendering the state service is performed through the service provider.

Chapter 2. Procedure for rendering the state service

- 4. Terms of rendering the state service:
- 1) from the moment of delivery of packet of necessary documents 6 (six) months, in the simplified procedure 3 (three) months;
 - 2) the most allowed time of expectation for delivery of documents 30 (thirty) minutes;
 - 3) the most allowed time of servicing 30 (thirty) minutes.
 - 5. Form of rendering the state service: paper.
 - 6. Are result of rendering the state service:
- 1) issue of the certificate of acceptance, recovery in nationality of the Republic of Kazakhstan in form according to appendix 1 to this standard of the state service;
- 2) issue of the certificate of getting out of nationality of the Republic of Kazakhstan in form according to appendix 2 to this standard of the state service;
- 3) refusal in rendering the state service in form according to appendix 3 to this standard of the state service in cases and on the bases, stipulated in Item 10 these standards of the state service.
 - 7. The state service is rendered on paid basis to physical persons (further uslugopoluchatel).

When rendering the state service the state fee according to article 499 of the Code of the Republic of Kazakhstan "About taxes and other obligatory payments in the budget" is collected (Tax code) which constitutes 100 percent from the size of the monthly settlement indicator established on the date of payment of the state fee.

Payment of the state fee is performed in cash or non-cash form through the banks of the second level or the organization performing separate types of banking activities which issue the document (receipt) confirming the size and payment date.

8. Working schedule of the service provider: Monday through Friday inclusive, from 09:00 till 18:30 o'clock, lunch break from 13:00 till 14:30 o'clock, except days off and holidays, according to the labor law of the Republic of Kazakhstan.

Reception of an application and issue of result of rendering the state service is performed from 9:00 to 17:30 o'clock with lunch break from 13:00 to 14:30 o'clock.

The state service is rendered in turn, without making an appointment and the accelerated servicing.

For acquisition of nationality of the Republic of Kazakhstan in the simplified procedure and the terminations of nationality of other Party address with the petition (statement) addressed to the chief of DP of areas and at the same time the official of the state of the arrival making decisions concerning nationality with notariallycertified written refusal of foreign citizenship.

The following documents join the petition (statement):

the questionnaire statement in form according to appendix 4 to this standard of the state service;

autobiography (any to form);

notarially certified declaration of abandonment of former nationality;

3,5 x 4,5 of cm four photos in size;

the obligation about observance of conditions, the stipulated in Article 1 Law in form according to appendix $\underline{5}$ to this standard of the state service;

the copy of the identity document and the Agreement confirming belonging to nationality of one of member countries;

notarized copy of the certificate of birth and scrap;

document on payment of the state fee or release from its payment.

If necessary the document confirming availability of one of the conditions necessary for acceptance of nationality in the simplified procedure is in addition submitted. notarially certified declaration of abandonment of former nationality;

the questionnaire statement in form according to appendix 4 to this standard of the state service;

3,5 x 4,5 four photos in size see;

the obligation about observance of conditions, <u>the stipulated in Article 1</u> Law, in form according to <u>appendix</u> <u>5</u> to this standard of the state service;

the copy of the document confirming belonging to nationality of foreign state;

- 3) performs the unlawful activity causing damage to homeland security, health of the population of the Republic of Kazakhstan;
- 4) kindles international and religious strife, counteracts functioning of state language of the Republic of Kazakhstan;
 - 5) belongs to the terrorist and extremist organizations or it is condemned for terrorist activities;
- 6) is in the international wanted list, serves sentence according to the become effective court verdict or its actions are acknowledged as court as especially dangerous recurrence;
 - 7) consists in nationality of other states;
- 8) reported about himself false data in case of the address with the petition for acceptance to nationality of the Republic of Kazakhstan or without reasonable excuse did not submit necessary documents within the terms established by the legislation of the Republic of Kazakhstan;
- 9) has not removed or unspent conviction for making of intentional crime in the territory of the Republic of Kazakhstan or beyond its limits, recognized by that legislation of the Republic of Kazakhstan;
- 10) made offense in the sphere of economy within five years to the address with the application for admission to nationality of the Republic of Kazakhstan or recovery in nationality of the Republic of Kazakhstan;
- 11) repeatedly within five years to the address with the application for admission to nationality of the Republic of Kazakhstan or recovery in nationality of the Republic of Kazakhstan violated the law of the Republic of Kazakhstan in the field of population shift;
- 12) nationality of the Republic of Kazakhstan based on <u>subitems 1)</u> lost, <u>2)</u> and <u>5) of article 21</u> of the Law "About Nationality of the Republic of Kazakhstan" within five years to the address with the application for admission to nationality of the Republic of Kazakhstan or recovery in nationality of the Republic of Kazakhstan;
- 13) owing to participation of person in foreign armed conflicts, extremist and (or) terrorist activities in the territory of foreign state.

The document confirming adoption of the claim is the coupon, with indication of date and time, surname and initials of person which accepted the address/claim and also term and the place of receipt of the answer to the made complaint and contact information of officials at whom it is possible to learn about the course of consideration of the claim.

The claim of uslugopoluchatel which arrived to the service provider is subject to consideration within five working days from the date of its registration. The motivated answer about results of consideration of the claim goes to uslogopoluchatel by mail or is issued purposely in office of the service provider or the Ministry.

In case of disagreement with results of the rendered state service the uslugopoluchatel can address with the claim to authorized body by assessment and control of quality of rendering the state services.

The claim of uslugopoluchatel which arrived to authorized body by assessment and control of quality of rendering the state services is considered within fifteen working days from the date of its registration.

Standard of the state service "Assignment and Prolongation of the Status of the Refugee in the Republic of Kazakhstan"

Chapter 1. General provisions

- 1. The state service "Assignment and Prolongation of the Status of the Refugee in the Republic of Kazakhstan" (further the state service).
- 2. The standard of the state service is developed by the Ministry of Internal Affairs of the Republic of Kazakhstan (further the Ministry).
 - 3. The state service appears territorial subdivisions of the Ministry (further the service provider).

Reception of an application and issue of result of rendering the state service is performed by the service provider.

Chapter 2. Procedure for rendering the state service

- 4. Terms of rendering the state service:
- 1) from the moment of delivery of packet of necessary documents 90 (ninety) calendar days;

- 2) the most allowed time of expectation for delivery of documents no more than 30 (thirty) minutes;
- 3) the most allowed time of servicing 30 (thirty) minutes.
- 5. Form of rendering the state service: paper.
- 6. Are result of rendering the state service:
- 1) assignment of the status of the refugee and certification of the refugee;
- 2) prolongation of the status of the refugee;
- 3) the motivated answer about refusal in rendering the state service in cases and on the bases, <u>stipulated</u> in Item 10 these standards of the state service.

Form of provision of result of rendering the state service: paper.

- 7. The state service is rendered to free of charge physical persons (further uslugopoluchatel).
- 8. Working schedule of the service provider: Monday through Friday inclusive, from 09:00 till 18:30 o'clock, lunch break from 13:00 till 14:30 o'clock, except days off and holidays, according to the labor law of the Republic of Kazakhstan.

Reception of an application and issues of result of rendering the state service is performed from 9:00 to 17:30 o'clock with lunch break from 13:00 to 14:30 o'clock.

The state service is rendered in turn, without making an appointment and the accelerated servicing.

- 9. The list of the documents necessary for rendering the state service in case of the address of uslugopoluchatel, in the place of stay of foreigners which are looking for shelter and members of their families in the Republic of Kazakhstan:
- 1) the petition for assignment (prolongation) of the status of the refugee in form, according to appendix 1 to this standard of the state service;
 - 2) identity documents of person who is looking for shelter;
 - 3) the documents and materials confirming justification of the petition (in the presence).

After adoption of all necessary documents by the service provider the coupon is issued to uslugopoluchatel about adoption of documents in form according to appendix 2 to this standard of the state service with indication of date of issue.

- 10. The bases for refusal in rendering the state service are:
- 1) lack of reasonable concerns that person can fall victim of prosecutions on the basis of race, nationality, religion, nationality, belonging to certain social group or political convictions;

If person refuses to report 2) or reports obviously false data on itself and on circumstances of arrival on the territory of the Republic of Kazakhstan, and also shows false documents;

- 3) availability at person of nationality of the third state whose protection it can use;
- 4) if person arrived directly from the territory of the safe third country;
- 5) if concerning this person there are strong reasons to assume that it participates or participated in activities the terrorist, extremist, and also forbidden religious organizations functioning in the country of civil accessory or in the country from where it arrived;
- 6) if concerning this person there are strong reasons to assume that it committed crime against the world, war crime or crime against humanity in the definition given to these acts in the international acts signed for the purpose of taking measures concerning similar crimes;
- 7) if concerning this person there are strong reasons to assume that it committed serious crime not of political nature outside the Republic of Kazakhstan before arrival on its territory;
- 8) if concerning this person there are strong reasons to assume that it is guilty of making of the acts contradicting the purposes and the principles of the United Nations and the international organizations which members is Kazakhstan;

9) if this person uses protection or the help of bodies or organizations of the United Nations, except Management of the High Commissioner of the United Nations for refugees.

Chapter 3. Procedure for appeal of decisions, actions (failure to act) of the service provider (or) his officials concerning rendering the state service

11. Appeal of decisions, actions (bezdeystviye) of the service provider and (or) his officials concerning rendering the state services: the claim is submitted addressed to the head of the service provider, or the Ministry, to the address specified in Item 13 of this standard of the state service.

The claim is submitted in writing by mail or purposely through office of the service provider or the Ministry.

In the claim the uslugopoluchatel enters its surname, name, middle name (in case of its availability), the postal address, reference number and date. The claim is signed by uslugopoluchatel.

The accepted claim is registered in registers of claims and appeals of physical persons and legal entities of law-enforcement body. The document confirming adoption of the claim is the coupon, with indication of date and time, surname and initials of person which accepted the address/claim and also term and the place of receipt of the answer to the made complaint and contact information of officials at whom it is possible to learn about the course of consideration of the claim.

The claim of uslugopoluchatel which arrived to the service provider is subject to consideration within five working days from the date of its registration. The motivated answer about results of consideration of the claim goes to uslogopoluchatel by mail or is issued purposely in office of the service provider or the Ministry.

In case of disagreement with results of the rendered state service the uslugopoluchatel can address with the claim to authorized body by assessment and control of quality of rendering the state services.

The claim of uslugopoluchatel which arrived to authorized body by assessment and control of quality of rendering the state services is considered within fifteen working days from the date of its registration.

12. In disagreement cases with results of the rendered state service, the uslugopoluchatel has the right to take a legal action in the procedure established by the legislation of the Republic of Kazakhstan.

Chapter 4. Other requirements taking into account features of rendering the state service

- 13. Addresses of places of rendering the state service are placed on Internet resource of the Ministry: www.mvd.gov.kz in the Section "About Activities of Law-enforcement Bodies".
- 14. Uslugopoluchatel has possibility of receipt of information on procedure and the status of rendering the state service in the mode of remote access by means of single contact center concerning rendering the state services.
- 15. Conditions for servicing of uslugopoluchatel physically challenged are provided, entrances to buildings are equipped with ramps, there are chairs for expectation.
- 16. Contact telephone numbers of service desks concerning rendering the state service are specified on Internet resource: www.mvd.gov.kz. Single contact center concerning rendering the state services: "1414".
