Mae adran 118 o Ddeddf Mewnfudo a Lloches 1999 ("Deddf 1999") yn ei gwneud yn ofynnol i awdurdod tai sicrhau, cyn belled ag y bo'n ymarferol, na fydd tenantiaeth ar lety mewn tŷ sy'n cael ei ddarparu o dan Ran II o Ddeddf Tai 1985, heblaw llety sy'n cael ei ddyrannu o dan Ran VI o Ddeddf Tai 1996, na thrwydded i'w feddiannu, yn cael ei roi i berson sy'n ddarostyngedig i reolaeth fewnfudo oni bai bod y person hwnnw yn perthyn i ddsbarth a bennir mewn gorchymyn a wneir, mewn perthynas â Chymru, gan Gynulliad Cenedlaethol Cymru, neu oni bai bod y denantiaeth, neu'r drwydded i feddiannu, yn cael ei roi yn unol â threfniadau a wneir o dan adran 95 o Ddeddf 1999.

Mae'r Gorchymyn hwn yn darparu ar gyfer pennu'r dosbarthiadau o bersonau a bennir at ddibenion adran 118 o Ddeddf 1999 mewn perthynas â Lloegr gan Gorchymyn Personau sy'n Ddarostyngedig i Reolaeth Ymfudo (Llety Awdurdodau Tai a Digartrefedd) 2000 at y dibenion hynny mewn perthynas â Chymru hefyd.

Section 118 of the Immigration and Asylum Act 1999 ("the 1999 Act") requires a housing authority, so far as practicable, to secure that a tenancy of, or a licence to occupy, housing accommodation provided under Part II of the Housing Act 1985, other than accommodation allocated under Part VI of the Housing Act 1996, is not granted to a person subject to immigration control unless that person is of a class specified by an order made, in relation to Wales, by the National Assembly for Wales or the tenancy of, or the licence to occupy, such accommodation is granted in accordance with arrangements made under section 95 of the 1999 Act.

This Order provides for the classes of persons which are specified for the purposes of section 118 of the 1999 Act in relation to England by the Persons subject to Immigration Control (Housing Authority Accommodation and Homelessness) Order 2000 to be specified for such purposes in relation to Wales also.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 118 a 166(3) o Ddeddf Mewnfudo a Lloches 1999(a) ac a freiniwyd yng Nghynulliad Cenedlaethol Cymru i'r graddau y maent yn arferadwy yng Nghymru(b).

The National Assembly for Wales makes the following Order in exercise of the powers conferred on the Secretary of State by sections 118 and 166(3) of the Immigration and Asylum Act 1999(a) which are vested in the National Assembly for Wales so far as exercisable in Wales(b).

**Enwi, cychwyn a chymhwysu**

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Personau sy'n Ddarostyngedig i Reolaeth Fewnfudo (Llety Awdurdodau Tai) (Cymru) 2000 a daw i rym ar 1 Ebrill 2000.

**Citation, commencement and application**

1.-(1) This Order may be cited as the Persons Subject to Immigration Control (Housing Authority Accommodation) (Wales) Order 2000 and shall come into force on 1st April 2000.

(2) Mae'r Gorchymyn hwn yn gymwys i Gymru yn unig.

(2) This Order applies to Wales only.

**Llety awdurdodau tai**

2. Mae'r dosbarthiadau o bersonau a bennir yn Erthyglau 3 a 4 o Orchymyn Personau sy'n Ddarostyngedig i Reolaeth Ymfudo (Llety Awdurdodau Tai a Digartrefedd) 2000(c) wedi'u pennu at ddibenion Adran 118(1) o Ddeddf Mewnfudo a Lloches 1999 mewn perthynas â Chymru, ac mae i ymadroddion a ddefnyddir yn yr Erthyglau hynny yr ystyr a roddir iddynt gan Erthygl 2 o'r Gorchymyn hwnnw.

**Housing authority accommodation**

2. The classes of persons specified in Articles 3 and 4 of the Persons subject to Immigration Control (Housing Authority Accommodation and Homelessness) Order 2000(c) are specified for the purposes of Section 118(1) of the Immigration and Asylum Act 1999 in relation to Wales and expressions used in those Articles have the meaning given to them by Article 2 of that Order.
