UNHCR seeks to uphold the human rights of displaced people, ensuring that refugees are provided with legal assistance, protected from sexual and gender-based violence (SGBV) and are not returned involuntarily to a country where they could face persecution.

In both emergency and protracted settings, UNHCR supports the construction of healthcare centres and hospitals, which provides necessary physical and psychological care for individuals and families.

UNHCR continues to work on malnutrition through enhanced prevention, detection and treatment, as well as providing vital water infrastructure that is crucial in disease prevention.

Steps to Leaving a

Legacy Gifto MHCR



Decide on the beneficiary that you would like to recognize in your legacy gift. Once you have considered the needs of your loved ones, you may also wish to consider leaving a humanitarian legacy gift to UNHCR.

Choose the type of legacy gift you would like to leave:

Gift-in-Will:

- A residuary gift: the remainder of your Estate once everything else is taken care of
- A percentage of your Estate: a specific proportion of your Estate's value
- A pecuniary gift: a specific sum of money

Insurance Policy Giving:

Naming the family, friends and/or UNHCR as the beneficiary of your insurance policies, either wholly or partially of the sum insured to support the work of UNHCR.

Gift-in-Will:

- Visit Forevergift (https://www.forevergift.hk/unhcr-eng) to create a Will for FREE (all Wills are prepared in Chinese, if you need a Will in English, please feel free to call or WhatsApp Forevergift at 5468 3635 for more details.)
- Visit a lawyer to have your Will written or updated with a codicil

Frequently Asked

Questions

Why should I make a Will?

 Making a Will is the only way you can be sure your wishes will be met after you pass away. Dying without a Will – 'intestate' –can cause unnecessary distress to family and friends. You can leave assets to beneficiaries who are not related to him/her, e.g. friends and charities.

Can including UNHCR in my Will reduce inheritance tax?

• In Hong Kong, Estate Duty was abolished on 11st February, 2006. People surviving that date do not have to worry about this.

Can I write my own Will?

Yes, but any errors in Wills can cause problems and make it invalid.
 That is why we strongly recommend that you use a qualified solicitor.

What if I already have a Will?

 You can amend an existing Will to include UNHCR very simply by asking a solicitor to draw up a 'codicil'.

What essential information will I need to give my solicitor?

 You will need to give your solicitor our name (THE UNITED NATIONS HIGH COMMISSIONER FOR REFUGEES), our registered charity number (91/6713) and our address (1/F, Eaton House, 380 Nathan Road, Kowloon, Hong Kong). You should also advise whether you would like to leave a specific, pecuniary, residuary or contingent gift.

Should I tell UNHCR I've included you in my Will or Insurance Policy?

• Your Will and Insurance Policy are very personal documents and you are under no obligation to let us know if you have included a gift to us. However, it is enormously helpful if we do know your intentions. That way we can make sure that your gift is used according to your wishes. Notifying us of your plans will enable us to plan for the use of your future gift. We will only send you information that is helpful and relevant to your circumstances and invite you to appropriate events. We'd also like the chance to say 'Thank you'!
