1. BACKGROUND INFORMATION

1.1 Introduction to Refworld

UNHCR's Refworld (www.refworld.org) is the leading source of information enabling high quality refugee status determination. Refworld is a collection of relevant and up-to-date public-domain documents from UNHCR and its information partners throughout the world. Refworld contains country of origin/asylum information reports, policy documents, documents relating to international and national legal frameworks, and other reference documents. The information has been carefully selected and compiled from UNHCR's global network of field offices, governments, international, regional and non-governmental organizations, academic institutions and judicial bodies. Refworld contains over 108,000 full-text searchable documents.

1.2 Case Law Collection

The Refworld [Case Law](#) collection currently comprises over 7,300 decisions/judgments from over 160 national and international courts, administrative tribunals and other judicial bodies. The collection focuses on asylum/refugee law and human rights issues, and covers more than 45 national jurisdictions, and a substantial number of international judgments and decisions from the United Nations, the European Court of Human Rights and other international and regional courts.

As Refworld is mainly an English-language information tool, majority of the available case law is in English. However, hundreds of decisions/judgments are also available in French, Spanish, German and Portuguese.

2. CASE LAW SELECTION METHODOLOGY

2.1 Precedent-Setting and Country Guidance

Whilst the [Case Law](#) collection focuses mainly on asylum/refugee law and human rights issues, it also contains a selection of key jurisprudence dealing with international humanitarian and international criminal law, immigration and counter-terrorism. This includes, for example, an exhaustive collection of trial and appeal judgments from the [International Criminal Tribunal for the former Yugoslavia](#), [International Criminal Tribunal for Rwanda](#) and the [Special Court for Sierra Leone](#).

Case law is selected for its precedent-setting value. As such, the collection comprises key decisions/judgments from the highest national instances (e.g. [UK House of Lords](#), [US Supreme Court](#), [High Court of Australia](#), [Conseil d'état](#) (France)), regional (e.g. [European Court of Human Rights](#), [Inter-American Court of Human Rights](#), [African Commission on Human and Peoples' Rights](#)) and international bodies (e.g. [UN Committee Against Torture](#), [UN Human Rights Committee](#)), but also first appeal instances, particularly where decisions provide country guidance (e.g. [Cour nationale du droit d'asile](#) (France), [Refugee Status Appeals Authority of New Zealand](#), [UK Asylum and Immigration Tribunal](#), [US Board of Immigration Appeals](#)).

2.2 Geographical and Language Diversity

Currently, 45 national jurisdictions and several regional and international bodies are being monitored. Although most national jurisprudence in the Refworld collection emanates from industrialized countries with established asylum systems, the Refworld team is actively seeking to achieve a wider geographical diversity.

The selection of case law is heavily influenced by the volume and availability of case law from a particular jurisdiction, as well as by the language of the publication. Since Refworld is principally an English-information tool, the majority of decision/judgments are in English, although other language versions are included, where available. As such, Refworld comprises a comprehensive selection of case law from English-speaking, and particularly common law, jurisdictions, including:

2.3 Resources

The [Case Law](#) collection is daily updated (UNHCR Headquarters working day). The Refworld team has one full-time person dedicated to monitoring and updating national and international case law of interest.

The various methods employed for identifying and selecting pertinent case law include the regular monitoring of: judicial bodies' websites (e.g. [HUDOC database](#) for European Court of Human Rights judgments); publicly-available and subscription-based legal databases (e.g. the [British and Irish Legal Information Institute](#), Lexis/Nexis, Lawtel); news and publications from established organizations dealing with human rights and refugee law issues (e.g. Asylum Aid, Human Rights Watch, Liberty, Redress); academic literature and law reports (e.g. Refugee Survey Quarterly, International Journal of Refugee Law, Immigration and Nationality Law Reports).

Case law is also sourced from the issuing body either through direct communications (i.e. electronic notifications) or through case law bulletins (e.g. Refugee Status Appeals Authority of New Zealand), particularly in jurisdictions which produce a substantial volume of case law (e.g. Australian Refugee Review Tribunal). In addition, UNHCR's network of field offices and regional legal advisers identify and, where necessary, translate national and regional case law of particular relevance.

Since September 2007, the Refworld team is including documents in additional languages in the database. These other language versions are accessible through the English version of the document, by clicking on the "Other languages" or "Related Document" options.

3. ACCESSING AND SEARCHING THE CASE LAW COLLECTION

3.1 Browsing the Case Law Collection

There are various ways of browsing the Refworld collection, including by country/region of interest, document type, Publisher or topic. The Refworld Case Law Collection is available under "[Case Law](#)" when browsing by "[Document Type](#)". Please note that when browsing, results will appear in reverse chronological order, i.e. the most recent document first.


3.1.1 By Document Type

You can browse by “[Document Type](#)” through the left-hand side of the navigation menu available on Refworld (www.refworld.org). For accessing the integrality of the collection, simply click “[Case Law](#)”. You will obtain a list of all the available case law in reversed chronological order.

You can, subsequently, narrow the results by choosing a “Publisher” (list of all instances by jurisdiction in alphabetical order) or a “Country” (list of all countries of asylum and origin in alphabetical order) using the tabs at the top of the “[Case Law](#)” page. Click on a link in the “breadcrumb trail” (which appears on the top of the page and begins with “Home >”) will automatically take you back to that page.

Example:

To browse all the judgments by the High Court of Australia, please click “Australia: High Court”:



3.1.2 By Publisher

If you are looking for documents from a particular court, it is easiest to access the Refworld collection by [Publisher](#). The complete listing of more than 300 Refworld sources is available in alphabetical order or by “Publisher Category” (type of organization).

Please note that “publishers” include governments, non-governmental organizations, United Nations and other international organizations, judicial bodies, and others. To access the case law from a particular instance in a jurisdiction, simply click on the appropriate name. Please note that the national/international jurisdiction appears first, followed by the name of the particular judicial body. Thus, the Supreme Court of Canada will be listed as “Canada: Supreme Court”, and the European Court of Human Rights, as “Council of Europe: European Court of Human Rights”.

You can narrow the results by choosing a “Country” (list of all countries of asylum and origin in alphabetical order) from the tabs in the navigation menu at the top of the particular publisher’s page. To further narrow your results, use the “Filter” options (see section 3.1.4 below).

Example:

For browsing all the available Inter-American Court of Human Rights case law involving Peru, click on “Peru” from the Country list.

3.1.3 By Topic

You also have the option to browse, through the left navigation menu of Refworld, documents by [Topics](#) covering a wide array of subject areas. These include aspects of international refugee law, international humanitarian and human rights law, specific groups, durable solutions, and domestic legal regimes. Topics (keywords) are identified manually for each decision/judgment in Refworld. Click on a particular topic from the list (organized in alphabetical order), or use the list of topic categories (“chapters”) to view a more detailed listing of sub-topics.

Please note that, when browsing, the number of documents available under a certain category (whether a particular publisher, topic, etc.) is indicated in brackets immediately following that particular category.

Example:


For browsing all the available documents on genocide under the “International Crimes” category, click on “Genocide”. The number of documents relating to “genocide” is 298, as indicated in brackets.



To further narrow your results, use the “Filter” options (see section 3.1.4 below).

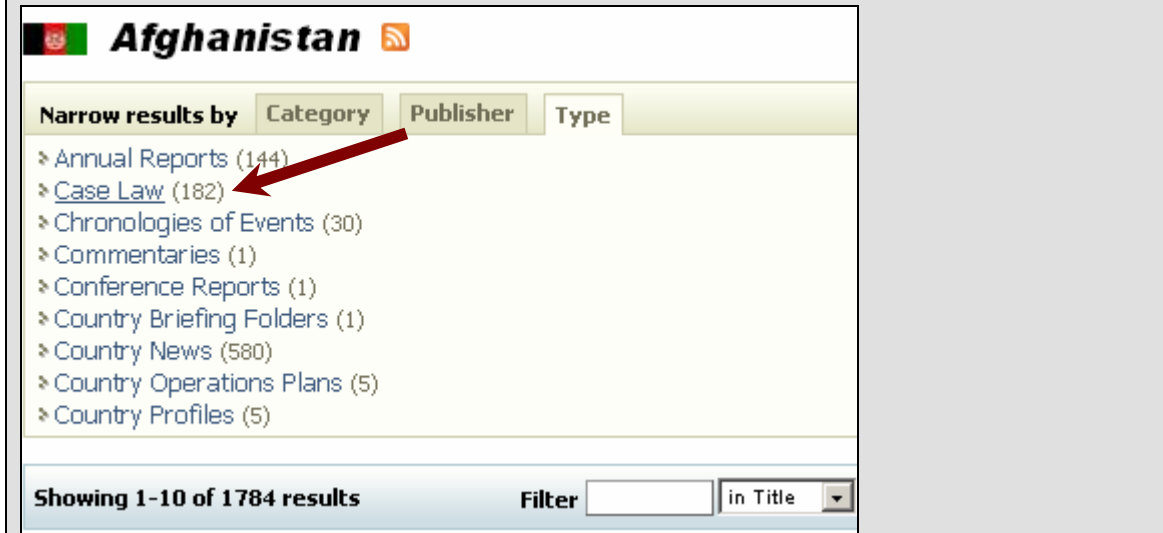
3.1.4 By Region or Country

You can select a particular region or country through the left navigation menu of Refworld by clicking on the world map, the region names, or by using the country drop-down menu. By selecting a region/country, you will have a display all information in Refworld relating to that region/country, from all sources in reverse chronological order. Note that the top right of the Refworld homepage gives quick access to the [top countries of origin](#). The ranking of these countries is regularly updated on the basis of UNHCR and government statistics.



To browse all available documents relating to a specific country, select the country from the list of countries. You can further narrow your results by using the tabs to choose a category of information (i.e. country, legal, policy or reference), a publisher or type of document. “Case law” is listed under (document) “Type”.

Example:



In addition an “[A - Z Index](#)” is available on Refworld, which combines all publishers (sources), document types (types of information) and topics (keywords) in one list, in order to further increase usability. In addition, the “[Site Map](#)” is also useful in assisting you to browse Refworld.

3.1.5 “Filter” Options

As outlined above, it is possible to browse the Refworld collection by type of document, publisher/source, topic/keyword, region or country. Using the filter bar that appears above document listing in the search and browse modes, you can further refine your results.

Currently, it is possible to filter by year of publication, terms in the document title or document text (full text). The “filter bar” is not case sensitive i.e. a term starting with an upper or lower case will produce the same results. When filtering the browsing results by using an expression or phrase, write such expression or phrase in between double quotation marks (e.g. “state protection” or “article 8”).

Additional filtering options, including modifying the number of results per page and ordering results by date or relevance, are also available. To return to the full set of documents, use the breadcrumb trail.

Example:

For obtaining all case law from the Federal Magistrate Court of Australia dealing with “Falun Gong”, select the Federal Magistrate Court of Australia from the list of

“Publishers”, then enter “Falun Gong” in the box in the filter bar and choose “in full text” from the drop-down menu and click “Go”.



3.2 Searching the Case Law Collection

3.2.1 Simple Search


In the left navigation menu of the Refworld website, you will find at the top left a very powerful, fast and reliable full-text search box. When using the basic search box, it is preferable to limit yourself to two or three relevant terms. It is not necessary to use “connectors” i.e. “and”, “or”, etc.

Please note that:

- when searching for documents containing two or more keywords, enter the keywords with a space between them (e.g. Iran homosexuals);
- when searching for documents containing a particular expression or phrase, place double quotation marks around the group of words (e.g. “traditional harmful practices”);
- when searching for documents excluding a specific word, place a minus sign immediately before the word to be excluded without leaving a space after the minus sign) (e.g. -Uighurs);
- when searching for documents excluding several words, place a minus sign before the list of words separated by commas (with no spaces after the minus sign and the commas) and put in parentheses (e.g. -(iran,kurds));
- when searching for documents containing words starting with a particular sequence of letters, enter the letter sequence followed by an asterisk (e.g. search for the term ref* to find refuge, refugee, refugees, refer, etc.);
- when searching for documents containing a word with different spellings, enter the specific word substituting the letter(s) which differs in the alternative spellings with a question mark (e.g. tal?ban to find taliban or taleban)

Example:

To find documents on military service in Eritrea or concerning Eritreans, enter in the Search Box: “military service” Erit*



In order to obtain relevant results, choose specific terms rather than general ones. Contrary to when browsing, search results will be by default displayed in order of relevance. A filter bar is included through which you can further re-fine your search results, by searching for words in the title/full-text or a specific year of publication, and/or display your results by date.

Example:

You could further refine the above search. By writing “Eritrea” in the filter box and choosing “Title” from the drop down menu, the results are limited to documents containing “Eritrea” in their title, thereby reducing the number of documents from 847 to 139.

3.2.2 *Advanced Search*

The “[Advanced Search](#)” will give you extended options to refine or expand your search. To this effect, one or more of the available search “fields” can be used.

Please note that when using the “Title” field to look for a specific document, the connecting words (also referred to as “noise” words, such as “and”, “or”, “a”, “of” etc.) should not be included. For example, if you are searching for the Cartagena Declaration on Refugees, you only need to enter in the “Title” field: Cartagena Declaration Refugees or Cartagena Declaration or Cartagena Refugees.

Example:

In order to search for case law on Iranian homosexuals in need of international protection since January 2007, you would fill in the fields below. Please note that when searching results from a specific date to the present, the “end date” field does not need to be filled.

The results of the above search can be further refined by, for instance, selecting a publisher (in this case the UK Asylum and Immigration Tribunal), and writing “CG” in the “Citation” field (which will reduce the results to only Country Guidance cases). In this example, the results will be reduced from four to one as a consequence.

3.3 Other Useful Features

3.3.1 Document View



Documents included in Refworld are either in html-format (📄) or in pdf-format (📄). In order to view documents in pdf-format, you will need to have [Acrobat Reader](#) installed on your computer.

Every time you open a document in Refworld (in whatever format), you will see a table/box at the top of the page, which includes the core data relating to that document (title, publisher, publication date), as well as additional information such as the citation or document symbol, other language versions where available, related documents when applicable, and comments or remarks. The table/box also includes a feature (“cite as”) which can be used when you would like to cite a document that you found in Refworld.

When opening a document in html-format, at the top you will have the option to change the font size of the viewed document (“text size”) or to e-mail the document to yourself or someone else that might be interested (“email this document”). When you want to print or save the document, please make sure to use the “printable version” option, as it will provide you with a clean copy of the document, without the Refworld frame. You can search for words in the document, by using the Ctrl-F option.

When opening a document in pdf-format, you will similarly have the option to e-mail the document to yourself or someone else that might be interested (“email this document”). In addition, you can open the document in a new browser window, so that you will have more space to view the document, without the Refworld frame. To print or save and to search within documents in pdf-format, you should use the Adobe Reader toolbar.

3.3.2 Other Language Versions

Wherever available, other language versions of a particular decision/judgment will also be made available, either as a “Related document” or as an “Attachment”.

If the additional language version is in one of the languages available in Refworld, particularly English, French, and Spanish, a separate record will be added and the additional language version will appear as a “Related document”.

Example:

If the decision/judgment is not in one of the above listed languages, it will be added as an attachment and will figure in the “Other Languages / Attachments” field of the English version. Such attachments are accessible by clicking on their title. Please note that “Attachments” are not searchable.

3.3.3 Case History / Summaries / Other Comments

Wherever possible, the case history or the precedential value (e.g. whether the decision was affirmed, overturned, etc.) of a decision/judgment will be reflected in the “Comments” field. Occasionally, short summaries of a decision of a particularly interest will also appear in the “Comments” field or as an “Attachment”.

3.4 Personalization Features / Information Alerts

3.4.1 Personalization Features

Refworld offers the possibility to create a personal profile, through which you can further optimize and personalize your Refworld experience. The personalization features enable you to maintain your Refworld profile, save searches, create folders with specific documents, and receive weekly Refworld updates that match your interests.

It is easy and quick to initially create a profile through the [register/login box](#) on the top right side of the Refworld homepage. When registering, you can indicate your interest in receiving Refworld weekly updates regarding specific countries, specific publishers/sources, and specific document types. You will then automatically receive by e-mail a weekly update of new documents in Refworld that match your interests. To unsubscribe to certain items, simply return to your profile and deselect the items for which you no longer wish to receive alerts.

Once logged in, you can take advantage of the “personalization bar” (marked in green), which can be used to save searches you have done either through the full-text search or by using the [“Advanced Search”](#). In addition, all documents in a document listing (both when searching and when browsing) will have a check-box in front of them. You can select as many documents as you like, and add them to your folders of choice, also through the green personalization bar.

Through the link to “Your Profile” in the header of the Refworld website (marked in green), you can at all times edit your profile and preferences, access your folders and saved searches, and manage or delete them.

3.5 Advantages of Using Refworld

Refworld is a user-friendly collection of relevant and up-to-date public-domain documents from UNHCR and information partners throughout the world, aimed at enabling well-informed and prompt refugee status determinations. As its collection, currently almost 110,000 documents, encompasses country reports, UNHCR country and thematic positions, international and national case law, regional and national legislation, research papers, training manuals, etc., it is a “one stop shop” for refugee status adjudicators and others. For a description of the various types of documents in the Refworld collection, please see the Annex to this Guide. It also contains a directory of [“External Links”](#) dealing with refugee, asylum, human rights and related topics.

Refworld is internet-based, thus accessible from anywhere in the world. Unlike other subscription-based country and legal information services, Refworld is free of charge.

Refworld is updated every (UNHCR Headquarters) working day. Therefore, new UNHCR papers, country reports, documents from various UN sources, case law, legislation and such are added on a daily basis. Please see the [“Latest Refworld updates”](#) page of Refworld online for the most recent additions.

4. FORTHCOMING DEVELOPMENTS

The Refworld team is actively working with UNHCR field offices and regional bureaux, as well as information partners and government counterparts, with a view to achieving improved **geographical coverage of both national case law and legislation**.



Significant efforts are made to capture current precedent-setting national case law and newly enacted laws relating to asylum/refugee law and human rights in countries of asylum, as well as new or in force national legislation (particularly penal, civil and human rights legislation) in the countries of origin, with particular focus on the 15 top countries of origin.

To this effect, the Refworld team is actively seeking **new partnerships** with non-governmental or international organizations with a proven record in refugee/asylum law and international protection in general.

Future improvements include **search enhancements** such as proximity, phonetic or fuzzy, thesaurus expansion and spell checking. For languages other than English, seamless searching of accented words and diacriticals will be supported. Browsing enhancements will include topics tabs for countries, publishers, categories and document types and extension of topic browsing to include publishers, countries and document types. The “[Advanced Search](#)” will incorporate topics as well.

ANNEX: Additional Information Sources on Refworld

1. SPECIAL FEATURES

Refworld contains several “Special Features”, developed by UNHCR staff with expertise in a particular area. They are thematic guides that provide quick access in a structured manner to key documents and related parts of Refworld.

For example, the Special Feature on “[Refugee Status Determination](#)” shortlists the 1951 Convention on the Status of Refugees and other legal instruments, the UNHCR Handbook and Guidelines on International Protection, as well as the key policy documents relating to refugee status determination, country-specific information tools, and related UNHCR and external weblinks.

There are currently 10 Special Features, including on “[Internally Displaced Persons](#)”, “[Migration](#)” and “[Statelessness](#)”. For an exhaustive list, please see the “[Special Features](#)” page of Refworld. The Special Features are also accessible through the Refworld homepage.

2. LEGAL COLLECTION

In addition to the Case Law Collection, Refworld’s wider “[Legal collection](#)” comprises a substantive selection of over 3,200 national legislation documents from almost 200 countries and autonomous administrative regions/territories. The [national legislation](#) collection encompasses asylum/refugee law, as well as immigration, human rights, criminal/penal, constitutional and other relevant laws.

Also available is a significant collection of asylum/refugee law and human rights related [bilateral](#) and [multilateral](#) treaties/agreements, [regional legislation](#) (mostly from the European Union), [legal analyses](#) and [case law compilations](#), [court interventions/amicus curiae](#) and [conclusions on international protection](#).

3. COUNTRY COLLECTION

The “[Country collection](#)” consists of documents from a wide variety of carefully selected sources, including UNHCR and other UN bodies/agencies, governmental and non-governmental organizations, international and regional organizations, academic institutions, etc., monitoring and reporting on country situations. The collection focuses on the human rights situation in countries of origin, and contains, *inter alia*, [annual reports](#), [country news](#), [country reports](#), [state party reports](#), [concluding observations](#) and other documents providing country of origin information. Some of Refworld’s strategic information partners are listed on the “[Partners](#)” page.

4. POLICY COLLECTION

The “[Policy collection](#)” contains mainly UNHCR policy documents, although contributions from other sources, such as the [Inter-Agency Standing Committee](#), [European Commission](#) and the [Parliamentary Assembly of the Council of Europe](#), are



continually added to the collection. The majority of the documents in the collection consists of country-specific asylum policy, and includes [country positions](#), protection [policy papers and positions](#), [thematic guidelines](#) and [statements](#) on international protection.

5. REFERENCE COLLECTION

Finally, the “[Reference collection](#)” consists of primarily thematic documents from a variety of publishers and gives access to documents such as [maps](#), [handbooks](#), [training manuals](#) and [research papers](#).
