Country Advice Bahrain Bahrain – BHR36231 – Lel Hasereba Habel El Nadiya – Salah Al Bandar – Shia Muslims 25 February 2010

1 Please provide any information on a group in support of the Shia Muslims in Bahrain called Lel Hasereba Habel El Nadiya, and its leader Salah Elbender?

No information was found regarding a group called Lel Hasereba Habel El Nadiya or similar. A Google translation of 'Lel Hasereba Habel El Nadiya' into Arabic characters and subsequent search using these characters did not produce any results. A translation of 'Lel Hasereba Habel El Nadiya' into English using Google Translate resulted in 'For/Of Exclusive Rope Club', for which no relevant results relating to Bahrain were found.

Annual reports published by the US Department of State, Freedom House and Amnesty International identify a Dr Salah Al Bandar, a Sudanese-born British citizen and former advisor to the Bahraini government's "president of the Central Informatics Organization, which originally had responsibility for conducting elections". In September 2006, Al Bandar published and "distributed a report to selected individuals and political societies claiming the existence of a group of high-level individuals in the government that attempted to manipulate the election process", particularly the outcome of the November 2006 parliamentary elections, at the expense of Bahrain's majority Shi'a Muslim population. Al Bandar "was accused of seizing official government documents and stealing private checks", and was subsequently deported to the United Kingdom on 13 September 2006. The report, and the publication of any related information, was banned on 4 October 2006 by a High Criminal Court injunction, which remained in effect at the end of 2008. Websites were also banned from discussing the report and the alleged election fraud. Al Bandar was convicted in absentia on 19 April 2007, and sentenced to four years imprisonment as well as a US\$265, or 100 dinar, fine.^{1 2 3 4 5}

A number of articles on the BCHR website also refer to Dr Salah Al Bandar and the 216-page report, which was distributed by the Gulf Centre for Democratic Development (GCDD) and "contains almost 200 pages of cheques, receipts, letters, bank statements and accounts sheets" in support of Al Bandar's claim that "[a] secret web lead by a high government official, who is a member of the royal family, has been operating in Bahrain with an aim to manipulate the results of coming elections, maintain sectarian distrust and division, and to ensure that Bahrain's Shias remain oppressed and disenfranchised". The report also finds that "policies to subjugate Bahrain's Shia majority…are being practiced today by high ranking government

officials".⁶ One article claims that the ban on any media coverage relating to Al Bandar's 2006 report has resulted in the prosecutions of journalists and human rights activists in Bahrain, including Nabeel Rajab of the BCHR. It is argued that the ban has also been used to prevent internet access to many websites, including that of the BCHR, which refer to the report.⁷

An article dated 21 September 2006 claims that Dr Salah Al Bandar had "worked as a strategic planning consultant to the Cabinet Affairs Ministry [since October 2005] and various private companies, up to his arrest and deportation"; and is the secretary-general of the GCDD. (The website of the GCDD is currently under maintenance.) Al Bandar's Bahraini wife Layla Rajab is the president of both the GCDD and the National Liberal Thought Society. ⁸ The following news articles also describe Al Bandar's activities and involvement in the publication of the so-called 'Bandargate' report and his subsequent deportation from Bahrain. ^{9 10} ¹¹ ¹² ¹³ ¹⁴.
