#### **G**EOGRAPHY

The Foreign and Commonwealth Office (FCO), UK in its Country Profile: Bosnia and Herzegovina, last updated 30 August 2007, recorded that:

"Bosnia and Herzegovina (BiH) has borders with Serbia to the East, Montenegro to the South East, Croatia to the North and West, and a 12 kilometre coastline on the Adriatic Sea. Its landscape varies from high altitude central mountains to arable land in the

north and Mediterranean vineyards in the south, with most of the major towns being located in valleys. Climatically, Bosnian summers last from May to September and are warm and humid whilst winters tend to be foggy and snowy and last from November to February. Autumn and Spring are usually short." [4a]

### **HISTORY**

"The Kingdom of Serbs, Croats, and Slovenes was formed in 1918 in the aftermath of the First World War and changed its official title to Yugoslavia in 1929. Following the Second World War, communist Partisan Leader, Marshall Tito, took control of the country and ruled it for the next 40 years. Although presiding over a communist regime, Marshall Tito successfully steered his own path between East and West and was a founder member of the Non Aligned Movement of countries in the United Nations." (FCO Country Profile, 30 August 2007) [4a]

"Following Tito's death in 1980 Yugoslavia began slowly to disintegrate in a process that culminated in the Balkans wars of the early 1990s. Slovenia, Croatia and Republic of Macedonia declared their independence in 1991, BiH in 1992. The remaining republics Serbia and Montenegro declared a new Federal Republic of Yugoslavia in 1992 and, under Slobodan Milosevic, undertook military interventions to achieve the integration of ethnic Serbs into 'Greater Serbia'. The policy was ultimately unsuccessful and prompted a co-ordinated military response from the United Nations and the international community, primarily in BiH, which eventually led to the Dayton Agreement of 1995. This agreement fixed internal borders in the Western Balkans along lines that still exist today." (FCO Country Profile, 30 August 2007) [4a]

#### RECENT EVENTS AND POLITICAL DEVELOPMENTS

"Bosnian political leaders signed a commitment to pursue constitutional reform in Washington on 21 November 2005. Discussions had been ongoing, facilitated by the international community, with the goal of improving the functionality of Bosnia and Herzegovinian institutions. The leaders of the largest political parties agreed to a constitutional reform package on 18 March 2006, which would have established a rotating Presidency with a single President and two Vice Presidents (as opposed to the previous, tripartite structure); build a more effective Parliament and enhance the protection of human rights. This would have been an important first step for Bosnia and Herzegovinian on the process of reform towards a more functional state, European integration and better human rights. But the agreement was blocked in the Bosnia and Herzegovinian House of Representatives on 26 April 2006, largely due to opposition from SBiH and HDZ-1990. Constitutional reform is still crucially important for Bosnia and Herzegovinian and there will need to be compromise between all parties to reach an agreement. As well as decisions on the April 2006 package of constitutional reforms, we hope that a longer term process will get under way soon."

"On 4 January 2007 a state level coalition government was formed. It consists of SDA and SBiH (Bosniak), SNSD and PDP (Bosnian Serb) and HDZ, HDZ 1990 and NSRzB (Bosnian Croat). Nikola Spiric (SNSD – Bosnian Serb) was appointed as state level Prime Minister." (FCO Country Profile, 30 August 2007) [4a]

Human Rights Watch in its World Report 2007 commented that:

"While nationalist parties lost some ground in the October 2006 elections, the election of Bosnian Muslim and Serb nationalists to the country's three-person presidency threatened to continue the dangerous rhetoric of the pre-election period. The presidency's Muslim representative Haris Silajdzic called for the dissolution of the two entities that make up Bosnia (Republika Srpska and the Federation), while Milorad Dodik, the Republika Srpska prime minister and head of the party holding the Serb seat on the presidency, called for Republika Srpska's self-determination. The international community's high representative in Bosnia responded by threatening to remove Dodik from office should he call a mooted referendum on the issue." [5a]

# **ECONOMY**

"Today, BiH's economic growth continues to be generated largely by post-war reconstruction funded by external aid (amounting to US\$5billion between 1995-99). The macro-economic situation remains weak but stable, underpinned by a fully convertible currency (the Convertible Mark (KM), which has a fixed parity with the Euro), low single digit inflation and relatively tight fiscal policies supported by the IMF. Post-war growth rates of 30% have stabilised at around 5%. With its official GDP of US\$2,440 per capita in 2005, BiH falls into the category of lower middle income countries. Approximately 62% of this comes from the service sector, 29% from industry and 9% from agriculture." (FCO Country Profile, 30 August 2007) [4a]

# **HUMAN RIGHTS**

The United States State Department in its Country Report on Human Rights Practices – 2006 noted that:

"The government's human rights record remained poor, although there were improvements in some areas. Serious problems that remained included:

- deaths from landmines
- physical abuse by police officials
- overcrowding and poor prison conditions
- improper influence on the judiciary
- harassment and intimidation of journalists
- restrictions on religious minorities and attacks on religious structures
- obstructionism toward minority returnees
- government corruption
- societal discrimination against women, ethnic minorities, sexual minorities, and persons with disabilities
- ethnically-motivated violence
- trafficking in persons
- limits on employment rights [2a]

The Foreign and Commonwealth Office (FCO), UK in its Country Profile: Bosnia and Herzegovina, last updated 30 August 2007, noted that:

**Refugee Returns:** "Substantial progress has been made in allowing refugees and displaced people to return home. Statistics from the UN High Commissioner for Refugees (UNHCR) indicate that by February 2006 1,012,320 refugees and internally displaced persons had returned to their pre-war places of origin. While this is

encouraging, around 50,000 refugees from BiH remain in Croatia, Serbia and Montenegro, and almost 200,000 are still internally displaced within BiH. Incidents of return-related violence are rare, but do still occur. Returnees continue to face a lack of educational facilities, unresolved property issues and poor economic prospects. The failure to bring to justice all war crimes indictees has also reduced confidence in the return process." (FCO Country Profile, 30 August 2007) [4a]

War Crimes: "2005 saw good progress in delivery of several persons indicted for war crimes and more recently there has been further progress with the arrests of ICTY indictees, Zdravko Tolimir on 31 May 2007 and Vlastimir Djordjevic on 17 June 2007. However, the continued presence at large of ICTY indictees — most notably the Bosnian Serb wartime leaders Radovan Karadzic and Ratko Mladic - represents a fundamental obstacle to lasting stability, reconciliation and prosperity in BiH and the wider region. The UK Government continues to make it clear that the continued freedom of indictees is incompatible with BiH's aspirations of further integration with Euro-Atlantic structures."
