ON APPROVING THE "2012-2016 ACTION PLAN FOR IMPLEMENTATION OF THE CONCEPT FOR THE POLICY OF STATE REGULATION OF MIGRATION IN THE REPUBLIC OF ARMENIA"

The Government of the Republic of Armenia decides:

- 1. To approve the "Action Plan for Implementation of the Concept for the Policy of State Regulation of Migration in the Republic of Armenia" in accordance with Annex N 1.
- 2. To define that the state executive bodies while developing the draft annual Action Plan of the Government of the Republic of Armenia, as far as migration policy is concerned, shall assume as a basis the actions defined in the "2012-2016 Action Plan for Implementation of the Concept for the Policy of State Regulation of Migration in the Republic of Armenia" for each given body within a respective year.
- 3. To the RA Minister of Finance: to discuss the opportunities for financing the actions envisaged by the Action Plan approved in Point 1 of this Decision, within the framework of fiscal procedures of each year, if there are claims submitted by interested state management bodies of the RA in accordance with established procedure.
- 4. With the purpose of observing the process of implementation of the Action Plan as approved under Point 1 of this Decision as well as pursuant to the Decision N354-N of the Government of the Republic of Armenia dated from April 1, 2010, to establish an Interagency Committee for monitoring the execution of the "2012-2016 Action Plan for Implementation of the Concept for Policy of State Regulation of Migration in the Republic of Armenia" (hereinafter: the Interagency Committee), to approve the structure of the Committee in accordance with Annex 2.
- 5. To the Heads of the executive bodies involved in the Interagency Committee: to present to the Head of the Interagency Committee the candidates to be enrolled in the Interagency committee, within a period of fifteen days.

6. To the Head of the Interagency Committee; to submit for approval to the Deputy Prime-

Minister and the Minister of the Territorial Administration of the Republic of Armenia, the

working procedure and composition of the Interagency Committee, within a period of one

month.

7. To define that the logistical support for functioning of the Interagency Committee shall be

provided by the State Migration Service of the Ministry of Territorial Administration of the

Republic of Armenia.

8. To the Heads of the state executive bodies responsible for implementation of the Action Plan

approved by given Decision: after entry into force of this Decision to submit periodical reports

on activities undertaken once per six months.

9. To the Head of the State Migration Service of the Ministry of Territorial Administration of the

Republic of Armenia: within a period of one month after the end of each year, to submit to the

Government of the Republic of Armenia a report on the implementation of the Action Plan.

10. This Decision shall enter into force on the next day after its official publication.

2012-2016 ACTION PLAN FOR IMPLEMENTATION OF THE CONCEPT FOR THE POLICY OF THE STATE REGULATION OF MIGRATION IN THE REPUBLIC OF ARMENIA

INTRODUCTION

1. The aim of the "2012-2016 Action Plan for Implementation of the Concept for the Policy of the State Regulation of Migration in the Republic of Armenia" (hereinafter: Action Plan) is to ensure implementation of the fundamental or priority directions defined by the "Concept of the State Regulation of Migration in the Republic of Armenia" (hereinafter: Concept) as approved by the Protocol Decision of the Government of the Republic of Armenia N 51 of December 30, 2010.

The system of the state regulation of migration in the RA (hereinafter: the Migration System) had undergone a substantial transformation during the period of 1988-2011 on political, legislative and conceptual level, as well as on the level of institutional and operational management, entailing a number of developments. Nevertheless, the Migration System continues to face a number of challenges and major problems requiring prompt and fundamental solutions. Part of these problems arose out of the migration situation of the past twenty years and, not having found solutions during previous stages of the state regulation of migration in the RA, has been passed to the current stage. Another part of the issues in question emerged during the last few years under the influence of globalization and international integration of new economic and geopolitical realities, and their urgency has become more apparent under the impact of the global financial crisis.

The main political milestones and targets of the state regulation of migration have been defined in Chapter 2 of the RA Government Program, ("The Key Priorities of Government Activities"), approved by the Governmental Decision N 380-U of April 28, 2008, whereby "averting emigration and encouraging immigration" was recognized as one of the main priorities.

The Government of the RA defined the main directions of migration regulation in Chapter 4 of the aforementioned Government Program ("The Key Priorities of Government Activities") as follows:

- continuing integration into the society of the refugees forcibly deported from Azerbaijan during 1988-1992.
- establishing an integrated system for the registration of directions and volumes of RA population movements,
- integration of citizens of the Republic of Armenia into the international labour market,
- bringing the RA system of providing humanitarian protection to foreign citizens and stateless persons in conformity with international standards,
- improving mechanisms for entry of foreign citizens into Armenia, their registration, issuance them with residence statuses as well as developing and introducing regulations on their employment activities
- improving the system of border control
- introducing the system of electronic passports and identification cards with biometric parameters

The need to regulate migration was also recognized as one of the priority areas of the National Security Strategy of the RA. The National Security Strategy has defined that: "Unregulated and illegal emigration is an internal threat to the national security of the RA". From this viewpoint, "the state policy on migration regulation shall aim at improving the demographic situation in Armenia and impeding brain drain."

- 2. The Government of the RA also pledged to consistently comply with its commitments under conventions and agreements related to migrants, refugees and forcibly displaced persons and their social protection, taken up within the framework of the UN, International Labour Organization (ILO) and Commonwealth of Independent States (CIS). Within the framework of the EU Armenia Action plan, the Government committed itself to reach facilitation of population movement between Armenia and the EU, including harmonization of the national legislation on asylum and refugees with the standards established by the international law governing the field.
- 3. The approval of the Concept of the State Regulation of Migration in the RA by the RA Government Protocol Decision N 51 of December 30, 2010 is the confirmation of the political will and commitment of the RA Government to comply with its international obligations in the area of migration. The Concept defines 14 major issues of the policy of state regulation of migration.

The measures to be taken to resolve these issues are intended to ensure conformity of the legislation of the Republic of Armenia in the area of migration with EU legislation and best institutional structures, introduction of a system of migration monitoring, analysis and assessment of the situation, protection of the rights and interests of the citizens of the Republic of Armenia leaving the country for work abroad, continuance of integration into the society of the refugees who were forcefully displaced from

Azerbaijan during 1988-1992, as well as to encourage return of the citizens of the Republic of Armenia from foreign countries and their further reintegration in the homeland, to prevent illegal migration from the Republic of Armenia, to increase the level of security of identification documents, to facilitate the right to free movement of the citizens of the Republic of Armenia, to regulate conditions for employment of foreign citizens in the Republic of Armenia and possible massive movements of people in emergency situations, to improve the systems of border control and provision of asylum, to organize effectively the fight against human trafficking and protection of victims of human trafficking, to guide internal migration according to the requirements of national security and sustainable development of the Republic of Armenia.

- 4. The Action Plan is intended to solve these problems, and is developed on the basis of the following:
- 1) Each fundamental or priority direction is numbered and presented in the Concept as a separate group of migration policy measures. The group itself is divided into several sub-directions or measures of general type and presented in the left-most column of the table enclosed to this Annex (e.g. the following fundamental and priority direction is defined as a separate group of measures under number 5: "Protection of rights and interests of the citizens of the Republic of Armenia leaving the country for overseas employment", which, in its turn, is divided into 6 sub-directions or measures, numbered 5.1.-5.6.;
- 2) The outcomes expected from every sub-direction or measure, are presented in the 2-nd column next to every sub-direction or measure (e.g. the sub-direction. "Legal regulation of the issues arising in the course of overseas employment aiming at protection of the rights and interests of the RA citizens" is presented under number 5.1 in the left-most column of the table, two expected outcomes from this measure, in particular, "1. Raising the level of protection of RA citizens leaving for overseas employment", "Complementing and completing legislation regulating protection of rights of citizens leaving for overseas employment" are presented in the second column).
- 3) The third column describes specific short, medium and long term legal, administrative and enforcement actions that shall be taken to reach expected outcomes from particular sub-directions (e.g. the above mentioned sub-direction "5.1." contains three specific actions numbered 5.1.1.- 5.1.3., in particular: "5.1.1. Analysing, revealing gaps of the RA legislation governing the sphere of protection of rights of migrant workers", "5.1.2. Discussion of legislative gaps and amendments thereto with relevant stakeholder state bodies and NGOs.", "5.1.3. Drafting a legislative package aiming at the protection of the rights and interests of migrant workers.");
- 4) The name(s) of the governmental agency/s responsible for the implementation of actions are referred to in the 4-th column next to the cell indicating each action;
- 5) A timeframe for completion of every specific action is described in the 5-th, column (deadlines for achieving specific outcomes from the measures taken within the framework of the Program are generally within the range of 2012-2016, with the exception of several actions, which can be completed later);

- 6) The last, 6-th column contains monitoring indicators of quantitative results received from every specific action, which will allow evaluating completion of every action and substantive results.
- 5. The Action Plan includes measures to be implemented during the period of 2012-2016 that shall be taken through precise short, medium and long term actions of legal, administrative and enforcement nature.

During the forthcoming five years, as a result of the application of the Action Plan, the following will be achieved: improvement of the system of protection provided for humanitarian reasons by the RA to foreign citizens and stateless persons, regulation of labour migration, prevention of irregular migration, facilitation of integration of refugees in the country and effective and systematized cooperation between the responsible bodies for development, coordination and implementation of migration policy will be ensured; including development of skills, distribution of functions, ensuring effective cooperation and collection of reliable data through analysis and statistical procedures.

- 6. The following documents are important for ensuring the outcomes of Action Plan: the "Action Plan for Ensuring Implementation of the Border Security and Integrated Border Management Strategy" approved by the RA Government decision N482-N of April 21, 2010, the "Concept on Reforms in the Area of Activities of the Police of the Republic of Armenia Adjunct to the Government of the Republic of Armenia and its Action Plan for 2010-2011" approved by the decision of the RA Government N354-N of April 1, 2010, as well as the "National Program 2010-2012 for Organization of Fight Against Trafficking in Human Beings in the Republic of Armenia" approved by the RA Government Decision N1140-N of September 3, 2010, and requirements of the Action Plans related to the "Concept on the Migration System of the Republic of Armenia" and the "Concept for Introduction of a System of Electronic Passports and Identification Cards with Biometric Identifiers in the Republic of Armenia" approved by the RA President Order #NK-53-A of March 15, 2008, which were entirely taken into account while developing the 2012-2016 Action Plan for the Implementation of the Concept of the Policy of State Regulation of Migration in the Republic of Armenia.
- 7. RA Government envisages implementation of the Action Plan by including respective measures of the Action Plan in question into the Annual Action Program of the Government of the RA, and by incorporating actions ensuring continuity of these measures in the Midterm Expenditure Program. Such an approach will enable to ensure the implementation of above mentioned measures through budgetary funds. Those actions of the Action Plan which shall not require additional financing from the State budget will be implemented by the staff of respective governmental agency, while actions and measures requiring technical assistance will be executed within the framework of grant programs of donor countries and specialized international organizations.

8. Periodic revision and adjustment of the Action Plan shall be conducted by the Government of the Republic of Armenia based on the monitoring and performance assessment of the results (taking into account the shortcomings and deficiencies detected, and lessons learned during the assessment).

The state agency responsible for the monitoring of the Action Plan is the State Migration Service of the Ministry of Territorial Administration. At the same time, in order to coordinate the monitoring of the implementation of the Action Plan an "Interagency Commission for Monitoring the Implementation of the Action Plan 2012-2016 of the Concept of the Policy for the State Regulation of Migration in the RA" (ICMAP) shall be established, which shall be comprised of representatives of the relevant governmental agencies.

Monitoring and progress assessment reports of the implementation of the Action Plan shall be submitted to the Government of the Republic of Armenia on annual basis by presenting the implementation results of the Action Plan, in accordance with the monitoring and evaluation indicators, the main developments and progress made in the area of migration in the RA, as well as recommendations/suggestions and evaluation results from stakeholders.

9. Based on the results of the annual monitoring reports of the 2012-2016 Action Plan, the targets, indicators, as well as main policy directions and priorities established by the Action Plan shall be subject to change through making amendments in the Plan.
