SPLA and SSPS clash in Khorflus

Fighting between the Sudan People's Liberation Army (SPLA) and Southern Sudan Police Service (SSPS) was reported in the village of Khorflus (28 kilometres south of Malakal) on 11 February.

UNMIS Sector Commander Col. Anil Singh Rathore arrived in Khorflus on 12 February to consult with the local Commissioner, political leaders and area villagers. The next day, he met with the SPLA and SSPS.

The situation remained tense, with the total number of the people killed still unconfirmed. UNMIS provided medical treatment to the wounded and assisted with restoration of peace to the area.

Maridi holds emergency security meeting

Following a series of uninvestigated crimes, Maridi's County Commissioner organized an emergency meeting on 12 February. County chiefs and Joint Integrated Unit Commanders as well as representatives of the Sudan People's Liberation Army, police, Attorney General's Office, UNMIS Security and UN Police got together in an effort to strengthen security in the area.

Several cases were reviewed, including that of a 14-year-old Dinka boy who went missing while following his father to feed cattle on 4 February. In another instance, following a JIU report in Malakia on 11 February that a 28-year-old man had shot himself, his remains were handed over to relatives for burial without a police investigation. Neighbours of the deceased, however, said he was shot by an unknown gunman.

In a third case, a woman was found dead in the JIU barracks on 9 February, and again buried by relatives before a police investigation could occur.

The meeting ended with resolutions to conduct immediate investigations of all cases within two weeks; to delay burial of the deceased by relatives unless ordered by police in consultation with the county judge; and to establish unconditional cooperation amongst police, JIU/SPLA and the judiciary.

UNICEF says situation in Southern Sudan "precarious"

On 12 February UNICEF launched its annual Humanitarian Action Report on the agency's funding requirements for emergency work in 2008. It calls on donors to help address 39 specific crises around the world, seeking funds totaling about \$850 million over and above regular programme budgets.

According to the report, Sudan claims the highest share -- \$150 million -- of the agency's emergency funding needs in 2008. Despite measurable

"From Somalia and the Democratic Republic of the Congo to Iraq, Zimbabwe and Sudan, children and women continue to bear the brunt of conflict, displacement and deteriorating conditions," UNICEF Executive Director Ann Veneman states in a foreword to the report.

Audit report contains old information, Spokesperson says

The report of the UN Office of Internal Oversight Services (OIOS) published in the *Washington Post* was compiled in 2006 and contained old information about UNMIS, UN Secretary-General Ban Ki-moon's Spokesperson, Michele Montas, said on 11 February.

Speaking at a press briefing in New York, Ms. Montas said the report referred to the findings of an inquiry conducted at that time about inconsistencies in contractual and administrative procedures. All cases had since been fully addressed with corrective and disciplinary measures, she said.

The UN had been under immense pressure at the time to rapidly mount its operation in Sudan, Ms. Montas said, adding that the mission had been through 12 audits since then.

"Ask the President" on UNMIS Radio Miraya

The first episode of UNMIS Radio Miraya FM's new monthly programme "Ask the President" was broadcast on 9 February.

During the 40-minute programme, Salva Kiir Mayardit, First Vice-President of Sudan and President of the Government of Southern Sudan answered questions posed by Miraya listeners on food security, Abyei, oil revenues, security threats, tribalism and development.
