### Authority transferred from AMIS to UNAMID

Authority was transferred from the African Mission in Sudan (AMIS) to the UN/AU Mission in Darfur (UNAMID) on 31 December 2007, as laid down by UN Security Council Resolution 1769 (2007).

The ceremony was attended by Special Representative of the Secretary-General to Sudan Ashraf Qazi, Joint UN-AU Special Representative and Head of UNAMID Rodolphe Adada, UNAMID Force Commander Martin Luther Agwai, UNAMID senior officials, UNMIS Force Commander Jasbir Lidder, other UNMIS senior staff, and the Wali of North Darfur.

In his address, Mr. Qazi said the transfer of authority from AMIS to UNAMID, the largest peacekeeping mission and the first to be jointly undertaken by the UN and AU, was a significant day in the history of UN and AU peacekeeping operations.

Mr. Adada delivered the message of UN Secretary-General Ban Kimoon, who emphasized the need for troop and police contributing countries to deploy personnel as quickly as possible. "If we are to have a real impact on the situation on the ground within the first half of 2008, these deployments must happen far more swiftly than they have done so far," Mr. Ban said.

The Secretary-General added that critical gaps remained in the UNAMID force, as no pledges had been received for ground and transportation units or aviation assets, which were vital for force mobility as well as to protect civilians in the vast area of Darfur.

# CFC Chairman concerned over arrest of JEM representative

Ceasefire Commission (CFC) Chairman General Matrin Luther Agwai expressed concern over the arrest of the Justice and Equality Movement (JEM) representative to the CFC, Major General Bashir, and five other JEM members on 30 December 2007 in El Fasher.

Mr. Agwai has been in contact with both JEM and the Government of Sudan to de-escalate tensions and ensure the safe release of the JEM representatives. He expressed regret over the resumption of hostilities between JEM and government forces in northwestern Darfur.
