On that occasion he had been tortured and, Η Η upon his release, informed that, in the event of any further LTTE campaign I Ι in the area, he would be marked for death. J J 4. The Director of Immigration ('the Director') permitted the K K applicant to remain in Hong Kong while his claim to be recognised as a refugee was investigated by the UNHCR. In April 2001, the applicant L L was joined in Hong Kong by his wife and three young children. М Μ 5. The UNHCR investigation took some two years. During Ν Ν that time the applicant was able to live with his family and had freedom of 0 0 movement in Hong Kong. Р Р 6. On 17 March 2003, before the UNHCR investigation had Q 0 been completed, the applicant was served with a removal order pursuant to s.19(1)(b) of the Immigration Ordinance, Cap.115 ('the Ordinance'). At R R the same time, on the basis that the Director considered him to be a threat S S to the 'peace, order and security of Hong Kong', the applicant was placed into detention pursuant to s.32(3A) of the Ordinance. 7. The applicant, however, was not removed from Hong Kong Е and remains here to this day. In the first instance, this was because the applicant's claim to be recognised as a refugee had not been determined by F That determination was, in fact, made in late March 2003. the UNHCR. G The UNHCR informed the applicant that, by reason of what it believed to be his previous actions in Sri Lanka, he was not entitled to protection Η under the 1951 Convention. In light of that rejection, the applicant I submitted a claim to the Hong Kong Government that he had been a victim of torture in Sri Lanka and was likely to be subjected to the same ordeal if J returned to that country. The applicant sought the protection of the K Hong Kong Government in terms of the 1984 United Nations Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or L Punishment ('the Torture Convention'). The applicant's claim under the М Torture Convention is still being investigated. The applicant, I am told, will not be removed from Hong Kong until that investigation is completed. Ν

8. On 30 March of this year, the applicant sought leave to institute judicial review proceedings to challenge the lawfulness of the removal order that had been served upon him in March 2003. In the same papers, as he still remained in detention, the applicant sought interim relief in the form of an order granting him bail pending a resolution of his application.

The procedure is to appoint a person, usually called a 'special advocate', who may not Р Р disclose to the subject of the proceedings the secret material disclosed to him, and is not in the ordinary sense professionally responsible to that party, but who, subject to those constraints, is Q 0 charged to represent that party's interests." R R 16. On the basis that the adoption of the procedure would have to S S be by agreement, having given the applicant an opportunity to consult with his representatives, I obtained the applicant's consent to the adoption of the Т Т U U

G 17. My reasons for determining that it was both lawful and appropriate in this case to appoint a special advocate are contained in this judgment together with an explanation of the procedures that were
I followed.

18. Having taken instructions from the applicant and having been K made privy to the material protected by public interest immunity, Mr Duncan was able in the course of an *in camera* hearing to grapple L directly with the concerns arising out of the confidential material. He М was not able to do so fully, of course, as the applicant himself remained ignorant of that material. But, subject to this material restraint, and while Ν I cannot, of course, speak to the benefit of the procedure on any future 0 occasion, I record that, in my view, Mr Duncan's submissions were of considerable assistance to me. In the result, I granted bail. Р

My reasons for doing so are contained in a confidential ruling
made available the day after the *in camera* hearing to the Director and to
Mr Duncan. That ruling goes directly to the material protected by public
interest immunity, assessing that material in light of the applicant's known
circumstances : hence its confidentiality.

During the course of the hearing, having heard argument, С С I ruled that this Court possesses an inherent jurisdiction to grant bail by way of relief ancillary to an application for judicial review. D D Е Е 21. In this regard, I chose to adopt what appears to me to be settled law in England that the High Court there possesses that same F F jurisdiction. I did so on the basis that, if it is recognised that such G G jurisdiction is vested in the High Court in England, absent a Hong Kong statutory instrument to the contrary or local precedent which binds me to Η Η such effect, it must follow that the Hong Kong Court of First Instance I Ι possesses the same jurisdiction. That this is so is a consequence of J J s.12(2)(a) of the High Court Ordinance, Cap.4, which reads : "The civil jurisdiction of the Court of First Instance shall consist K K of— (a) original jurisdiction and authority of a like nature and extent L L as that held and exercised by the Chancery, Family and Queen's Bench Division of the High Court of Justice in England." Μ Μ Ν Ν 22. As to the position in the Queen's Bench Division in England, 0 0 this was authoratively stated by Sir John Donaldson M.R. in *R v. Secretary* of State for the Home Department, ex parte Turkoglu [1988] QB 398. As Р Р to the nature of the jurisdiction to grant bail, he said (at 400F) : Q 0 ... in my judgment bail is to be regarded in civil proceedings -as it is in criminal proceedings—as ancillary to some other R R proceedings. It is not possible, so far as I know, to apply to any court for bail in vacuo. It is essentially an ancillary form of relief." S S Т Т U U v V

由此 - 9 -A А In looking to the jurisdiction of the High Court, as opposed to the Court of B B Appeal, the Master of the Rolls said : С С In my judgment you cannot apply to the High Court for bail unless the High Court is seized of some sort of proceedings. Secretary of State for the Home Department [2002] 1 Η Η WLR 348 in which Gibson LJ said (at 354A) : I Ι We own to having some doubts as to whether there is room for an inherent jurisdiction to grant bail in relation to a civil J J appeal in judicial review proceedings when Parliament has given the Secretary of State the power to detain and the substance of the complaint is the exercise of that power. But in light of the K K authorities we accept that the High Court has the power in judicial review proceedings to make ancillary orders temporarily *releasing an applicant from detention.*" [my emphasis] L L Μ М 24. The Court of Appeal in Sezek recognised therefore that, while Ν Ν it was not the easiest of issues to resolve, the jurisdiction did exist. 0 0 25. Although I was not bound by the two authorities to which Р Р I have referred, they are persuasive and I saw no reason to part from their conclusions. Q 0 R R 26. Mr Marshall, however, advanced the proposition that in *Sezek* the Court of Appeal, by couching its language in the way it did, recognised S S that it was "too late to go back"; in short, that it was now bound to Т Т a finding it itself would not have reached. The judgment in question is that of Le Ν Ν Tu Phuong and Another v. Director of Immigration and Another [1994] 2 0 0 HKLR 127. Р Р 29. The first question, of course, was whether the judgment, being Q 0 a judgment of the Court of Appeal, was binding on me in this instance. I was satisfied it was not.
