### CIVIL AND POLITICAL RIGHTS, INCLUDING THE QUESTION OF TORTURE AND DETENTION

Status of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment

#### Report of the Secretary-General

- 1. The General Assembly, in its resolution 39/46 of 10 December 1984, adopted and opened for signature, ratification and accession the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, and called upon all Governments to consider signing and ratifying the Convention as a matter of priority.
- 2. The Convention was opened for signature in New York on 4 February 1985. In accordance with article 27 thereof, the Convention entered into force on 26 June 1987, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.
- 3. In its resolution 2000/43 of 20 April 2000, the Commission on Human Rights urged all States to become parties to the Convention as a matter of priority; encouraged States parties to consider limiting the extent of any reservations they lodged to the Convention, to formulate any reservations as precisely and narrowly as possible and to ensure that no reservation was incompatible with the object and purpose of the Convention; also encouraged States parties to review regularly any reservations made in respect of the provisions of the Convention with a view to withdrawing them; invited all States ratifying or acceding to the Convention and those States parties which had not yet done so to make the declarations provided for in articles 21 and 22 of the Convention and to consider the possibility of withdrawing their reservations to article 20; and urged States parties to notify the Secretary-General of their acceptance of the amendments to articles 17 and 18 of the Convention as soon as possible.

- 4. As at 15 November 2000, the Convention had been ratified, acceded or succeeded to by 123 States. In addition, 11 States had signed the Convention. The list of States that have signed, ratified or acceded to the Convention, as well as the dates of their signature, ratification or accession, is contained in the annex to the present report.
- As at the same date, 43 of the States parties to the Convention, namely Algeria, 5. Argentina, Australia, Austria, Belgium, Bulgaria, Cameroon, Canada, Croatia, Cyprus, Czech Republic, Denmark, Ecuador, Finland, France, Ghana, Greece, Hungary, Iceland, Italy, Liechtenstein, Luxembourg, Malta, Monaco, the Netherlands, New Zealand, Norway, Poland, Portugal, the Russian Federation, Senegal, Slovakia, Slovenia, South Africa, Spain, Sweden, Switzerland, Togo, Tunisia, Turkey, Uruguay, Venezuela and Yugoslavia, had made the declarations provided for in articles 21 and 22 of the Convention. In addition, three States parties, namely Japan, the United Kingdom of Great Britain and Northern Ireland and the United States of America, had made the declaration provided for in article 21 only, thus bringing the total of declarations under that article to 46.<sup>2</sup> Under article 21, a State party to the Convention may declare at any time that it recognizes the competence of the Committee against Torture to receive and consider communications to the effect that a State party claims that another State party is not fulfilling its obligations under the Convention. Under article 22, a State party to the Convention may declare at any time that it recognizes the competence of the Committee to receive and consider communications from or on behalf of individuals subject to its jurisdiction who claim to be victims of a violation by a State party of the provisions of the Convention.
- 6. The provisions of articles 21 and 22 entered into force on 26 June 1987 in accordance with paragraph 2 of article 21 and paragraph 8 of article 22.
- 7. The Committee against Torture held its twenty-fourth and twenty-fifth sessions at the United Nations Office at Geneva from 1 to 19 May 2000 and from 13 to 24 November 2000, respectively. In accordance with article 24 of the Convention, the Committee submitted its annual report, which covered the activities of the Committee at its twenty-third and twenty-fourth sessions, to the States parties and to the General Assembly at its fifty-fifth session.
