Pursuant to Article 27 of the Law on Citizenship of the Republic of Macedonia (“Official Gazette of the Republic of Macedonia” no. 67/92 and 8/04), the Minister of the Interior adopts

Regulations Changing and Amending the Regulations on the Manner of Keeping Records of Citizens of the Republic of Macedonia and on the Forms Applied or Issued**Article 1**

In the Regulations on the Manner of Keeping Records of Citizens of the Republic of Macedonia and on the Forms Applied or Issued (Official Gazette of RM no. 2/93), in Article 1, following the word “acquisition” the words “respectively cessation” shall be added, and in the fourth line, following the word “Macedonia” a comma shall be placed, and the words “a guarantee for admission into citizenship of the Republic of Macedonia, oath” shall be added.

Article 2

In Article 6, paragraph 1, the words “The Citizenship Certificate is issued based on an application, (Form No. 1)”, are replaced with the words “The Application for Acquisition or Cessation of Citizenship of RM (Form No. 1)” and after the word “place of domicile” the words “or if the person lives abroad, to the diplomatic and consular mission of the Republic of Macedonia abroad.” shall be added.

Following paragraph 1, two new paragraphs 2 and 3 shall be added which read as follows:

“The guarantee for admission into citizenship of the Republic of Macedonia shall be issued on the Form number 2.

The oath shall be issued on the Form number 3.”

In paragraph 2, which becomes paragraph 4, the number “2” shall be replaced with the number: “4”.

Article 3

In Article 7, the words “The Forms number 1 and 2” shall be replaced with the words: “The forms number 1, 2, 3 and 4”.

Article 4

This regulation shall enter into force on the eighth day from the day of its publication in the “Official Gazette of the Republic of Macedonia”

Guarantee for Admission into Citizenship of the Republic of Macedonia

That _____ born on _____ year _____ in _____, of father _____, citizen of _____, shall be admitted into citizenship of the Republic of Macedonia if he/she fulfills the requirements of Article 7, paragraph 1 items 1 to 9 of the Law on Citizenship of the Republic of Macedonia and if within a time-limit of two years from the day of delivery of the guarantee, he/she has submitted a proof of release from his former citizenship or if he/she has proven that he will obtain a release if he/she is admitted into citizenship of the Republic of Macedonia.

If within the time-limit of two years from the day of delivery of the guarantee, the above mentioned does not submit a proof of release from his former citizenship or does not prove that he will obtain a release if he/she is admitted into citizenship of the Republic of Macedonia, it shall be considered that he/she has renounced his application."
