GEOGRAPHY

Burundi is a small land-locked mountainous country lying south of the Equator in Central Africa. It shares borders with the Democratic Republic of the Congo (DRC), Tanzania, and Rwanda. It has a temperate climate with two rainy seasons (March to May; October to December). Official languages are Kirundi, French and Swahili. RECENT HISTORY

Burundi gained independence from Belgium in 1962. With six million people [The CIA World Factbook reported on 8 February 2007 that there were over 8 million people living in Burundi] living in an area of only 27,830 square kilometres, Burundi is Africa's most densely populated country. Since independence, Burundi's political life has been characterised by rivalry, conflict and violence between the larger ethnic groups, the Hutu and Tutsi. Over half a million people have been killed; more than 281,000 people have been internally displaced; and there are more than 800,000 refugees living in neighbouring countries, mainly in Tanzania. The FCO country profile for Burundi stated that "Burundi's first ever election, held in 1993, was won by a Hutu. Elements of the Tutsi-dominated army assassinated the new President a few months later, triggering the start of a long-running conflict between the army and Hutu rebel groups that has cost an estimated 500,000 lives. In 1996 Buyoya again took power but was unable to stop the violence. Under pressure from the region, negotiations between the belligerents began in 1998, and in 2000 a peace agreement

was concluded in Arusha, Tanzania. It was signed by all parties except four hard-line rebel groups. Violence between these groups and the army continued, despite the institution of a transitional government in 2002, until separate cease-fire agreements were concluded with three of them during the second half of 2003. The UN deployed a peacekeeping force in Burundi (ONUB) in June 2004, and successful elections between June and September 2005 ended the transition and installed Pierre Nkurunziza's CNDD-FDD party in power.” [3a]

RECENT EVENTS AND POLITICAL DEVELOPMENTS

The new government, led by President Pierre Nkurunziza, signed a South African brokered ceasefire with the country's last rebel group, the Forces Nationales de Liberation (FNL) in September of 2006. [5a] ([CIA World Factbook – Burundi, 8 February 2007](#)) While the FNL entered the peace process in September 2006, its fighters remained in the field. [3a] ([Foreign and Commonwealth Office – Burundi Country Profile](#)) Jane's Sentinel Security Assessment for Burundi (updated 19 January 2007) noted that the FNL, led by Agathon Rwasa, remained an active insurgent faction. The United Nations Operation in Burundi (ONUB) completed its peacekeeping mandate on 31 December 2006. On 1 January 2007 the United Nations Integrated Office in Burundi (BINUB) started its mandate for an initial period of one year. [39a] ([United Nations Operation in Burundi: Chronology](#)) “The BINUB proposed responsibilities include support for demobilization and reintegration of ex-combatants and reform of the security sector in the wake of the 7 September Comprehensive Ceasefire Agreement. They also include the promotion and protection of human rights and measures to end impunity through a truth and reconciliation commission and special tribunal, as well as support for poverty-reduction efforts.” [19b] ([United Nations Press Release PKO/157, 20 December 2006](#))

Despite many positive developments in the country, the overall political situation remained tense. “Seven individuals, including the former transitional President, Domitien Ndayizeye, and Vice-President, Alphonse-Marie Kadege, arrested in connection with the alleged coup plot, were still in detention. On 26 October, the Supreme Court reversed its own ruling of 6 October ordering the release of the seven detainees before their trials, and their detention was extended until 26 November.” [20b] ([United Nations Security Council - p3, 18 December 2006](#)) On 15 January 2007, Reuters reported that former president Ndayizeye and four others accused of plotting a coup were acquitted of all charges. Former rebel leader, Alain Mugabarabona and co-defendant Tharcisse Ndayishimiye were sentenced to 20 and 15 years in prison respectively. [40] ([Independent Online, 15 January 2007](#))

"The mainstay of the Burundian economy is agriculture, accounting for some 49% of GDP, and supporting more than 90% of the labour force. Continued insecurity, overpopulation, and soil erosion have contributed to a significant contraction of the subsistence economy in recent years. The main cash crop is coffee with other principal exports including tea and raw cotton. Although potential wealth in petroleum, nickel, copper, and other natural resources is being explored, the uncertain security situation has prevented meaningful investor interest. Industrial development also is hampered by Burundi's distance from the sea and high transport costs." [3a] (**Foreign and Commonwealth Office – Burundi Country Profile**) "Burundi grew about 5 per cent in 2006. Delayed disbursements of funds from the World Bank may add to budget pressures in 2007. Burundi will continue to remain heavily dependent on aid from bilateral and multilateral donors." HUMAN RIGHTS

The FCO country profile for Burundi stated, "The human rights situation in Burundi remains poor, with widespread abuses committed by all parties, particularly in the rural areas surrounding the capital. Tens of thousands of people remain internally displaced. Killing of civilians, reprisal killings, torture, rape, theft, illegal and arbitrary detention, and forced labour have been reported. Rape and gang rape against women, girls and boys is on the increase. The judicial system has little capacity to act in timely and impartial manner, and impunity is pervasive. The indigenous Twa (Pygmy) people remain marginalised economically, socially, and politically." [3a]

The USSD, Country Report on Human Rights Practices 2005, 8 March 2006, noted that "Widespread poverty, food shortages in some parts of the country, lack of basic infrastructure, and a high level of foreign debt contributed to the overall poor human rights situation. ... The PALIPEHUTU-FNL [Party for the Liberation of the Hutu People/National Liberation Front] continued to commit numerous serious human rights abuses against civilians, including killings, indiscriminate shelling of civilian areas, kidnappings, rapes, theft, extortion, the forcible recruitment and employment of children as soldiers, and the use of forced labor."
