## AHMAD MSHAIMA' REARRESTED

**Ahmad Mshaima was rearrested on 13 November. He has not had access to his lawyer since his arrest. He may have been detained for exercising his right to freedom of expression.**

**Ahmad Hassan Ali Mshaima'** was rearrested on 13 November when he was trying to leave Bahrain via the causeway that links the country to Saudi Arabia. He was held incommunicado for the first day he was detained, but managed to phone his family the next day. When his lawyers tried to attend his interrogation before the Public Prosecution they were told that Ahmad Hassan Ali Mshaima's name was not on the list of those to be interrogated that day. However when he spoke to his family, Ahmad Hassan Ali Mshaima' told them the Public Prosecution had questioned him the previous day without his lawyer present.

The legal team representing Ahmad Hassan Ali Mshaima' have had no access to him or to any of his case files since his arrest, but in a phone call to his family he told them he had been accused during the interrogation of insulting the King of Bahrain after he read a poem during a religious festival.

Ahmad Hassan Ali Mshaima' was previously arrested in December 2013 and charged with "illegal gathering with an intent to commit crimes and disturb public security" but he was released on bail in June while his trial was still underway. It will resume in December. He is now held at the Dry Dock prison in the capital, Manama.

### Please write immediately in English or Arabic:

- Urge the authorities to allow Ahmad Hassan Ali Mshaima immediate access to his lawyers;
- Urge them to release him if he has been detained solely for exercising his right to freedom of expression.

## AHMAD MSHAIMA' REARRESTED

### ADDITIONAL INFORMATION

Ahmad Mshaima's father, Hassan Mshaima' is serving a life sentence in Jaw Prison on the outskirts of Manama, as one of 13 jailed opposition activists. In 2013, Hassan Mshaima' was denied adequate medical care and family visits for refusing to wear the prison uniform. Ahmad Mshaima' was arrested on 28 December 2013 and charged with "illegal gathering with an intent to commit crimes and disturb public security" following protests on 14 February 2013 to mark the second anniversary of the start of the uprising. His trial started before the Lower Criminal Court in Manama on 13 March 2014. He denied all charges.

He had told his family when they visited him that he had been tortured when he was interrogated during the first hours he had been detained. This had included being beaten, kicked in the legs, forced to insult his father and his religion, and coerced into signing documents.
