**REGULATIONS
ON THE MANNER OF SERVING MILITARY DRAFT IN THE ARMY OF THE
REPUBLIC OF MACEDONIA WITHOUT WEAPONS, THAT IS IN THE CIVIL
SERVICE¹**

9 June 2002 / Official Gazette no. 50/2002

Article 1

These regulations regulate the manner of serving the military draft in the Army of Republic of Macedonia (hereinafter: the Army) without weapons, as well as the manner of serving the army draft in civil service.

Article 2

The army draft in the Army without weapons is served in units and institutions of the Army on the duties that are not related to carrying and using of weapons.

As duties of paragraph 1 of this Article are considered the duties carried out in the units for connections, warehouses for sanitary and veterinarian items, the storage and retail centre, construction and maintenance of the infrastructure, military restaurants, military baths and laundries, supply services, technical workshops, gas stations as well as the duties in the units commands and the Military Academy.

Article 3

Before being referred to the duties of Article 2 of these regulations, the soldiers serving the army draft in the Army without weapons, complete the basic course without weapons in the Army Logistic Educational Centre and in the Training Centre for Combat Arm, according to a special plan and programme.

Article 4

The provisions regulating the internal order and relations in carrying out of the services within the Army are accordingly applied to the soldiers that are serving the army draft without weapons.

Article 5

The soldiers, to whom in accordance with the Law, the army draft service without weapons is discontinued, will serve the remaining part of the army draft to the duties of Article 2 of these regulations.

Article 6

In the written information of the Ministry of Defence to the recruit, the health, humanitarian or social organisations or the fire extinguishing unit where he will be directed to is indicated, the working place where he will be serving the army draft in civil service, as well as the place and time of reporting to duty.

Article 7

In the organisations, institutions and units in which the army draft is being served in civil service, the person serving the army draft is provided with:

1. Free accommodation and food conditions that cannot be more unfavourable than the accommodation and food conditions of the soldiers that are serving the army draft at the Army;

2. Working conditions (working rooms, etc.) for performing the duties on time and for serving the civil service, the same as for the other employees;
3. Working garments required for the employees in the organisations, institutions and units where the person is serving the civil service;
4. Daily schedule (wake up, breakfast, lunch, siesta, dinner, night rest), in accordance with the schedule of the working schedule of the organisation, institution and unit;
5. The right of weekends and other leaves in accordance with the provisions regulating the internal order and attitude of conducting the service in the Army;
6. Regular monthly income pay to the same amount as for the soldiers serving their army draft in the Army and
7. Financial means for transportation to the place of residence when released from serving the army.

Article 8

After the completion of the civil service, the person that was serving the army draft in civil service shall give in the working garments and other clothes he was provided with.

Article 9

Provided that the person is carrying out civil service in the organisation, institution or unit in the place of residence, the same shall not use complimentary accommodation.

In the case of paragraph 1 of this Article, the person shall report to duty on daily basis at his working place that shall be set in accordance with Article 7, item 4 of these regulations and shall receive reimbursement for his travel expenses for commuting to the civil service.

Article 10

The person carrying out the civil service shall comply with the daily time schedule of Article 7, item 4 of these regulations, respect the order and discipline of the organisation, institution or unit in which he carries out the civil service, same as the other employees and conduct duties and assignments entrusted to him consciously, on time and with quality.

Article 11

For the purpose of controlling the work and behaviour of the persons carrying out civil service in the organisations, institutions and units, a record book shall be kept for compulsory military persons or approved absences, as well as a daily attendance and performance book of assigned tasks.

The Book of Records and Approved Absences Form (Enclosure no.1) and the Daily Attendance and Performance Book Form of assigned tasks for compulsory military persons serving army draft in the civil service (Enclosure no.2) are a constituent part of these regulations.

Article 12

Following the completion of civil service in the organisations, institutions and units, the Ministry of Defence shall be informed that the person has served the military draft in civil service in order to be recorded in the military booklet.

Article 13

These regulations enter in force the eighth day following the day of publishing in the "Official Gazette of Republic of Macedonia".

After comparison to the original text of the Regulations on the Manner of Serving the Army Draft in the Army of Republic of Macedonia without Weapons, that is in the Civil Service (Official Gazette no. 50/2002, an error is observed, which reads as follows:

In Article 6 after the word “recruit” the words: “who will serve the army draft in civil service” are to be added.
