Program and work plan for relief package for victims of conflict

Background:

In the past eights years, the number of victims of conflict is in increasing trend due to terrorist activities under the so called peoples war. Not only the number of victims has increased, but also the types of sufferings have changed during this time. In addition to the directly affected population, there has been substantial rise in the number of displaced due to insecurity in respective areas. A huge number of people have left for other countries. Victims have gathered in big cities like Jhapa, Biratnager, Bhairahawa, Pokhara, Nepalgunj, including Kathmandu valley. Though there is no systematic data available, there is an estimate of above 100,000 people displaced and residing in other areas of the country. Enclosed in annex- 4 is the number of displaced people in various districts. The problem of victims has grown from personal to families to society and the nation. The government has started providing assistance to the victims from the year 2056 (1999). Many of their problems have remained untouched due to lack of understanding between the GON's initiatives so far and the changing needs and types of victims. Longer term needs have not been addressed from the immediate relief programs.

2. Identification of victims

Keeping in view the nature of the sufferers, their periodic demands raised through organized sectors and minimum humanitarian needs, it is necessary to consider the following points in delivery of relief services.

- a) Provision of regular source of livelihood to dependants of those deceased in the conflict who were family's main source of income and arrangement of scholarships for their children up to higher level.
- b) Appropriate arrangement for medical treatment of injured.
- c) Provision of regular income opportunities for dependants of disabled and mutilated people and scholarships for their children.
- d) Compensation for those with property destroyed.
- e) Temporary shelter, medical treatment, education for children and alternative employment training and income opportunities for those living elsewhere due to security reasons.

3. The current initiatives under the relief:

Government was providing one time cash compensation to the dependant families of those lost in the conflict and to those injured for medical treatment since 1996. Taking into consideration the increasing number of displaced and the nature of sufferings, a more systematic support has been provided through program entitled "Ganesh Man Singh Peace Campaign" since 2056, Asoj 6 (23 Sept, 1999). For the last 2 years, the government's various units have been conducting programs addressing the need of victims. Enclosed in annex -1 are the types of program available at present.

4. Proposed program for FY 2061/62 (2004/05)

Annex-2 consists of the programs proposed for this FY, these programs are reserved for conflict victims, and some other new programs. The activities include cash support to the victims' families, scholarship for children, and cash compensation for property damage, treatment of injured, and support for women and children victims.

Needs of Victims and Analysis of the on Going Programs:

The following status has been revealed in terms of programs implemented to date:

a) The HMG's relief package to families of deceased victims has been satisfactory. Geographic limitation is seen in provision of income opportunity for longer term dependent widows.

b) Arrangement for medical treatment of injured is adequate. Some of them are still suffering due to lack of provision for treatment in the private nursing homes and hospitals abroad.

c) Cash compensation for property damaged from HMG has not been so effective due to delayed release of the fund.

d) Foreign employment as an exception, other programs have not been in operation for the displaced people.

Proposed New Programs:

Based on the review of current programs, need of types of relief, and available resources of the government, it seems necessary for revision of programs and introduction of new ones. The following programs have been proposed based on the specific needs of victims.

- a) At least one member of the deceased person's family will be included in skill development and income generation activities.
- b) Enroll orphans, who have lost either father or the mother, in children's homes.
- c) Include woman family members of deceased or disabled victims in skill development and income generation
- d) Provide free education up to lower secondary and secondary level, and Rs. 1000 against the monthly scholarship cum education materials for children of disabled and mutilated
- e) Provide free education up to lower secondary and secondary level, Rs. and 1000 against the monthly scholarship cum educational materials for children of displaced people.
- f) Include one female member of displaced family in skill development and income generation activities. Male members will be involved in skill development training
- g) Make arrangements for cash compensation within 3 months people who have lost their property.
- h) Job skills training for victims of conflict.
- i) Make arrangement for provision of one time cash amount of Rs. 25,000/- for medical treatment, if the regular treatment is required for more than 6 months.

- j) Cash reimbursement of medical bills up to Rs. 5000/- for displaced people over 60 years of age for treatment in government hospitals.
- k) Construction of 'Cold Ward' in the Teaching Hospital for longer term treatment of victims.
- Even though it is appropriate to provide immediate relief by providing cash allowances, it is not practical and affordable in the long run. As an option, trainings will be provided to those who don't have alternate sources of income. Trainings will be conducted in the respective district headquarters. Before they are participate in trainingsor before they are engaged in an employment programs, they will receive one time cash allowance of Rs 2000/-, Rs 3500/- and Rs 4500/-per family of 4, 5-8 and up to 8 respectively. After receiving training and based on the skill acquired, soft loans will be provided in coordination with credit agencies.
- m) Monthly allowance of Rs 500/- for disabled due to conflict
- n) Rs 300/- monthly allowance for displaced elderly male or female those who don't have anyone to support

Note: efforts will be made to avoid double benefits to victims. For instance, those receiving scholarship allowances will not be provided with free education, monthly fees and education materials.

7. Arrangement of Resources:

For making available the aforesaid relief programs, there is a need to merge programs, make new resources available and make others more effective.

- a) Policy of reservation will be made effective by coordination between the Ministry of Education other related agencies providing educational materials. Hence, additional resources are not required under the category.
- b) Resource arrangements will be made available for Children's Home including Bal Mandir (state owned orphanage) for orphans.
- c) Necessary coordination will be maintained amongst MOLD, MCSCW, Labor and Transport, and Industry, Commerce and Supply for provision of skill training. Hence, additional resources will not be required.
- d) Foreign employment and related skills training will be made available through reservation under the Labor Ministry. Hence, additional resources are not required.
- e) District level temporary employment will be assured through the infrastructure works under Ministry of Local Development and Ministry of Physical Planning. Hence, separate budget is not required under this.
- f) Ministry of Local Development is responsible for making available soft loans for income generation for the victims at local level. Hence, additional resources are not required under the heading.
- g) Ministry of Labor and Transport is responsible for making arrangement for skill training through labor training centers and other training agencies by assuring reservations for the victims. Hence, additional resources are not required.
- h) Ministry of Home and Finance will make necessary arrangements within 3 months in response to compensation for loss of property of the victims.
- i) With the view of providing longer term treatment for injured, if necessary, provision of Rs 2500000/- will be made for functioning of the Cold Ward (under construction) in the

- Teaching Hospital. This activity will be implemented in coordination with Ministry of Education and hence, no additional support is required.
- j) Displaced people, above 60 years of age, will be provided with maximum of Rs 5000/-equivalent of bill annually for the hospitalized treatment.
- k) Provision of one time medical expense of Rs 25000/- for injured and needing hospitalized treatment for more than 6 months or more. Additional resources are required for this.
- Prime Minister's and Cabinet Minister's Office including Home Ministry will take action on provision of Rs. 25000/- from the Prime Minister's Relief Fund to disabled and mutilated.
- m) Provision of Rs 300/- monthly allowance for one elderly citizen per family, who is displaced, 60 years of age and above and is a dependant. Additional resources are required for this.
- n) Based on the family size of 4, 5-8 and above 8, provision will be made of one time allowance of Rs 2000, Rs 3500 and Rs 4500 respectively before included in trainings or before employed in some infrastructure activities. The allowance will be made available at the district itself. A soft loan will be provided for income generation activities after training in coordination with other credit institutions. Additional resource will be required for this.

8. Identification of Displaced:

- a) A displaced identification committee will be formed under the chair the Chief District Officer. Other members representing the committee are Local Development Officer, district chiefs of RNA, police, and National Intelligence Department.
- b) An advisory committee consisting of the District Development Committee Chairman and legitimate political party leaders will be formed to assist in identification process.

9. Coordination:

- a) Central coordination and directives committee: a Central Level Coordination and Directives Committee will be formed under the chair of concerned Joint Secretary of Ministry of Home with the view of maintaining coordination of relief package for victims.
- b) District Coordination and Directives Committee: a committee chaired by CDO, will be formed at the district level with the view of identifying the displaced and coordinate relief programs. Chiefs of the program implementing agencies will act as members to the committee. In addition to program coordination, the committee will also be mobilizing local resources with the view of providing the relief. The local committee may also include victims and civil society as necessary.

10 Work plan:

the detailed work plan is attached in annex-3

11. Monitoring and evaluation:

The following mechanism is suggested for monitoring and evaluation.

- a) The central coordination and directive committee will do the monitoring and evaluation at central level.
- b) The regional administrative office will be responsible for monitoring at regional level
- c) The district coordination and directive committee will be responsible for district level monitoring and evaluation.

12. Considerations in program implementation:

The followings should be taken into consideration in program implementation.

a) Systematic identification of victims, avoidance of prejudices and favoritism and selection of appropriate mechanism will be adopted in provision of services.

According to the present arrangement, the CDO is responsible for identification of victims. Except for those displaced due to security reasons, it is relatively easy to identify the victims in a transparent and objective manner. Therefore, the CDO office should make the list of identified people public. A separate list should be prepared for those who are displaced due to security reasons.

- b) Relief services should be made available without any discrimination.
- c) The data/information of the target group should be maintained in systematic manner and should be updated on periodic basis.

At present there is no reliable data available at CDO offices or Home Ministry. The relief program can not be implemented efficiently if data is not systematized. Therefore, the HMG should designate the Home Ministry as data collector and equip it with necessary materials and resources.

- d) Priority should be given to most needy first in terms of relief assistance.
- e) Transparency should be maintained in relief distribution. The CDO should periodically report to the on the status of relief activities.
- f) HMG should consider districts the focal point and provide the relief at respective districts.

13. Review:

Based on the district and regional level monitoring reports and the recommendations of the central committee, a quarterly review of the program will be arranged.

14. Conclusion:

It has been seen that there are various programs being implemented form various agencies for the victims of conflict. In some programs, implementation is ineffective. A concerted effort to provide services is needed, and objective identification of victims is critical. It is possible that the number of people willing to receive service may increase with increment in quantity of relief assistance. Indirect relief is more practical than the direct one. The mechanisms should be created in the manner that only needy people avail the benefits. It is inappropriate to provide more benefits under immediate and direct relief package and adding obligation for the longer term.

Classification of Victims:

The following types of victims have been identified so far:

- 1. Dependent family of civilians killed by Maoists (MHG has decided to provide cash relief to the families)
- 2. Dependent family of civilians killed during any security operations (HMG has decided to provide cash relief).
- 3. Disabled due to gruesome attack by terrorists
- 4. Dependent family of civilians who are abducted by Maoists and already declared dead (HMG has decided to provide cash relief).
- 5. Whose property has been seized by terrorists and the whole family is ousted from the village.
- 6. Those injured by terrorists and their family
- 7. Those abducted by terrorists and returned with mental torture and their family.
- 8. Whose with fixed and mobile property damaged by terrorists and their family
- 9. Those forced by terrorists to leave their jobs and their family
- 10. Displaced due to security reasons and their family

Annex - 6

Definition of Victims:

- 1. <u>Displaced</u>: displaced is defined as those people who have left their residence and taking shelter in district headquarters and/or other secured place for security reasons due to Maoists terrorism.
- 2. <u>Disabled</u>: disabled is defined as the one who is injured in Maoists conflict and has lost his/her hand/hands, leg/legs, eye/eyes and/or paralyzed in the process of treatment.
- 3. <u>Mutilated</u>: mutilated is defined as the one who have lost his/her some parts of the body, such as: ear lob or finger.

Cabinet decision

A, Approval of the proposal submitted by the task force coordinated by Dr. Shankar Sharma, Vice Chairman of National Planning Commission. Immediately arrange for implementation of the program by designating the responsible agencies as follows:

1. Ministry of Education and Sports

- 1.1 Provision of Rs1000/- cash for children of disabled and mutilated persons to study in lower secondary and/or secondary level education (including private schools), monthly fee and education materials
- 1.2 Provision of free education for children of displaced people to study in lower secondary and secondary level education in public schools. One time expense of Rs 1000 for monthly fee and education materials

1.3 provsion of Rs 25000 to teaching hospital to build the Cold Ward for those requiring longer term treatment

Financial arrangement: by coordinating programs

2. Ministry of Labor and Transport

- 2.1 Provision of employment oriented training to victims
- 2.2 Send victims of conflict to foreign employment
- 2.3 Provision of soft loan to one member of dead person's family to go for foreign employment

Financial arrangement: by coordinating programs

3. MOLD and Min of Physical Planning

3.1 provision of temporary employment of victims of conflict

Financial arrangement: by coordinating programs

- 4. MOLD/Women, Children and Social Welfare/Industry, Commerce and Supply
- 4.1 include one female member of the dead person's family in skill development and income generation activities.

4.2 Include one female member of the person disabled or mutilated in skill development and income generation programs.

4.3 Include one female member of the displaced family in skill development and income generation programs.

4.4 Provide training to victims of conflict.

- 4.5 Provide soft loans to victims of conflict and include them in income generation activities Financial arrangement: by coordinating programs
 - 5. Min of Women, Children and Social Welfare
- 5.1 Enroll orphans, who have lost their father or mother, in children's' home Financial arrangement: Ministry of Finance is to provide

6. Ministry of Health

6.1 Provide Rs. 5000 max, as per invoice, to elderly citizens who are displaced and requiring support for hospitalized treatment.

6.2 Provision of Rs 25000/- one time medical expense for those injured due to conflict and requiring regular hospitalized treatment.

Financial arrangement: ???

7. Ministry of Home

- 7.1 Provision of Rs. 2000/-, Rs 3500/- and Rs 4500/- to the family of 4, 5-8 and more than 8 respectively before receiving training or entering into employment- made available at districts.
- 7.2 Provision of Rs. 500/- monthly as helpless allowance to disabled due to Maoists conflict
- 7.3 Provision of Rs 300/- monthly to elderly citizens who are displaced and don't have any bread earners in the family.

Financial arrangement: Ministry of Finance releases

- A. Following arrangement to be made in terms of identification
 - Arrangement of an identification committee in coordination of CDO with representation of LDO, district chiefs of Army, Police and National Intelligence.
 - Arrangement of an advisory committee in coordination of DDC Chairman with representatives of other legitimate party leaders to assist the identification committee
 - C) MOLD coordinates all the trainings to be provided to the victims of conflict. Other Ministries such as MWCSW, labor and Transport, Industry, Commerce and Supply provide necessary assistance.
 - D) Considering the facilitation of service and effective delivery, the presently operated medical treatment programs for the senior citizens under the MWCSW will be transferred Ministry of Health.
 - E) Insurance of more effective implementation of current relief programs under the Home ministry, such as cash relief for family of dead civilians and security forces, cash compensation for disabled and sick security forces, compensation for loss of property including medical treatment of injured and supplement the support with the proposed programs.
 - F) Arrangement will be made for those with high threat list of local security unit will be provided with relief package, upon recommendation of the latter, from the district administration office the victims selects to receive from.
 - G) Ministry of local development is to prepare the peace, resolution of conflict and forward looking program with community participation and implement those.
 - H) Ministry of finance is to make arrangement for release of necessary funds for the implementation of afore- listed programs.
 - I) Hon Deputy Prime Minister and Finance Minister is to maintain necessary coordination between the presently running and the newly proposed programs
